Cowlishaw: "Thank you very much, Mr. Speaker, Ladies and Gentlemen of the House. Representative Daniels and I are the Co-Sponsors of House Bill 39, which is a waiver Bill for unreimbursed mandates on schools. I think we understand what our school people back home feel about mandates. The merit of this Bill is beyond question, it's not the merit that we stand here today to discuss: It is whether this Bill was given an ample opportunity in committee to be heard, and I claim that it Because last week, when the committee had its postings, this Bill was posted (like all others) in both subcommittee and the full committee. Later (although there had been no discussion of this), it was declared by the chairman of the committee that anything that was also posted to a subcommittee would not be posted for the subsequent week. Mr. Chairman, in particular, I real regret about this because I did not ask for sense of this Bill to be called because I'm a member of committee, and I thought it was only courteous to permit those people who are not members of the committee present their Bills first. As a result, because I wanted to be courteous and helpful to my colleagues from both sides of the aisle and because of what was clearly a misunderstanding, this Bill never got heard. I ask you, Mr. Chairman, in (sic - on) behalf of the basic rules of

courtesy and consideration for one another, that you please support the Discharge Motion on House Bill 39, and, as a Member of this chamber, I, respectfully, ask for a Roll Call Vote on this Motion. Thank you very much."

- Speaker McPike: "Representative Cowlishaw, all of these Motions require roll calls. It requires 60 votes to discharge committee. Representative... Brunsvold."
- Brunsvold: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I stand opposed to the Motion to discharge...committee. This Bill was posted three times in three...in the three subcommittees on March 3, March 17 and March 24. The Sponsor or the Co-Sponsor never attempted to call the Bill for a vote in subcommittee, and...every attempt was made by the subcommittee chairman and the subcommittee to hear this Bill and vote on this Bill. had had...has had a fair hearing, ...because it was never really called by the Sponsor; never made an effort to come to committee and call the Bill. ...We're there waiting; subcommittee did a fine job at hearing the Bills that were posted in the subcommittee. ... Every opportunity was afforded Mr. Daniels to appear and present his Bill. He never did, and I think...we ought to oppose the Lady's Motion to discharge."
- Speaker McPike: "The question is, ... Representative Cowlishaw, did you have anything...further to add? Okay. The question is, 'Shall the Education Committee be discharged on House Bill 39?' All those in favor of the Lady's Motion... The question is, 'Shall the Education Committee be discharged from further consideration of House Bill 39?' All those in favor of the Motion vote 'aye'; opposed vote 'no'. Have all voted? Have all voted who wish? Have all voted who wish? Mr. Ryder, to explain his vote."

Ryder: "Thank you, Mr. Speaker, I appreciate the opportunity to explain my vote. I'm disappointed in the vote that...that see at this point, because some additional help might be I seem to remember that there were some people requesting that mandates be funded or mandates be eliminated. This is your opportunity to do that. The Motion denies that discussion. I wanna talk about it; my constituents wanna talk about it, and I bet 'ya. constituents wanna talk about it, too. But a red vote means you're not gonna let your constituents hear thoughts about mandates, whether they should be funded and what we should do with those mandates that are not being funded. Thank you, Mr. Speaker."

Speaker McPike: "All right, the Members are reminded that this is not a discussion of the Bill, but a discussion of the Motion, and the Chair will hold the Members to that.

Representative Black, on the Motion and not on the Bill."

Black: "Thank you very much, Mr. Speaker. The Motion to discharge... I don't know how anyone can vote against a Motion to discharge. The Bill itself is permissive. It's what everybody talks about. An 'aye' vote is the right vote. It's very difficult to explain why you wouldn't let a Bill come to the floor for full debate on such an important issue as mandates."

Speaker McPike: "Representative Brunsvold, to explain his vote."

Brunsvold: "Mr...Mr. Speaker, I agree with you totally. The
merits of the Bill...should be left to subcommittee. We're
discussing here on the floor whether this had a fair
hearing. Well, it..."

Speaker McPike: "You're correct."

Brunsvold: "It had three hearings, and it was never called."

Speaker McPike: "Have all voted? Have all voted who wish? Have

von Bergen-Wessels: "Thank you, Mr. Speaker. This Bill seeks to correct one person's problem: seeks to correct the problem of Lydia Thorpe, who gained national attention. Because of reapportionment, her secret ballot was denied. She's the only woman or person, to my knowledge, in the entire nation who no longer has a secret ballot. A number of lawyers have (sic - has) looked at this, and the only solution that anyone came up with was to move her into a different legislative district."

Speaker McPike: "...Excuse me...excuse me... I know I'm gonna...and... Representative von Bergen-Wessels, until I recognize five people over here... This is a Motion to discharge, and it's not a discussion of the Bill."

von Bergen-Wessels: "Right. Excuse me. I understand that."

Speaker McPike: "So, if you would...if you would keep your remarks to the Discharge Motion."

von Bergen-Wessels: "Thank you."

Speaker McPike: "Thank you."

von Bergen-Wessels: "It is... My former remarks are to...make it clear why I think it's important that we discharge...this from committee. It does...did not get a full hearing in committee; it was posted for subject matter only. So, it never, ultimately by error, never did get posted, never had a hearing, so I would, respectfully, ask that...this Body allow it to be discharged from committee."

Speaker McPike: "All right. On the Lady's Motion, Representative Moore. Andrea Moore."

Moore: "With all due respect to the Representative's request to discharge, there was ample time to discharge Motions; and, speaking to the merit of that as she did, was, of course, out of order because we are talking to discharge. I would urge you to vote 'no' on the Motion to discharge."

Speaker McPike: "Representative Curran."

Curran: "I, also, wish to compliment the Minority Spokesperson for the hard work that they did, but this particular Bill never got a chance. Inadvertently, the Bill was not posted at the appropriate time. This Bill only affects one voter in this Representative's district - not mine, but Representative von Bergen-Wessels. One voter. So that that one voter can have a secret ballot. How can we deny one voter in somebody else's district?"

Speaker McPike: "Mr. Curran. Mr. Curran. Mr. Curran. Mr. Curran. Mr. Curran. The Motion on discharge, Mr. Black."

Black: "Yes, thank you very much, Mr. Speaker. Would the...Sponsor on the Motion to discharge yield for a question, as to the reason seeking discharge?"

Speaker McPike: "Yes, she will."

Black: "Thank you. Representative, I'm unclear as to your earlier comments. You said the Bill was only posted for subject matter. ...What I need to get clear in my mind: ...Was this Bill posted in a subcommittee or on subject matter or in any posting, at any given time, during the process?"

von Bergen-Wessels: "Sir, there was no vote taken. It was only
 posted for subject matter."

 get a hearing, and it could not get a vote."

Black: "Thank you very much."

von Bergen-Wessels: "And...and...and..."

Black: "Thank you very much, ..."

von Bergen-Wessels: "Mr. Speaker?"

Black: "...Representative. Mr. Speaker, to the Motion to discharge."

Speaker McPike: "Yes, proceed."

"The Sponsor of this Motion to discharge has clearly Black: indicated, I think, that the Bill was posted. Now, it's no one's fault in this chamber that, for whatever reason, didn't come to a vote; it didn't come to a vote. were hundreds of Bills posted that didn't come to a vote. Now, if we're gonna sit here all day and debate every one of those, then make your arrangements. We can be in tomorrow morning. She just said the Bill was posted. Now, not her fault, the chairman's fault or the vice-spokesman fault that it didn't get called for a vote. Motion to discharge, therefore, should be ruled not...or out of order and defeated. It was posted. are hundreds of Bills that were posted and didn't get a hearing. Vote 'no' on this."

Speaker McPike: "Representative Dunn."

Dunn: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House.

I rise in support of the Lady's Motion and...to, hopefully,
help clarify some things. The Lady has...has clearly

indicated...that...it was her objective to...present her Bill to the committee and have a Roll Call Vote. She didn't have a chance to do either one. She did not have a chance to present her Bill. She did not have a chance a Roll Call Vote, and, in spite of whatever technicality the previous Gentleman is referring to about posting or not posting or subject matter or not subject matter, the fact the matter is this Bill did not get a hearing, and it affects one franchise voter in the State of Illinois. talk about equity, fair play, justice and giving the people the right to vote. We need to discharge this Bill so we can address this inequity, and the only way to do that to discharge this...this Bill from it...from committee, so I urge a green vote on this Motion."

Speaker McPike: "Representative von Bergen-Wessels, to close." von Bergen-Wessels: "Thank you, Mr. Speaker. Just to make one small correction: This does not affect a voter in my district. It affects a voter who is in a Republican district and who will be in a Republican district. would ask that we move this. It did not get a hearing. We have... This woman should have a fair hearing before the full Body, and I would, respectfully, ask that we would...move to discharge it."

Speaker McPike: "The question is, 'Shall Elections and State Government be discharged from further consideration of House Bill 1650?' All those in favor of the Motion vote 'aye'; opposed vote 'no'. Have all voted? Have all voted who wish? Have all voted who wish? Have all voted who wish? The Clerk will take the record. On this Motion, there are 63 'ayes' and 43 'noes'; then the Motion carries. House Bill 1705, Representative Hicks. Out of the record. Returning to 1705. Representative Hicks, on a Motion."

But I had a coupla Bills myself that I thought that, perhaps, the assignment was somewhat unique...until I got a 'do not pass' Motion, and I figured out why it was assigned there; and, as a result, I can't understand anyone who

Well, this Discharge Motion with a...with a stand on similar...with a similar reason for believing that this Motion should be approved. It is not, however, that this was not the correct committee, it is that the committee had so many Democrats replaced by other Democrats that we don't really know what the committee thought. Therefore, I would just point out to you before you vote on this - in fairness to all of my colleagues on both sides of the aisle - this Bill has to do with using current census figures for distribution of money for senior citizens. This is a very sensitive vote, and you'd better be mighty sure you know

whether your district gains or loses if we put the 1990 census figures into the Department on Aging formula. But we'll never know because there were so many replacements on...of people who for whom this would have been an extremely sensitive vote, for others (mainly Chicagoans) who stand to lose some money under this law..."

- Speaker McPike: "Representative Cowlishaw, on the Motion, not on the merits of the Bill."
- Cowlishaw: "I move that we discharge the committee on House Bill 2378 in order that simple fairness may prevail, since the committee had so many replacements on it that we don't really know what the committee (the real committee) might have done; and, on that basis, I move 'do pass'."
- Speaker McPike: "Representative DeJaegher, on the Motion."
- DeJaegher: "Thank you, Mr. Speaker and Members of the General Assembly. House Bill 2378 had a fair and spirited hearing in committee. To move this Bill at this time is not timely. This Bill is in litigation. It could have a severe impact on the court decision. For this reason, I ask that you oppose this Motion to discharge."
- Speaker McPike: "Representative Olson."
- Olson: "Thank you, Mr. Speaker, Members of the House. I think on everybody's desk is a map of the state. If you're in area other than two, four or three, your area will lose money under this Bill. I encourage a 'no' vote."
- Speaker McPike: "All right. The question is, 'Shall the committee on Aging be discharged from further consideration of House Bill 2378?' All in favor vote 'aye'; opposed vote 'no'. Have all voted? Have all voted who wish? Have all voted who wish? Have all voted who wish? The Clerk will take the record. On this Motion, there are 49 'ayes' and 58 'noes', and the Motion fails. Any

Speaker McPike: "Any announcements?"

T. Johnson: "I'd like a chance to call my Motion to discharge on my University of Illinois early retirement Bill."

- McPike: "Mr. Electrician. Electrician. Speaker Mr. being...there being no announcements. Representative Granberg moves that the House stands adjourned until Monday, April 12 at 3:00 p.m., allowing perfunctory time today for committee reports and perfunctory times next week, Tuesday the 6th, Wednesday the 7th and Thursday the 8th from 2:00 to 3:00 p.m; and, on that Motion, all in favor say 'aye'; opposed, 'no'. The 'ayes' have it, and the House stands adjourned."
