- Speaker Madigan: "Representative Brunsvold and Representative Hartke shall be in the Chair."
- Hartke: "Well, thank you very much, Members of the General

As Chuck has said, we visited China on a agricultural mission, and the gentleman I'm going to introduce, Wang Lee, is the Consul General who is stationed in Chicago, and it was through his help and his contacts in China that helped put this trip together, So, with great pleasure, I'd like to introduce Wang Lee, Consul General, China."

"Honorable Congressmen, it is my great pleasure and honor to Lee: visit this beautiful city, Springfield, the hometown of Lincoln, and also my great honor to speak a few words here the very great Congress. And I would like to send my best wishes for you, the deputies of the hometown of Lincoln, home state of Lincoln, and wish you success in your work. I know you have a very busy schedule, and today I realize that Congressmen are very busy. Sometimes couldn't even have their lunch, and you're working very hard for the benefit of the people of the state, and as you know, I have come to Chicago three years ago as the Consul General of the People's Republic of China and my main function, the purpose of my mission is to improve and promote good relations between China and the Illinois State We are in charge of nine states. Our and the Midwest. main purpose is to promote trade and business, to promote educational cultural exchanges between the people, to promote friendship and the mutual understanding between the two peoples. We also provide a service to the Chinese

community in this area, and also taking care of Chinese students in the United States. We have 15,000 students studying in the United States here, and the large number of course, is in Illinois. There are many products from this state goes to China. Of course, Chinese consumer goods also come into the United States, so my message to you is that China has become a very great, huge market for the United States, and United States also a big market for China. very beneficial trade and business relations. Brunsvold: "We'd also like to thank Senator Woodyard for his efforts in promoting the relationships between the State of Illinois and the loaning province which is our sister province in China, and the efforts that the Chinese government has done to try to promote trade with the United States. In fact, there're ongoing efforts right now in Chanute Air Force Base area to have a management...Chinese management facility there of which is going to be a great economic benefit for Illinois. So, that's just one thing going on, and we'll thank Senator Woodyard for his efforts. Wang Lee, thank you for coming today. Appreciate it."

I think we all know what this issue is. Levin: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I would oppose the Gentleman's Motion. There was very extensive discussion and debate in the subcommittee on Real Estate with respect to Senate Bill 1. We were, in fact, graced with both Senator Philips and Representative Daniels, as well as numerous television cameras and media, and discussed and debated this legislation for probably minutes. I think all of the...there was about 45 adequate...I think adequate debate on the matter, and the matter...you know, failed to obtain the support of the subcommittee; and, indeed, the Motion that was adopted as a recommendation was a 'do not pass' Motion which was affirmed in the full committee. I would point out that opportunity for a full debate in the substantive committee is not something that more than 200 of our Bills that we passed out of here got in the Senate, Bills that did not even get out of the Senate Rules Committee. this legislation had an opportunity. It did not succeed on the merits, and I would oppose the Gentleman's Motion."

Speaker Madigan: "Mr. Black."

Black: "Thank you very much, Mr. Speaker. An inquiry of the

Chair, and I suppose it must go back to what Representative Levin...my concern is whether or not this Bill was heard by the Standing Committee or a subcommittee of that Standing Committee."

Speaker Madigan: "Mr. Levin."

Levin: "Representative, we have a policy in Revenue that hearings are held in subcommittee. As far as this particular piece of legislation, the subcommittee made its recommendation to the full committee. It recommended 'do not pass'. That matter was taken up by the full committee yesterday, and the full committee adopted the 'do not pass' Motion. So, the matter was heard in both subcommittee and in full committee."

Black: "All right. Thank you very much. I appreciate your explanation, but it might give rise to questions later on.

I appreciate that. Thank you."

Speaker Madigan: "Representative Currie, on the Motion."

Currie: "Thank you, Speaker, Members of the House. We did have an extensive hearing on this Bill, and it's certainly not the first time this House has considered the question of property tax caps. Property tax caps have come to a vote in this House when we were looking at House Bills all by themselves, and it is my recollection the property tax caps failed and failed dismally. We've also seen a lot of legislation this Session to exempt items from the property That was not, of course, the proposal in Senate tax cap. Bill 1, but that suggests that property tax caps are not working as well as they might in the collar counties where they currently are imposed. Senate Bill 1 does not deserve a further hearing on this House floor. I support a strong committee system. This committee, the Revenue Committee gave Senate Bill 1 every opportunity to be heard.

measure was rejected by the committee on its merits as a proposal that will not be helpful to the citizens of this state who seek property tax relief, and I would urge your 'no' vote on this Motion to take Senate Bill 1 from the table."

- Wennlund: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, what we're talking about here is the concept of property tax relief, not the details of what's in this particular Bill or in any other Bills, we're talking about the whole concept of property tax relief. And this is of such importance to the people of Illinois, that the matter deserves to be heard by the full House Membership, not just the committees or the subcommittees. Local Government, there appears House Bill 87, and I believe a Motion has been filed by Mr. Walsh, and would Representative Currie take the Chair. Mr. Walsh."

- Walsh: "Thank you, Mr. Speaker. I'd move to discharge the

  advance to the Order of Second Reading, Senate Bill 87."
- Speaker Currie: "Representative Walsh moves to discharge the Committee on Elementary and Secondary Education from further consideration of Senate Bill 87 and move that Bill to Second Reading; and, on that Motion... Representative Walsh."
- Walsh: "Madam Speaker, it was the Executive Committee."
- Speaker Currie: "Executive Committee. Pardon me; and, on that

  Motion, Representative Bugielski, the Chairman of the

- Bugielski: "Thank you, Madam Speaker and Members of the House. I rise in opposition to the Representative's Motion. This Bill had a fair hearing in the executive meeting. We met, there was a quorum present, and he did have the hearing on the Bill. It was a fair hearing and it failed, and I ask my Members to oppose this Motion."
- Speaker Currie: "Speaker Madigan, on the Motion."
- Speaker Madigan: "Madam Speaker and Ladies and Gentlemen of the House. This Bill is concerned what...with what is referred to as reform of the Chicago school system. The Bill, by its very nature, gets into matters which in part are subject to the normal collective bargaining process at that system. In addition, it gets into matters which are properly before the General Assembly. In regard to the matters which are currently under consideration by the General Assembly, they're highly technical and complex. They were the subject of a meeting which I convened last

my office between the Chicago Board of Wednesday in Education on the one hand and the Chicago Teacher's Union on the other. Both sides to that negotiation felt that fruitful meeting. They left the meeting was a very agreeing to go back in one instance to caucus, in another instance to do further research, so that they can come back to the General Assembly, work together to try to forge an agreement in certain areas which are currently pending before the General Assembly. They did agree concerning matters which are not properly before the General Assembly but are the subject of a collective bargaining negotiations currently under way, they would go and do that as they have always done it between themselves. And for those reasons, I would rise in opposition to the Gentleman's Motion to discharge the committee."

Speaker Currie: "Further discussion? Representative Kubik."

Kubik: "Thank you, Speaker and Ladies and Gentlemen of the House.

I am the Spokesman on the Executive Committee, and Representative Walsh presented his Bill and a large number of people left the room and there were not a sufficient number of people in the room to vote on the Bill. I think that the Bill is a legitimate effort to bring forward an important issue with respect to the Chicago schools. It was debated very fiercely, I might add, in the Executive Committee, but the fact of the matter was that there were a number of Members who were not present for the final vote. And I think that if you asked any of the people who came down to testify, they will acknowledge to you that this was not a fair hearing or a fair vote. With respect to the Speaker's comments, I think...I recognize there are ongoing negotiations and I think that is a good, good thing; however, we ought to bring this Bill forward as a...as an

attempt to start talking about this very important issue, and perhaps it can be used as a part of the discussions as we move forward. So I think this is a very legitimate, good Motion to discharge, and I would hope that Members would look beyond partisan reasons to support this important piece of legislation. Speaker Currie: "Representative Bugielski, on a point of personal privilege, to explain about the committee."

Bugielski: "Thank you, Madam Speaker and Members of the House.

need seven to get a Bill out of committee, so there were
enough people in the room to pass the Bill if needed.

What we're doin' here today is a farce and a sham, but it was a farce and a sham four years ago when we voted for school reform, and at the time that we voted for school reform, we said, 'don't vote for it unless you're willing to put the money behind it to carry it out.'

Walsh: "Thank you, Madam Speaker. I just would like to point out with the rush of business in the last week, many of the Members of the committee were coming and going because they had Bills in other committee, and weren't able to listen to the lively debate that we had. So, I would like to again move this Motion. I would also like to point out the fact that we had a number of principals that came down from the Chicago public schools that were not able to testify on this Bill. So, I think this...it's a good Motion. I would ask for your favorable...favorable consideration. Thank you."

Speaker Currie: "Representative Walsh has moved to discharge Senate Bill 87 from Executive Committee and move the Bill to the Order of Second Reading, First Legislative Day. All in favor of the Motion signify by voting 'yes'; opposed vote 'no'. Voting is open. Have all voted who wish? Have all voted who wish? The Clerk will take the record. Bud DeJaegher votes 'no'. On this Motion, there are 54 voting 'aye', 28...38 voting 'no', and the Motion fails. Next Order of Business on the Special Order of Call, Law, is Senate Bill 127, Representative Lang, for a Motion. Excuse me. For what reason does Representative Cowlishaw rise?"

Cowlishaw: "I'm sorry, Madam Speaker. I thought you were on a Special Order for education Bills. I have a...I have filed a Motion to Discharge the Committee of Elementary and

- Cowlishaw: "Would the Chair please let me know when you plan to get to the Education Order?"
- Speaker Currie: "The Chair will be happy to. Representative Lang on the Motion."
- Lang: "Thank you, Madam Speaker. I move to discharge Judiciary I Committee and advance this Bill to the Order of Second Reading. Judiciary I is my committee, but we didn't get a chance to hear this Bill because we finished our business except for this Bill and maybe one other and cancelled our second meeting. So, this Bill has not had a hearing in committee, and I would ask the indulgence of the House to discharge the committee."

- Granberg: "Thank you, Madam Speaker, Ladies and Gentlemen of the House. Pursuant to Rule 77(a), I move to discharge the Committee on Executive and advance to the Order of Second

  Representative Kubik has a Motion in respect to that measure. Representative Kubik."
- Kubik: "Thank you, Madam Speaker. I would move to...pursuant to Rule 77(a), I move to discharge the Committee on Revenue from further consideration and advance to the Order of Second Reading."
- Speaker Currie: "You've heard Representative Kubik's Motion.

  Representative Levin, the Chair of the Revenue Committee."
- Levin: "Thank you, Madam Speaker, Ladies and Gentlemen of the House. I would oppose the Gentleman's Motion. Senate Bill 100 was heard in our committee and was ably presented by the Sponsor who's making a Motion now, and it failed to receive the requisite number of votes. I think one of the observations that was made in committee at the time was those who wanted tax caps, the City of Chicago in making its decision with respect to this particular tax wanted to avoid imposing increasing property taxes, and this was unfortunately the alternative. I personally do not like this source of revenue, but we, you know, should not impinging on the rights of local jurisdictions, especially when they're trying to avoid raising property taxes. T would point out, moreover, that not only does this particular Bill eliminate revenue in terms of soda pop. but it also eliminates revenue with respect to natural The committee considered the Bill and did not approve it.

Speaker Currie: "Further discussion? Speaker Madigan."

The Bill is a pre-emption Bill. It's a direct assault on the ability of local governments to finance their operations and to raise their own taxes, and for that reason I stand in opposition to the Motion."

Speaker Currie: "Further discussion? Representative Black."

Black: "Yes. Thank you very much, Madam Speaker and Ladies and Gentlemen of the House. I rise to support the Gentleman's Unfortunately, I think there's been a total lack of communication on the other side of the aisle. The next Order of Business is Professional Regulation, Special Order of Call, Representative Giglio, on Senate Bill 603. Representative Giglio."

- Giglio: "Thank you, Madam Speaker. Pursuant to Rule 77(a), I move to discharge the Committee on Regulation and Registration from further consideration, advance to the Order of Second Reading, First Legislative Day. This Bill is the agreement on both sides of the aisle. There was some mixup as to whether this Bill was going to go in an omnibus Bill, and decided not to; and, therefore, I'd ask for its discharge."
- Speaker Currie: "Representative Giglio has moved to discharge the Committee on Professional Regulations from further consideration of Senate Bill 603, and on that Motion, is there any discussion? Representative Saviano."
- Saviano: "Thank you, Speaker. I will concur as the Minority
  Spokesperson for Reg and Reg debt that Representative
  Giglio made an accurate description of what happened in
  committee, and I would rise in support of his Motion.
  Thank you."
- Speaker Currie: "Further discussion? Representative Steczo."
- Steczo: "Thank you, Madam Speaker. Concurring with

Seeing no opposition, the Motion is adopted by the Attendance Roll Call. On the Special Order of Call, Local Government, appears a Motion with respect to Senate Bill 851, Representative Wennlund."
- Wennlund: "Madam Speaker, we have an agreement to call that on Tuesday. The Chairman of the Counties and Townships Committee is absent right now, is not here. Representative Santiago."
- Speaker Currie: "Is it your thought that the Chairman of that committee will have a problem with your Motion?"
- Wennlund: "That he will concur with it, yes."
- Speaker Currie: "Concur with it. Can we trust you,

  Representative Wennlund?"
- Wennlund: "What happened was...is right after Session when Counties and Townships met, we had a short leadership meeting. By the time I got over there, they said they had passed out an Agreed List and one Bill and had adjourned, so there was not adequate time to...for me to present the Bill."
- Speaker Currie: "Let me consult with the Parliamentarian on the question of the trustworthiness of the maker of this Motion."
- Wennlund: "Well, you could do it..."
- Speaker Currie: "Representative Wennlund, we believe you. So, if there's any discussion on Representative Wennlund's Motion to discharge the Committee on Counties and Townships from

On the Special Order of Call Law, Senate Bill 870, with a Motion with respect to that Bill, Representative Maureen Murphy."

Murphy M.: "Thank you, Speaker. Ladies and Gentlemen, the matter before us is a Discharge Motion of Senate Bill 870 that was before Judiciary I with Chairman Lang. Questions arose during the presentation of this Bill that could only be answered by an outside agency. We believed there was going to be a second time for Judiciary I to meet, but because the shortened, abbreviated schedule that was cancelled, the outside agency has since been contacted and the various concerns by committee members have been addressed. Representative Dart has joined on with me on the Senate Bill, and I've talked with Chairman Lang about the possibility of discharging this Bill from his committee."

Speaker Currie: "On the Motion, Representative Lang."

Lang: "Thank you, Madam Speaker. The Sponsor is correct. I have no objection to discharge."

Speaker Currie: "You've heard the Motion to discharge the committee of Judiciary I from the further consideration of Senate Bill 870. On that Motion, is there any discussion? Seeing no further discussion, the question is, 'Will the House give leave by the Attendance Roll Call to adopt the Motion?. Is there leave? Leave is granted, and by the Attendance Roll Call, the Motion succeeds. Now, back to Representative Cowlishaw. Representative Cowlishaw has filed a Motion with respect to Senate Bill 135, and her

All of the people who had come here to testify on that Bill during the meeting of the Elementary and Secondary Education Committee held right here in this chamber yesterday were given ample opportunity to testify, were treated very fairly and politely by Chairman Brunsvold, however, partly because we were running late and almost into the time when we needed this chamber in order for the House to meet, the fact is that the Elementary and Secondary Education Committee was adjourned before we even

had an opportunity to vote on this Bill at all. I think, Madam Speaker and Members of the House, every Bill is entitled to be voted upon by the Members of this Body, and because the meeting was adjourned before any vote was taken at all, I would respectfully suggest that the proper and fair thing to do with Senate Bill 135, irrespective of what the contents of the Bill are, just the principle of the thing, that the correct vote on this Motion is 'yes'."

Speaker Currie: "The Chair recognizes the Chair of the House Elementary and Secondary Education Committee, Representative Brunsvold."

Brunsvold: "Thank you, Madam Speaker. I rise to oppose the
Lady's Motion. As I had indicated yesterday, we met in
Speaker Madigan's office and with his guidance between the
Chicago Board of Education and the Teacher's Union, much
progress was made on the supernumerary issue, 5 by 5 and
the principal engineer situation. It seemed that they were

going to meet and they were meeting yesterday, the day after we had the meeting to try to come to agreement on The House taking a vote on this Bill would those problems. have destroyed those negotiations. The House then would have taken a position for one side or the other, don't think that's our responsibility here to try to dictate to the locals about what that decision should be, and so Mary Lou has a very good comment. We can vote on this Bill, yes, but we ought to wait until they...the two sides have either come to agreement or they can't come to an agreement. When that situation arises, then we can, out of Rules Committee, discharge this Bill and vote on that Bill at that time. But right now, we shouldn't be doing that. We should let both sides work on the issue and see if they can come to a mutual agreement before we come down here and try to pick sides. So, I stand opposed to Lady's Motion, and ask for your 'no' vote."

Speaker Currie: "Further discussion? Representative Black."

Black: "Thank you very much, Madam Speaker, Ladies and Gentlemen of the House. To the Motion. It's only been five minutes ago that someone on your side of the aisle asked that you all respect the sanctity of the committee process. Well, here we have a Motion that does exactly that. This Bill received a full hearing in these...in this very chamber yesterday, both sides adequate debate, but all of a sudden, the committee was gaveled to adjournment and no vote was taken on this Bill now, if you're going to respect the sanctity of the committee process on one side of the aisle, we would like to join with you and respect the sanctity of the committee process in that any Bill presented, both sides being heard, deserves to have a vote. Speaker Currie: "Further discussion? Speaker Madigan."

Madigan: "Madam Speaker, I rise in support of the position of the Chairman of the Elementary and Secondary Education Committee. As has been explained on a previous Bill, all of these matters have been brought into my office. We have open discussions and negotiations on these questions. It is my expectation that the parties to these negotiations will be reasonable, open minded, and that they will act in good faith, and for those reasons, I would humbly suggest that we oppose this particular Motion. Thank you."

Speaker Currie: "The Motion is to discharge the House Elementary and Secondary Education Committee from further consideration of Senate Bill 135 and put that Bill on the Calendar of Second Reading, First Legislative Day. All favor of the Motion vote 'aye'; opposed vote 'no'. Voting is open. Have all voted who wish? Clerk will take the record. On this Motion, there are 52 voting 'aye', 42 voting 'no'...
