Conservation... This is a Bill. The Conservation supported Amendment that Representative Giglio put on yesterday raised the amount of catch of perch in Lake Michigan to 300,000 pounds per licensed commercial fisherman. I think the Amendment had 90 votes. So I would with that, answer any questions and ask

It wouldn't be, obviously, because the parent wasn't there to give you the car seat."
