Rotello: "Well I think that this committee, the intent of this legislation would be to have hands on experience, hands on learning skills and so on. For instance, computers are extremely important and there aren't enough in the public school systems, and certainly every one graduating school today should have some type of computer experience. Above and beyond that however, there haven't been any changes in curriculum in the last several years, since we've been in school Representative Skinner. So if someone has some

Ostenburg: "It does that by imposing severe requirements on them, reporting relationships, for visitations and things of that sort. When the details of what they have to report on have not yet been worked out by the State Board of and by the testimony of the superintendent in committee, will not be finalized for as much as 15 months yet from today's date. Given that circumstance, a number of districts have had to prepare reports which have then been thrown back to them for Amendment and correction, they have submitted them a second and even a third time, involving academic time that should

Wennlund: "Can you tell me why LUDA would be against it then, though? The Large Unit District Association, why would they be against a Bill that would stream line or make it more efficient, for teachers to spend more time teaching rather than testing."

Ostenburg: "Again, Representative I don't know why any particular group is against it. You would have to ask them, but I can tell you that a lot of people are fearful that this is going to interfere with the process. The Bill does not interfere with any thing except the time lines, and it may very well be that they're concern is based upon what they see as a change in the process. Everything will be in place the same as it always has been. It only creates a one year moratorium so that the requirements at the state level can be worked out adequately."

Wennlund: "So, the State Board of Education is opposed to it.

They just haven't had their act together to implement the necessary rules and regulations, so that this will give them one year moratorium, so that they can put those regulations into effect, is that what it does?"

Ostenburg: "That's exactly what it does."

Wennlund: "Okay, thank you very much."

Speaker Flower: "Representative Persico."

Persico: "Thank you, Madam Chair. Will the Sponsor yield?"

Speaker Flower: "Yes, he will."

Persico: "Representative if your Bill passes this is no way in effect, you're not against the concept of school improvement programs, correct?"

Ostenburg: "Not in the least bit."

Are there any other particular things that they are trying to come up with?"

Persico: "So again you are just trying to slow down the process a little bit in order to let the State Board of Education to come up with the different recommendations that they are trying to implement a little bit."

Ostenburg: "Exactly."

Persico: "Okay, thank you. To the Bill, I stand in support of this Bill, as one of the unique position that I have teaching half the year and being involved in the school improvement program, I have had direct, hands on, contact with this particular aspect. What I have found out in the semester that I thought this year is that, two full institute days have been spent, on trying to deal with a coming up with the school improvement program. arguing with the concept. What we found out was, there were very few parameters in order to give us the guidance that we needed to come up with a particular program that would pass the State Board of Education. Now let me tell you what it prohibits. prohibits, during that period of time, without limitation any proceedings to implement recognition standards for student performance or school improvement, proceedings to complete pending proceedings for the recognition non-recognition of schools or school districts, proceedings to place schools or schools districts on an academic watch list. Proceedings to conduct an on site visitation or evaluation or assessment incident to determine other whether the school or school district should be placed on a academic watch list, and proceedings to implement rules or regulations at the school or school district as part of the recognition process. What this Bill asks us to accept, is taking absolutely no responsibility for the quality of education being offered to the children of our state, from now until July 1, 1995. In my opinion that is not iust misguided, it is the most irresponsible proposal I have ever seen brought before us, and believe me folks I have seen a lot of irresponsible proposals, but this one not only takes the cake, it takes the cake with frosting."

Speaker Flowers: "Representative Ostenburg, to close."

Ostenburg: "Thank you, Madam Speaker and Ladies and Gentlemen of the House. Contrary to the comments that were just made. I think what this does is creates a greater opportunity for responsibility, because, in fact, what we're doing is not subjecting school districts, teachers, and administrators, to useless exercises, where they're preparing material that will them be rejected because it's not clear cut, being asked of them. But, in fact, gives the opportunity to the State Board, to work out the details, so that we do have a conscientious, and responsible response when it finally comes from the various school districts and schools. I think that this is an action that improves the process and, does nothing to deter from its effectiveness. long run, we will be far better served if these reports are prepared based upon accurate details. allow them to be prepared when the requirements are non-specific all we are doing is creating a mess out of which the schools are going to have a difficult time emerging with accurate material later on. urge a favorable response."
