Speaker Giglio: "Representative Deuchler, House Bill 1410."

Deuchler: "Mr. Speaker, Ladies and Gentlemen of the House. I move to concur with Senate Amendment 1 and Senate Amendment 2 to House Bill 1410. Senate Amendment 1 amends the Electronic Fund Transfer Transmission Facility Act to provide that a terminal may not bear any form of financial institution proprietary advertising other than simply a notice identifying the financial institution that established that particular ATM. In Senate Amendment 2, which contains further technical information expanding on Amendment 1 and adds the technical Amendment that includes point of sale terminals as well as ATM's, and I move to concur."

Speaker Giglio: "Any discussion? The question is, 'Shall the House concur with Senate Amendments #1 and 2 to House Bill 1410?' And on that question, all those in favor signify by voting 'aye'; opposed 'no'. The voting is open and this is final action. Have all voted who wish? Have all voted who wish? Have all voted who wish? On this question there are 114 voting 'yes', none voting 'no', and the House does concur in Senate Amendments #1 and 2 to House Bill 1410, and this Bill having received the required Constitutional Majority is hereby declared passed. Steczko: "Thank you, Mr. Speaker, Members of the House. I would ask that the House concur in Senate Amendment #1 to House Bill 1532. What the Senate did was deleted the Industrial Hygiene Technologists from the licensure requirements of this Bill and also exempted persons licensed under the Architecture Practice Act from the provisions of this Bill as well. There was also language that was provided that clarifies that this is not a practice Act, that this is a Title Protection Act, and also indicates by the presented action that all individuals required to be licensed under this new Act shall register with the Illinois Environmental Protection Agency within 90 days of the effective date of the Act. Mr. Speaker, I would answer any questions, but now would ask that the House concur in Senate Amendment #1 to House Bill 1532."

But they also incorporated House Bill 149, by Representative Saltsman, dealing with infectious wastes; House Bill 698, by Representative Schakowsky, dealing with some cleanup language there; Representative Black's piece of legislation, 1198, the Illinois Commerce Commission language; Representative Laurino's 1229, dealing with some problems they had in Chicago with the adjudicating vehicle compliance violations; Again, Representative Black's 1513 dealing with limousines and lengths and sizes of buses, I do believe as well as Representative Stephens Bill, 1646, with the Secretary of State's cleanup language and Representative Lang's language, as well, dealing in Cook County/DuPage about drivers license for the Secretary of State. Take the record. On this question there are 117 voting 'yes', none voting 'no', and the House does concur in Senate Amendment #2 to House Bill 1575, and this Bill having received the required Constitutional Majority is hereby declared passed. Bugielski, House Bill 1637. The Gentleman from Cook, Representative Bugielski."

Bugielski: "Thank you, Mr. Speaker, Members of the House. I move to concur in Senate Amendments #1 and 2 to House Bill 1637. Senate Amendment #1, what that does, it increases the maximum amount of materials, supplies and equipment that may be purchased by the Metropolitan Water Reclamation in an emergency, from \$25,000 to \$50,000, and Amendment #2 would annex the water reclamation district with the Rich Township, and I move to concur on these two Amendments."

Speaker Giglio: "Any discussion? The Gentleman from Cook, Representative Kubik."

Kubik: "Thank you, Mr. Speaker. Would the Sponsor yield?"

Speaker Giglio: "He indicates he will."

Kubik: "Yes, Representative, you said you...you're concurring with both Amendments? What does Amendment #1 do?"

Bugielski: "Amendment #1 would increase the amount of money that they would be able to spend in cases of an emergency from \$25,000 to \$50,000. There has been many cases where there have been sewer collapses and as you know they endanger the public health, and all they are saying is that they would like to increase that amount from 25 to \$50,000 in case...in cases of emergencies only."

Kubik: "Well, Representative, what is the current procedure?"

Bugielski: "The current procedure is where it's up to \$25,000, and over the past several years the cost of sewer construction has increased so dramatically that when you have a major sewer collapse that all they are asking is for the increase in the amount that they could spend without going through the open bidding process. And for your information, Lake County just was increased up to 100,000."

Kubik: "Well, Representative, what...what happens? I mean

if...if its over 25,000 then the...then what happens? Does the Superintendent handle this or who actually handles this?"

Bugielski: "This is only in cases of an emergencies (sic-emergency). This isn't for regular construction or repair, this is in cases of emergencies only."

Kubik: "I understand. But if it goes above \$25,000 as it is in current law, who then makes the decision to spend the money?"

Bugielski: "The Board and the Superintendent."

Kubik: "The Board and the Superintendent?"

Bugielski: "I would imagine. I'm not positive, Sir."

Kubik: "What constitutes an emergency?"

Bugielski: "When a sewer collapses, that would constitute an emergency."

Kubik: "I mean, I don't have the Bill in front of me, but I was wondering what would constitute an emergency?"

Bugielski: "A disaster, sewer collapse, where it is endangering the health of the public."

Kubik: "Well, Representative, I think that we ought to take a long look at this...this Bill before we pass it because it does change significantly, and I...I would ask my Members on the Republican side of the aisle to pay attention to this, that it does dramatically effect the amount of...of contracts that can be issued. These are contracts. Let's face it. These are emergency contracts that can be issued without allowing the Board to make a judgement as to whether these are good or bad and I think that the question of emergency is an open question. We ought to tighten that particular provision to make sure that this provision is not used to skirt the law. So, I would think that maybe what we ought to do is send this Bill to conference and

tighten up these provisions so that we can make sure that these provisions aren't used in a less than good manner. So, I would hope that we could oppose this Motion and make some changes in the language which is very wide open at this point and make sure that this isn't abused. We...we've spent a lot of time this session talking about how contracts are being issued and they're not being issued properly. And here we're saying, we're going to double the amount of contracts that can be issued by this authority without going to the Board of Trustees, and I don't know about you, but I think that before we do that we ought to make sure that this language is very, very tight and that it's going to work. So, I would hope that our side of the aisle and some of my colleagues on the Democrat side of the aisle might look at this Amendment and...and oppose it at this time. So, I would hope we would vote this Concurrence Motion down."

Speaker Giglio: "Any further discussion? The Gentleman from Cook, Representative Dart."

Dart: "Will the Sponsor yield?"

Speaker Giglio: "He indicates he will."

Dart: "The second Amendment here, which expands the Sanitary District. Why are we doing that?"

Bugielski: "This was on behalf of the Republican side of the aisle."

Dart: "This was for the Republicans and the Sanitary District is okay with having this...?"

Bugielski: "Yes, they are. They accept this..."

Dart: "And the expansion of the bonding authority to the year 2001, Representative?"

Bugielski: "Right. This is all an agreed between both sides of the aisle with the Metropolitan Water Reclamation

Dart: "Thank you."

Speaker Giglio: "Further discussion? Representative Wennlund, are you seeking recognition? Representative Bugielski to close."

Bugielski: "Thank you, Mr. Speaker. Just to clear up some problems that the other speaker on the other side mentioned. First of all this is for supplies only. This is a Republican Amendment that has been put on. It passed the Senate by 57 to 0. This is not something that we put on. This is a Republican Amendment that was put on to increase the fees. The same thing happened in Lake County where it went up to \$100,000. This is only for \$50,000 and I'd ask for a favorable 'aye' vote. Thank you."

Speaker Giglio: "The question is, 'Shall the House concur in Senate Amendments #1 and 2 to House Bill 1637?' All those in favor signify by voting 'aye'; opposed 'no'. The voting is open. This is final action. Have all voted who wish? Have all voted who wish? Lang, 'present', Tony. Have all voted who wish? Take the record. On this question there are 24 voting 'yes', 78 voting 'no', and the Gentleman's Motion fails. Representative Bugielski?"

Bugielski: "Thank you, Mr. Speaker. I wish to nonconcur on the Senate's Amendments #1 and 2."

Speaker Giglio: "All those in favor of the Gentleman's Motion signify by saying 'aye'; opposed 'nay'. In the opinion of the Chair the 'ayes' have it and the House nonconcur in Senate Amendments #1 and 2 to House Bill 1637. Representative McAuliffe on House Bill 1642. The Gentleman from Cook..."

Persico: "Well, for example, they...the State Board of Education sets up a system where only certain things can be used with these Chapter 1 funds, for example, the childhood education, reducing class size and so on. On the example of misuse would be something like maybe sending teachers to a educational seminar."

Dart: "But...and the penalty for the misuse of this fund though is though that we will not allow them to have this money next year."

Persico: "Just the Chapter 1 funds?"

Dart: "Just the Chapter 1...and how much money is...potentially are we talking?"

Persico: "Well, probably if all local school councils misuse it, it would be millions of dollars, but we don't expect that to happen."

Chicago or elsewhere?"

What I'm saying, is if they misuse this. For example, sending educators to a seminar, conference or something. That would be misuse.
