Senate Bill 402 as amended creates the industrial jobs recovery law to authorize any municipality to establish a redevelopment projects area and define economically in environmentally stressed areas to acquire land and to rebuild infrastructure within their communities. We move for its adoption."
- Speaker McPike: "Representative Granberg on the Motion."
- Granberg: "An inquiry of the Clerk? Mr. Clerk, what Amendments have been adopted to Senate Bill 402?"
- Clerk Rossi: "Amendment #3 has been adopted to the Bill."
- Granberg: "Representative Balthis, would you mind explaining the Bill as amended in a little more detail please?"
- Balthis: "Yes, the Bill as amended, actually tightens up the

original language which allowed for local communities to create an industrial park conservation area in communities where they have abandoned buildings, in areas, in communities where they have an unemployment rate that's in excess of the state or national level. It also is big in industrial buildings. It also allows them to clean up blighted or contaminated areas. It allows them the use of alternate bonds, that's...that's basically the intent of the Bill."

Granberg: "Representative Balthis what kind of requirements are for the issuance of the bonds?"

Balthis: "The...there are three different ways that actually the bonds could be used in this. In fact bonds are not the bottom line of it. They can use the increment from the land when it is actually going...goes into the district, how it increases as it is developed. They can use alternate bonds, which is the revenue off of that, or they can use a GO back stop. But they do not have to use GO bonds, it is primarily the revenues off the increment increase within the district."

Granberg: "If...if the bonds are issued? What would be the revenue stream for the debts service on the bonds?"

Balthis: "The increment from the district that's created. In other words whatever the level when the district was created and as that district's EAV increases there will be an increase just in that district and that revenue source would pay off the bonds."

Granberg: "Would this be similar to the TIF legislation that we passed years ago?"

Balthis: "Yes, yes."

Granberg: "And was..."

Balthis: "This was a site specific. It has some very tight and

restrictive requirements in it that are not in the current TIF law."

Granberg: "If it's similar to the current TIF legislation, would the state have any obligation on referencing our general revenue fund? Would we have to..."

Balthis: "Absolutely none."

Granberg: "So the state would have..."

Balthis: "There...there is no state obligation, there is no sales tax bonds in this...no sales tax money, it is purely and simply off of those sites that are being...that are being improved or upgraded within a local community."

Granberg: "So, this would be a property tax TIF? Similar to a property tax TIF?"

Balthis: "It would be similar, but this is primarily driven off of the EAV increases and that's the funding mechanism that's there."

Granberg: "Okay. Thank you, Representative."

Speaker McPike: "Representative Skinner."

Skinner: "Will the agencies that implement these TIF districts have quick take power? Quick take condemnation power? No.

No, I read in our analysis that this is payable by property tax and there is a possibility of a back door referendum.

How can a back door referendum be initiated?"

Balthis: "The same way that any other back door referendum, but this...this primarily is predicated upon the use of the increase in EAV inside the district, in fact, we have taken care of the school districts requirements in protecting them from the school aid formula lost so that they would not lose money as a result of this improvement."

Skinner: "Is it a 5% petition or a 2 1/2% petition or what?"

Balthis: "Five percent."

Skinner: "And that's 5% of what?"

Balthis: "Of the registered voters in... The voting members of that community." Skinner: "That is registered voters of that community?"

Balthis: "I believe it's the voting members."

Skinner: "Well does that mean those that voted in the last mayoral election for example?"

Balthis: "Yes, which is a smaller requirement of 5% than the registered voters."

Skinner: "Thank you very much."

Speaker McPike: "Representative Hoeft. I'm sorry, the Chair didn't understand your explanation."

Hoeft: "The light just jumped on, it happened to fly on, it's a
 mystery to me."

Hoeft: "It's a white light, it's not pink."

Speaker McPike: "Representative Balthis, to close."

Balthis: "Thank you, Mr. Speaker. I would ask for your concurrence in this Bill. This is a jobs creation Bill and a job saving Bill. It allows local governments a tool to operate to clean up blighted areas. In fact, the language was changed to tighten that language to make sure that it was contaminated areas, and those contaminated areas have to be defined in a finding by the IPA and other agencies have to be involved in this, so that this language has been tightened up. It is a very good tool for communities that have a high unemployment rate, abandoned buildings and I would move for its adoption."

Deering: "I heard you talking about organ donors and funding libraries and everything. How much of this money is going to go to state employees to sidestep the appropriations process? It's my understanding some..."

Erwin: "Okay, Representative, you will have ample opportunity through the normal appropriations process to look at the Secretary of State's budget to review any appropriations. The dollars allocated in this program are not in appropriations, so you will be...have every opportunity to review the appropriations when it goes through."

Deering: "But throughout all the testimony and all the talk about
'Live and Learn' it has been common knowledge that a lot of
these dollars are going to the operations of the Secretary
of State's Office and that's not coming through the

Erwin: "Well, I think we deal with Secretary of State's budget."

Deering: "Thank you."

Speaker McPike: "Representative DeJaegher."

DeJaegher: "Judy, I'm totally in support of organ donor...I'm in total support of library funding, but my question is this. Don't think shirking you we are some responsibilities as to the responsibility to my that we provide the Secretary of State adequate amount of money to run his particular office? What's going to prevent other constitutional officers for coming up with something similar to this that they again can acquire additional money for their office expenses, et cetera, that

George Ryan is going to be doing at this particular time? I think it's a bad precedent to establish ourselves in. I think we as a General Assembly have a responsibility to fund that office adequately without him going out and basically passing a tax increase upon the citizens of the State of Illinois."

Erwin: "Representative, let me just add that because the Secretary of State is the Head Librarian, and really the librarian for every community in this state, we've also asked the Secretary of State to be responsible for educating the people of this state on organ...on the organ donor program. I think this is a unique situation and so, I don't think it's circumventing the appropriations process, and I'm sure we'll have ample opportunity to review his budget, or whoever the next Secretary of State's budget is."

Speaker McPike: "Representative Edley."

Edley: "Thank you, Mr. Speaker, Ladies and Gentlemen of the General Assembly. Could I...would the Sponsor yield for a question?"

Speaker McPike: "Yes."

Edley: "Representative, the fees that are...that are going to be increased to fund these programs are coming from what source? Are they license fees, transfer fees?"

Erwin: "Representative, it's the vehicle title fee."

Edley: "Could you repeat that again?"

Erwin: "Vehicle registration, transfer fee."

Edley: "Vehicle registration fees?"

Erwin: "Correct."

Edley: "I'm...well I'm sure these are good programs. I don't know why we're using what has been traditional fee used for road funding projects using fees to fund libraries."

Erwin: "Representative, the vehicle title fee is a general revenue fund fee. Again let me add, the Secretary of State is the librarian for the whole state, and so we have placed in that office the unique responsibility to provide for libraries around the state, which we have not attended to over many years and so I firmly believe that this is an important responsibility if we're not going to come up with the money out of the general revenue fund someplace else, this is a very appropriate way to do it."

Edley: "To the Amendment or to the Motion. I...I think that while these projects are good and maybe should be funded out of our general revenue stream that this would...this funding source really diminishes the integrity of what has traditionally been used to fund our road projects and bridges and things like that, and I would oppose it on that ground."

Speaker McPike: "Representative Novak."

Novak: "Yes, Mr. Speaker, Ladies and Gentlemen of the House. You know I have the utmost respect for libraries in this state, but here we have a \$33 million proposition. All right, we've had fee Bills down here held up and bottled up because they are synonymous with the tax word and we've had these things held up for here...down here for a couple of years to help our communities and for other endeavors, help the environment and the public welfare. I just can't understand why something like this has to fly out of here so quickly without some more debate on it. I urge everyone to be very cautious about this. This is a big fee Bill."

Speaker McPike: "Representative Schakowsky."

Schakowsky: "Thank you, Speaker, Ladies and Gentlemen of the House. We do a lot of hand wringing around here about the need to educator our children and here is an opportunity in

a creative way to fund libraries which have been grossly suffering over the last several years. I know in our community we've had to deal with reduced hours, lack of appropriate books, an inability to provide the services that our kids need. This 'Live and Learn Program' that's being funded in this way is one that will provide more opportunities for our libraries and not unduly burden the taxpayers of Illinois. I think we should reward this creative way of finding the dollars and vote 'aye'."

Speaker McPike: "Further discussion? Any further discussions?

Representative Daniels, to close. Please give the

Daniels: "Mr. Speaker, Ladies and Gentlemen of the Secretary of State George Ryan, as you know, is charged responsibility of funding and assisting our libraries within the State of Illinois. He's also charged with the responsibility to make sure that our libraries throughout the State of Illinois furnish the required services to all of Illinois. Secretary of State Ryan, like most of us at state government, has been working very hard to find the resources necessary to involve the libraries in the current demands that are placed on them today. Whether it is that you want to go into a library to find a video a computer system, the latest novel, or non-fiction or fiction, you will find your libraries locally furnishing the needs of the people of the State of Illinois. T reviewed this process and this Amendment very, very carefully. I think it's come out of the Senate in a carefully crafted manner and I commend Secretary of State George Ryan for effort...for his efforts in this regard. The Sponsors of this Amendment, or this Amendment in the

So, along with the Speaker and Representative Erwin and Representative Cowlishaw, I proudly ioin sponsorship and the concurrence Motion that has been brought before the House today. Commend the Secretary for his fundings source and his effort to bring to the people of Illinois an outstanding and continuing service in the library system and proudly join in supporting concurrence Motion."

Speaker McPike: "This is final action. The question is, 'Shall the House concur in Senate Amendment #2 to House Bill 2123?' All in favor vote 'aye'; opposed vote 'no'. Representative Schoenberg, one minute to explain your vote."

Schoenberg: "I just want to say that I hope that Representative

Novak will be inviting everyone for coffee and donuts from

the Secretary of State's Office, just like you did during
the campaign."

Speaker McPike: "Representative von Bergen-Wessels."

von Bergen-Wessels: "Thank you, Speaker. To explain my vote. I recently got a letter from a constituent asking if we were willing to tax library cards to help our road fund if we would tax our drivers to help our library fund. I'm afraid I don't have an answer to her...to her question. I'm very concerned if we really want to help finance libraries that we do a more modest fee increase and let that money go to the library, instead of having a gigantic fee increase and having a good chunk of that money go to further the bureaucracy. My constituents keep saying they want less

money going to the bureaucrats and I don't see that this Bill does that."

- Speaker McPike: "Have all voted? Have all voted who wish? Have all voted who wish? The Clerk will take the record. this Motion, there are 86 'ayes', 26 'noes', and the House does concur in Senate Amendment #2 to Representative Tim Johnson, votes 'aye' and Representative Hughes, changes from 'no' to 'aye'. Representative Salvi, changes from 'aye' to 'no'. Further changes? On this Motion, there are 87 'ayes' and 26 'noes', and the House does concur in Senate Amendment #2 to House Bill 2123; and this Bill, having received the Constitutional Majority, is hereby declared passed. Senate Bill 536, Representative Mr. Parke. Terry Parke?"
- Parke: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. On Senate Bill 536, I refuse to recede and ask for a Conference Committee Report to be established."
- Speaker McPike: "The Motion is that the House refuse to recede from Amendment #1 to Senate Bill 536 and ask for a Conference Committee. All in favor say 'aye'; opposed, 'no'. The 'ayes' have it and the Motion carries. Any announcements? Any announcements? Representative Granberg moves that the House stand adjourned until Wednesday, June 2 at the hour of 3 p.m. All in favor of the Motion say 'aye'; opposed, 'no'. The 'ayes' have it and the House stands adjourned."
