It's the Chair's understanding that the House and Senate adjourn until Tuesday, the first call of the Governor, for the First Special Session deals with the budget, medicaid and bonds that would relate to the implementation of those programs. The second call from the Governor, for a Special Session #3, relates to the Baby Richard Bill that the House acted on last night, 2424, which may or may not come back from the Senate. But that's the special call for that. To my knowledge the four Leaders and the Governor are meeting currently and the intent of the Chair is to stand in recess until the call of the Chair. Special Session #3 will stand in recess until the call of the Chair."

Speaker McPike: "Second Special Session will come to order. I don't see anyone in Leadership on the...Oh, is anybody here. Oh, I'm sorry, I didn't see you. Okay. All right, Representative Wojcik would you like a Republican caucus? Okay. Representative Brunsvold, you were concerned about being kept in the dark, so we'll try to clarify it. Representative Granberg moves that the Second Special Session moves...stands adjourned until tomorrow at 10:00 a.m. All in favor say 'aye'; opposed, 'no'. The 'ayes' have it. Representative Granberg moves that the Third Special Session stands adjourned until tomorrow at the hour of 10:05 a.m. All in favor say 'aye'; opposed, 'no'. The 'ayes' have it.
