Senate Bill 706 becomes...under this Amendment, the ability for the Cook County Sheriff to operate a boot camp in Cook County with the approval of the County Board of Commissioners. The Amendment authorizes the Department of Cook County and the Department of Corrections to enter into an intergovernmental agreement with...under which persons in the Department's custody may participate in the county's boot camp program pursuant to criteria set forth in the Unified Code of Corrections. It also amends the Code of Corrections to authorize the Department of Corrections to operate a super maximum security prison which we have

already passed, but this was already in the Bill and we felt that it's the same exact language that we utilized prior to this Bill being printed, so I ask for your approval and adoption of this Amendment to Senate Bill 706."

Speaker Dunn: "On the Amendment is the Gentleman from Vermilion, Representative Black."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Dunn: "He indicates he'll yield."

Black: "Representative, there's nothing in this Amendment. Well,
let me back up. Does the Amendment become the Bill?"

Laurino: "Yes, it does."

Black: "All right. There's nothing in this Amendment that would state these impact incarceration programs in Cook must be operational prior to any super maximum security facility being on line?"

Laurino: "No, Sir."

Laurino: "I would assume, Representative Black, that the
