We do this and ask this in Your Son, Jesus name and we all say. Amen."

Speaker Steczo: "We will be led in the Pledge of Allegiance by Representative Hartke."

Hartke - et al: "I pledge allegiance to the flag of the United States of America, and to the Republic for which it stands, one nation under God, indivisible, with liberty and justice for all."

Speaker Steczo: "Roll Call for Attendance. Representative Kubik. Mr. Kubik, are there any excused absences on the Republican side?"

Kubik: "No, Mr. Speaker. All the Republicans are present."

Speaker Steczo: "Representative Currie."

Parke: "Thank you, Mr. Speaker. I'm not sure I understand what the Third Special Session, you're going to start it. Maybe you can give us..."

Speaker Steczo: "The Third Special Session was announced by the Governor and the intention was to address one issue. That issue, with the reading of the Message from the Senate, will have been accomplished. It will then be the intention of the Chair to adjourn the Third Special Session, sine die."

Parke: "The Third Special Session..."

Speaker Steczo: "The Third Special Session will adjourn, sine die because House Bill 2424...The Third Special Session was called by the Governor to address one issue. That issue will be able to be addressed on its own in the Veto Session should need be. Should the need arise."

Parke: "Okay. So, right now your asking us to stand at ease and be ready to do the work of the people whenever some kind of that work comes down."

Speaker Steczo: "That is correct."
