- Daniels: "Mr. Speaker, let the record show that all Republicans are here with the exception of Representative McAuliffe and Representative Salvi, Representative Parke. We are not registering in, in the quorum call because very frankly, we don't think that the people of Illinois should be charged \$81 a day and not do business. Now, we are here ready to business. If you'll call House Bill 12 in Special Session, if you'll call the Bill that the Senate has passed, the Budget Bill, put it up for a vote, we are prepared to take that action immediately. Mr. Speaker, we know that you don't have enough Members on your side of the aisle, the Majority Party to make up the quorum. We can see right now that there are 44 Members on the Democrat side of the aisle. There are 48 Republicans here at the present moment. We would like you to call House Bill 12, so that we can act on this business. At that time, we will be prepared to collect the per diem. Also, Mr. Speaker, as you know, a Bill has passed the Senate which is a per diem Bill that would prohibit per diem after Session, after when it goes into a Special Session like this after the adjournment time.
