Speaker Steczo: "Members will please be in their chairs. The chaplain for today is the Reverend Paul Stamm of the Athens Christian Church in Athens, Illinois. Reverend Stamm is a guest of Representative Moseley. All guests in the gallery may wish to rise for the invocation."

Reverend Stamm: "Let's just take a moment and pray together. Our Father in Heaven, You're so good to us, and I would ask now that You would give all these people here a sense of rest, a sense of Your comfort and Your peace. We thank You for all the work they do and all the hardships they go through, and we would just pray that You would give them Your wisdom. For it's the name Jesus. Amen."

Speaker Steczo: "We will be led in the Pledge of Allegiance by Representative Hawkins."

Hawkins - et al: "I pledge allegiance to the flag of the United States of America, and to the Republic for which it stands, one nation under God, indivisible, with liberty and justice for all."

Speaker Steczo: "Roll Call for Attendance. Kubik. Representative Kubik."

Kubik: "Thank you, Mr. Speaker. Let the record reflect that Representative Ryder, Walsh, and Wirsing are excused today."

Speaker Steczo: "Mr. Clerk, please take the Roll. One Hundred Fourteen Members having answered the quorum Roll Call, a quorum is present. Committee Reports."

Clerk Rossi: "The Committee of the Whole has heard public testimony and reports First Special Session House Joint Resolution Constitutional Amendment #1 back to the House without recommendation. Signed by Chairmans Representative Brunsvold and Representative Bill Edley."

Speaker Steczo: "State your inquiry."

Black: "Yes. For the record, we just would like to know from the Clerk, what position is House Joint Resolution Constitutional #1 on, right now?"

Speaker Steczo: "Mr. Clerk."

Clerk Rossi: "Second Reading."

Black: "It's on Second Reading of a what? Of a Supplemental Calendar? It isn't on the regular Calendar. That's why I was confused. We'll get a Supplemental? Another inquiry of the Chair. Have any Amendments been filed to this House Joint Resolution Constitutional Amendment?"

Speaker Steczo: "Mr. Clerk."

Clerk Rossi: "Ten Amendments."

Black: "Oh. Ten Amendments? So, I assume that those will be...will be heard at the appropriate time."

Speaker Steczo: "Mr. Black, at the appropriate time, they will be heard."

Black: "Yes. Prior to Third Reading...that's the specific appropriate time, correct?"

Speaker Steczo: "I would think that would be appropriate time."

Black: "Thank you very much."

Speaker Steczo: "For what purpose does the Gentleman from Peoria, Representative Leitch, seek recognition? Representative Leitch."

Leitch: "Thank you, Mr. Speaker. We would request a Republican Conference for about 45 minutes."

Speaker Steczo: "The Republicans will conference or caucus in Room...118."

Speaker Steczko: "The Chair recognizes Representative Currie."

Currie: "With news from the front, although not very specific news, the news is that the Senate is going to meet in the Rules Committee tomorrow morning at 8:00, and convene at 9:00. The House will come in at 10:00 tomorrow morning. We don't know whether to tell you to give up your hotel reservations tomorrow night. It just isn't clear what will be happening next, but the latest news is that we are prepared to adjourn now until 10:00 a.m. tomorrow. I wish I could tell you what to do about hotel reservations tomorrow night, but I think we're waiting on a meeting among the governor and the four tops, and that meeting is not, at this point, on the schedule. So, with that, Speaker, I would move that the House stand adjourned until tomorrow at the hour of 10:00 a.m."

Speaker Steczko: "Representative Currie moves that the House stands adjourned until Friday at the hour of 10:00 a.m. All those in favor will signify by saying 'aye', those opposed 'no'. The 'ayes' have it, and the...the House now stands adjourned."
