Resolved by the Senate of the 89th General Assembly of the State of Illinois, the House ofRepresentatives concurring herein that there shall submitted to the electors of the state for the adoption or rejection at the general election at the next occurring at least six months after the adoption of this Resolution a proposition to amend Section VIII of Article IV of the Illinois Constitution as follows: Article IV of the Legislature Section VIII, passage of Bills. The enacting clause of the laws of this state shall be being enacted by the people of the State of Illinois represented in the General Assembly. The General Assembly shall enact laws only by Bills. Bills may originate in either House but may be amended or rejected by the other. No Bill shall become a law without the concurrence of a majority of the Members elected to each House. Final passage of a Bill shall be by

record vote. In the Senate at the request of two Members and in the House at the request of five Members a record vote may be taken on any other occasion. A record vote is a vote by 'yeas' and 'nays' entered on the Journal. A Bill shall be read by title on three different days in each Α Bill in each Amendment thereto shall be reproduced and placed on the desk of each Member before Bills, except Bills for appropriations and passage. for decodification, revision or rearrangement of laws shall be confined to one subject. Appropriation Bills shall limited to the subject of appropriations. A Bill expressly amending a law shall set forth completely to Sections amended. The Speaker of the House of Representatives and the President of the Senate shall assign each Bill that passes both Houses to certify that the requirements for passage have been met. After November 5, 1996, no portion of any Bill shall require a unit of local qovernment or school district to establish, expand, modify or increase its programs, activities or services in such a way as to necessitate the expenditure of additional public revenue by the unit of local government or school district unless at least one of the following applies. appropriates additional funds to the unit government or school district to fully fund the additional expenditures necessary to carry out the requirement for each year the requirement is in effect, the Bill passes with the concurrence at least three-fifths of the Members elected to each House. That portion of the Bill imposes a federal law that the unit of local government or school district would otherwise be required to meet by federal law imposes a state or federal court order with no additional requirements imposed by the state. Or

portion of the Bill creates, expands or modifies a specifically defined crime. A law enacted after November 1996, may not be the basis for administrative rules, regulations or actions that requires a unit of local government or school district to establish, expand, modify or to increase its programs, activities or services in such a way as to necessitate the expenditure of additional public revenue by using the local government or school district unless the law authorizes the rules, regulations or actions. The Subsection E does not apply to any portion of a Bill that limits or regulates the ability of unit of local government or school district to raise revenue. Schedule this Constitutional Amendment take effect upon approval by the electors of this state. First Reading and introduction of Senate Joint Resolution Constitutional Amendment #3. Referred it to Rules Committee. Committee Report. Committee from Representative Noland, Chairman for the Committee on Agriculture, to which the following Bills were referred.
