Speaker Madigan: "Okay. Mr. Clerk."

Clerk Rossi: "Committee Reports. Representative Edgar Lopez, Chairman from the Committee on Consumer Protection, to which the following measure was referred, action taken on February 3, 1998, reported the same back with the following recommendation: 'be approved for consideration' Conference Committee Report #1 to House Bill 597; Representative Dan Burke, Chairman from the Committee on Executive, for which the following measures were referred, action taken on February 3, 1998, reported the same back with the following recommendation: 'do pass short debate' House Bill 2385, 'be approved for consideration' Conference Committee Report #1 to Senate Bill 120; Representative Shirley Jones, Chairman from the Committee on Rules on Public Utilities, for which the following measures were referred, action taken on February 3, 1998, reported the same back with the following recommendations: 'be approved for consideration' Conference Committee Report #1 to House Bill 263. Supplemental Calendar #1 is being distributed."

Speaker Madigan: "Mr. Black, are you prepared to call your House Bill 2473? On page 2 of the Calendar on the Order of House Bills - Third Reading, there appears House Bill 2473. Mr. Clerk, read the Bill."

Clerk Rossi: "House Bill 2473, a Bill for an Act concerning the location of adult entertainment facilities. Third Reading of this House Bill."

Black: "Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. This Bill, as amended, yesterday, actually amends a Bill that you passed last year, and all this does is to amend the County Code and the Municipal Code that prohibits the location of an adult entertainment facility and that is explained in the underlying Bill, within 1000 feet of the property, the actual preserve property, operated by any forest preserve or park district in the State of Illinois. I'd be glad to answer any questions you have."

Speaker Madigan: "Is there any discussion? There being no discussion, the question is, 'Shall this Bill pass?' Those in favor signify by voting 'aye'; those opposed by voting 'no'. This is Third Reading. Have all voted who wish? This is a Third Reading Roll Call. Have all voted who wish? Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question, there are 117 people voting 'aye', 0 voting 'no'. This Bill, having received a Constitutional Majority, is hereby declared passed. On the Supplemental Calendar #1, there appears House Bill 20, excuse me, House Bill 263. Mr. Ryder."

Ryder: "Thank you, Mr. Speaker. I would move to adopt the First Conference Committee Report to House Bill 263. This incorporates some clean-up language in the

telecommunications rewrite. I want to be very specific on two items. One, some of you may have received correspondence on this particular Bill indicating that some consumer groups had problems with one section of the Bill. That section has been removed. The consumer group is now in support of the Bill. I know of no opposition to the Bill and we believe, as a result, that Conference Committee Report is now acceptable. Secondly, anytime that there is a telecommunications Bill, there is sometimes a concern that it would affect the cable industry. That is not the case. It does not affect the cable industry in any fashion. I would be happy to answer any questions, should there be any. And I do wish, as a final note, to thank my very capable, courageous cosponsors on this Bill."

Speaker Madigan: "Mr. Granberg."

Granberg: "Will the Gentleman yield?"

Speaker Madigan: "The Sponsor yields."

Granberg: "Representative Ryder, it was my impression that Representative Novak was the Sponsor of this Bill, was the previous Sponsor."

Ryder: "I believe that's correct, Sir. He was, indeed and he was kind enough, he was kind enough, Sir, to allow me to do the heavy lifting because he had very important matters that required his attention and I was happy to accommodate him."

Granberg: "Did he need... did he need your assistance and... Well, you've always been a Gentleman. But for the edification of the Members on this side of the aisle, the Citizen's Utility Board, as you explained, was in opposition to the Bill a few months ago, they are now supporters of this Bill. So, the Citizen's Utility Board has come on board. Any controversial provision has been removed from the Bill in the final Conference Committee

Report that's been drafted. There is no opposition. It has nothing to do with cable. Everyone is in favor of the Bill and you know of no opposition? Thank you."

Ryder: "That is correct. I know of no opposition."

Speaker Madigan: "Is there any further discussion? There being no further discussion, the question is, 'Shall this report be adopted?' Those in favor signify by voting 'aye'; those opposed by voting 'no'. Have all voted who wish? This is a Third Reading Roll Call. Have all voted who wish? Have all voted who wish? This is trailer language to various pieces of legislation that were passed in the last Spring Session that needed clean-up and I would ask for a favorable vote. Thank you."

Speaker Madigan: "The Gentleman moves for the adoption of the Conference Report. Is there any discussion? Is there any discussion? Representative Wojcik, are you prepared to offer Senate Bill 120, where you're the second named Sponsor after Mr. Burke?"

Wojcik: "No, I don't think so."

Speaker Madigan: "It's concerned with the Juvenile Court Act. Representative Slone, are you prepared to call your Bill? On the regular Calendar, on the Order of House Bills Third Reading, there appears House Bill 2471. Representative Slone. Mr. Clerk, read the Bill."

Clerk Rossi: "House Bill 2471, a Bill for an Act amending the Park District Code. Third Reading of this House Bill."

Speaker Madigan: "Representative Slone."

Slone: "Thank you, Mr. Speaker, Members of the House. Last year, you passed legislation to bring the Wildlife Prairie Park in Peoria County into the State Park System. The Wildlife Prairie Park is adjacent to some property that belongs, currently, to the Peoria Park District and this Bill would allow the park district, if it so chooses, it's a permissive piece of legislation, to give to the Wildlife Prairie Park or some other agency of State Government, a piece of property that would serve as a buffer and wildlife habitat and be added to the park if the park district so chooses. So, it would allow a gift to park district land and I would be happy to answer any questions. Thank you."

Speaker Madigan: "Mr. Black."

Black: "Yes, thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "The Sponsor yields."

Black: "Representative, perhaps I've been misinformed, but I thought you were to hold this Bill and work out some language with the Illinois Association of Park Districts. Is that a misunderstanding on my part?"

Slone: "I certainly said, in committee when the committee supported the Bill, that I would be willing to do that and I have not heard from the park districts if they have other language that they would like to see. They had a concern having to do with whether existing language in the statute would require the same kinds of safeguards in the case of a gift and, since I had not heard from them, my understanding was that they read it as we read it, which is that it would require those safeguards."

Black: "So, in the absence of any language from the Association of Park Districts, then it's obviously your intent to run this Bill out on Third Reading, correct?"

Slone: "I beg your pardon."

Black: "It's... since there is no language in the Bill from the Illinois Association of Park Districts, and I think they have a very legitimate concern, I'm only left to assume that you desire to pass this Bill today without some language that many of us would like to see in the Bill."

Slone: "Mr. Black, if there's a real problem with the Bill, I'm certainly willing to take it back to Second Reading and wait for another day to do that."

Black: "Well, I... again, and if I'm wrong, I apologize, but it was my understanding that you were going to hold this Bill on Second Reading until the park districts could put some language that would clarify the Bill, otherwise, you're opening a Pandora's Box where a park district, without due notice to the public, could give land to somebody else. I

don't think that's a good policy. I understand the situation in your district and I don't think there's any opposition to that, but this, then, becomes the policy of state law and I know some people have expressed some serious concerns to me about the implications of this Bill statewide, and I don't want to try and tell you what to do with your Bill, but without that Amendment, Representative, I would stand in opposition to the Bill."

Speaker Madigan: "Is there any further discussion? Representative Slone to close."

Slone: "Thank you, Mr. Speaker. I... if there is any further suggested changes in this legislation from the park districts, I would be pleased to hold the Bill, if need be, or to deal with this on the Senate side to make any changes they feel is necessary, so, I would appreciate a favorable consideration of the Bill today. Thank you."

Speaker Madigan: "Representative, just as I recognized you to close, Mr. Brady was seeking recognition, so we'll recognize Mr. Brady. Mr. Brady."

Brady: "Will the Sponsor yield?"

Speaker Madigan: "The Sponsor yields."

Brady: "Representative, I have a question for you. This only allows property to be given to the State of Illinois, sold or leased to the State of Illinois. Is that correct?"

Slone: "This would allow park districts, which are currently allowed to sell or lease property, they are currently allowed to sell or lease property to the State of Illinois, it would allow them to make a gift to property of the State of Illinois, but only for continued use for park purposes or recreational purposes."

Brady: "Okay, when you sell or lease property, it's a contract between two government agencies in this case. When you

give it, does the State of Illinois have to receive it? In other words, if a ..."

Slone: "I don't know that the... I don't know that the state would be obligated to receive it, no."

Brady: "Well, I guess it's kind of a question that I have. If I... we have a park district that owns a piece of land that's contaminated and they decide that they want to now give that property to the State of Illinois, can they do so, without the state receiving it?"

Slone: "Can they give it to the state without the state receiving it?"

Brady: "Wishing to receive it?"

Slone: "For use... for a particular type of land use. I would assume that the state would have the ability to refuse a gift of land that it did not wish to receive. But the Bill doesn't really address that in any detail."

Brady: "So, clearly, your intent and the intent of this legislation is, the state must agree to receive any gift from a park district and if the state refuses, although you haven't provided a mechanism to refuse, to receive that gift, they can do so?"

Slone: "I would assume so, but I regret to tell you that I can't tell you for sure. I haven't done the necessary research on that, but I would... It's my belief that the state can refuse to receive a gift, yes."

Brady: "Can... under this legislation, can this land only be given to the state or can it be given to another entity?"

Slone: "This would only allow a gift to the State of Illinois, or an agency of the State Government, is my understanding, or local government, I beg your pardon."

Brady: "We appear to have some question on that. We don't quite agree... Representative, I'd ask you to take this Bill and

hold it so that you could come to some understanding here within this Body. I think there is some areas that are vague. I think I understand one of your... one of the things you wish to do. I happen to support some of what you want to do, but I'm not sure this language is correct. Would you be willing to do that?"

Slone: "Yes, I request that the Bill be taken out of the record. Thank you."

Speaker Madigan: "Once again, Representative Slone to close. Oh, the Lady wishes to take this out of the record, so take the Bill out of the record."

Slone: "Thank you."

Speaker Madigan: "Mr. Burke. Mr. Burke, are you prepared to call Senate Bill 120? All right, Mr. Clerk, we'll go to the Order of the Supplemental Calendar #1 and the Chair recognizes Mr. Burke on Senate Bill 120."

Burke: "Thank you, Speaker. Senate Bill 120, having passed out of the Senate and just considered in our committee, Executive Committee, yesterday, has to do with the practice of Naprapathy in the state, and, in particular, when a malpractice action is brought against any naprapath in the state, currently, only a medical doctor would be asked to testify in that action. We are asking that the statute be amended to suggest and include naprapaths as the professional that would testify in malpractice actions, and I'd be happy to answer any questions."
