Speaker Madigan: "Mr. Novak."

Novak: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 2295 amends the Downstate Transportation Act by removing the 10% cap that is currently in place. Let me just explain essentially what this Bill does. It helps out the newly, fledgling Kankakee Transit District. In the City of Kankakee, the mayor has started a transit system just within the city limits of Kankakee within the surrounding communities that are contiguous, communities that I live in such as Bradley and Bourbonnais and Aroma Park. They are under consideration right now, with the strong possibility that more communities may join this transit system. So the Illinois Department of Transportation has given us language; they are in support

of the Bill. And this does not take any dollars away from any existing downstate transportation system that is currently being funded by IDOT. I'd be more than happy to entertain any questions."

Speaker Madigan: "The Gentleman has moved for the passage of the Bill. The Chair recognizes Mr. Black."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "The Sponsor yields."

Black: "Representative, I'm not sure how many people heard you, and I think it's very important that we make sure they understand that what you are doing does not have an adverse impact on anyone else's mass transit district. You may want to reiterate that."

Novak: "Yes. Mr. Speaker. Mr. Speaker, could we have some order, please? Yes, Representative Black, that is correct. This Bill specifically takes the cap off just for the Kankakee Transit System, and there's not one dime comes from any other transit systems that are currently in operation in the State of Illinois."

Black: "Representative, some questions have come up about why we're eliminating or getting away from that 10% cap. As I recall our earlier discussion, it's simply to catch you up since you are a relatively new transit district. Is that correct?"

Novak: "Representative Black, you are correct. The transit system started about two years ago. Although we did change the law in 1989, a transit system never was put together and now, more people are sitting down at the table and considering expanding it with the neighboring communities, and you are correct."

Black: "Thank you very much for your forthright answers,

Representative. I stand in support of your Bill. It's a reasonable Bill that many of us have benefited from, and as I will be reminding you in the months ahead, Kankakee is a downstate city. Keep that in mind. You're going to hear that in the months ahead. Kankakee is a downstate city."

Novak: "You are right."

Black: "I rise in full support of the great City of Kankakee."

Speaker Madigan: "Mr. Novak to close."

Novak: "Yes, thank you, Mr. Speaker, and thank you, Representative Black. Kankakee is a downstate city and Kankakee for everyone's information, the metropolitan area is the only metropolitan area in the entire state that does not have a transit system. So, this Bill takes the cap off to allow them to receive more funding from IDOT. IDOT and the Governor's Office are in support, and I ask my colleagues to join me in voting for House Bill 2295. Thank you very much."

Speaker Madigan: "The Gentleman has moved for the passage of the Bill. Those in favor signify by voting 'aye'; those opposed by voting 'no'. This is a Third Reading Roll Call. This is a Third Reading Roll Call. Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question, there are 116 people voting 'aye', 0 voting 'no'. Speaker Madigan: "Mr. Noland."

Noland: "Thank you, Speaker. House Bill 2315 is an initiative that Representative Hartke and I are working on. What it essentially does, it allows unclaimed dividends, patch these dividends from Ag cooperatives that are presumed abandoned to be returned to the cooperative instead of being claimed as an unclaimed asset."

Speaker Madigan: "Mr. Noland."

Noland: "I have addressed the Bill."

Speaker Madigan: "You've spoken to the Bill?"

Noland: "Yes, I have."

Speaker Madigan: "Okay. The Gentleman has moved for the passage of the Bill. Mr. Black."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "The Sponsor yields."

Black: "Representative, can you tell me what... are there any other exclusions in the Unclaimed Property Act at the present time? Any other entities or individuals or businesses that do not have to comply with the current Unclaimed Property Act?"

Noland: "Mr. Black, there are. There's one other, and that's in reference to electric cooperatives or telephone cooperatives. So what we are doing is allowing agricultural cooperatives to be on the same standing as electrical or telephone cooperatives."

Black: "Do you have any estimate of potential revenue loss should your Bill become law?"

Noland: "Yes, I do. It's minimal; however, Growmark, the large farm supply cooperative in Bloomington, has 60% of all the cooperatives in the state. So Growmark is the majority cooperative in the state. They estimate that over three

years, the average unclaimed asset would have been \$50,000 per year. Now, if they are 60% of the total, another 40%, so we're looking at maybe \$75,000 annually. We feel that the paperwork and the staff time and the effort to return that money is... and for Department of Financial Institutions to work with that, doesn't make sense. The money should stay in the local cooperative, in the membership hands to build up that cooperative in the local communities."

Black: "All right. Thank you very much, Representative."

Speaker Madigan: "Mr. Hartke."

Hartke: "Thank you very much, Mr. Speaker. I stand in support of this legislation. As Mr. Noland said, this is a minor problem for the agency; however, it's a major problem for the co-ops to go through the paperwork and so forth. So I stand in support of this piece of legislation, and I think it's only in fairness that the dividends and patronage that was meant for the co-ops stay with that co-op, for that was its intent originally as the money was invested, and I think it should stay there. Thank you, Mr. Speaker."

Speaker Madigan: "Mr. Hannig."

Hannig: "Yes, thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "The Sponsor yields."

Noland: "Yes, it will. To Mr. Black's question, I estimated that Growmark thought it would cost \$50,000 a year over the last three years, \$50,000 per year. They comprise 60% of the agricultural cooperatives in the state, so I'm estimating the cost will be around \$75,000."

Hannig: "Okay. Thank you, Representative."

Speaker Madigan: "The Chair recognizes the Clerk for an

First of all, have you ever worked with the Unclaimed
Property Act?"

Noland: "Annually, they send us a whole listing of people whose... who have assets that haven't been claimed, and so I've attempted in the past to send letters to the people. Generally, generally, they can't find them, so that's why it's unclaimed."

Tenhouse: "Do you know what currently takes place as far as company is concerned? Let's say you have checks that are outstanding, you have to search out to find out who actually is the owner of the check. I guess my real question to cut to the chase here is, what incentive would there be for these cooperatives to see that those patronage refunds are returned to the members?"

Noland: "That's a good question. The incentive is, these are member-owned cooperatives. The members on the board of directors are the cooperative, and so if they don't know whose estate it is and how to find grandma's heirs or grandpa's heirs, nobody will. So, I think a local cooperative in an area, they will know, they will know how to find Johnny or Susie easier than anyone. And if the local cooperative doesn't know, the State of Illinois sure

won't find out."

Tenhouse: "But to play Devil's advocate here, Representative Noland, what happens if you're sitting with \$50,000 in unclaimed patronage dividends, what incentive is there for you to go out and really try to find those folks as opposed to turn it back? And what I'm saying is at present times, the co-ops, like all companies are pretty aggressive in trying to see that those dollars are returned to the members, as opposed to sending those dollars into Springfield."

Noland: "Well, I have not heard a hue and cry from the electric co-ops or from the telephone co-ops, and this is... we're doing the same thing for them. So I guess if there was some... If there was an issue about poor business practices or somebody being bilked out of their rightful asset, I think we would have heard that. I don't believe that would happen, but then again, Mr. Tenhouse, anything can happen. Last year, the Growmark system only had \$50,000 for over 140 cooperatives. So we're looking at maybe \$350 per cooperative. So we're talking about a little amount of money, but I know it's still in total a considerable size of money."

Tenhouse: "But again, Representative, one of the reasons they only turned back \$50,000 is because they had the incentive to go out and search out those members. Now, why would that incentive continue to exist if they know that those dollars are not going to be turned back to Springfield?"

Noland: "Well, the board of directors, again, are local people and they have good names, good reputations. And I can't imagine a farmer-owned co-op, seven or nine local farmers, trying to cheat grandmother out of a \$300 check. I mean, that just doesn't happen in rural America. Now, yes, there

might be an isolated case, but that rarely happens. Again, what you're asking is the same question we could ask of electric co-ops and the telephone co-ops, and that has not happened."

Tenhouse: "Thank you, Representative."

- Kosel: "Thank you very much, Mr. Speaker, Ladies and Gentlemen of the House. This Bill takes the hold harmless provision of House Bill 452 and rolls it into the continual appropriation of that Bill, thus stating that no school district will receive less dollars this year than they did the previous year."
- Speaker Madigan: "The Lady has moved for the passage of the Bill.

 Is there any discussion? Mr. Black."
- Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"
- Speaker Madigan: "The Sponsor yields."
- Black: "Yes, Representative, would you be willing to accept an Amendment that I have and if we could amend the Bill on its face?"
- Kosel: "I would have to see what the Amendment was, Sir."
- Black: "Well, it just says that all school districts will receive no less money, but those in my district could receive more money. Would that be all right?"

- Skinner: "I wonder if the Lady could tell us if this means that

Kosel: "This will mean that no school district will receive less money than they did in the previous year. What this does, Representative Skinner, is it nails the top and then it allows us, as a state, through the... through the foundation level to start racheting up the bottom. So that no longer will your school districts from your district be able to say, 'I have less dollars this year than I did the year before.'. And I know you've said that in the past, Sir."

Skinner: "Well, fortunately, none of the school districts in my district got less money, but there was one in McHenry County that did. Thank you."

Kosel: "You're welcome."

Speaker Madigan: "Mr. Moore."

Moore, E.: "Mr. Speaker, I rise in support of House Bill 2411, certainly an excellent piece of legislation, done by our co-person over there on the other side of the aisle as appreciate this Bill. Certainly it's going to surely hurt some of our communities that this Bill is not actually supported, and I support it 100% for providing for Oak Park Township. So make sure we all put up 118 votes on this Bill. Thank you very much."

Speaker Madigan: "Mr. Novak."

Novak: "Yes, thank you, Mr. Speaker. Will the Lady yield?"

Speaker Madigan: "The Sponsor yields."

Madigan: "Could the Members give their attention to Representative Kosel?"

Kosel: "This Bill... This Bill would fund it as a continuing appropriation for three years. The funding after three years would be subject to the appropriation. It rolls it into the continuing appropriation part of 452, which will be addressed after three years. If this works, I will be out there very strenuously supporting a continuation of this."

Novak: "Okay, so what we're saying, that since it's going to go into continuing appropriation, it's just like our obligations to pension payments in the state. It just comes... Every year that money for this hold harmless comes right off the top and it's dedicated."

Kosel: "That's correct. That's correct."

Novak: "Okay. Now, this is for high school districts or for all school districts?"

Kosel: "All school districts throughout the state from border to border."

Novak: "...that are affected by this? Okay, now the big question is, Representative, what do we do after three years?"

Kosel: "After three years, if this is working, then you and I
will sit down and make sure that it goes on."

Novak: "Well, I mean, I understand that, but the life of the entire program is for three years. What do we do after

three years? Do we go back to the table and start all over again?"

Kosel: "There's many provisions in that Bill that are ongoing.

It's just after three years, there's some provisions that have to be re-evaluated. This particular continuing appropriation would have to be re-evaluated, not the hold harmless in itself. The hold harmless is for subsequent years and so it would go on. Only the continuing approp would have to be re-evaluated."

Novak: "Thank you, Representative. I'm not standing opposed to the Bill. I'm sure there isn't anybody opposed to the Bill on the floor, but we need to get this passed so to make sure that we can at least say to those high school districts and school districts that didn't get one red cent under House Bill 452 or even stood to lose hundreds of thousands of dollars annually, at least this is going to put a stop to that for a temporary moment. So I support the Bill. Thank you."

Kosel: "Thank you."

Speaker Madigan: "Mr. Lang."

Lang: "Thank you, Mr. Speaker, Ladies and Gentlemen. I rise in support of House Bill 2411. This is an excellent concept. Many of us who voted for the Education Funding Reform that we passed, said at the time that there were significant flaws in that Bill. One of the flaws was that the money for schools was only going to be guaranteed for three years. So I think the Lady has an excellent approach here. We need to continue that hold harmless for as long as we can possibly do it; otherwise the reform package that we passed won't really have the teeth we desired. So I would recommend 'aye' votes."

call your Bill? Mr. Clerk, read the Bill."

Holbrook: "Thank you, Mr. Speaker. Mr. Speaker, House Bill 2424 is an initiative of the township officials. I know of no opposition to the Bill. It allows political affiliation to be established by party caucus. It cleans up some language where there is conflicting amounts on population for township officials on who's eligible for office, and it changes the time of filling the vacancy from 60 to 120 days. It will be subject to appropriation by the General Assembly for the Economic Development Matching Grant Funds, easy for me to say, a special fund created by the State Treasury to nonprofit organizations and local units of government whose primary objectives are to promote Illinois communities as sites for industrial and business location and expansion. It provides that the application proposed project must have a definite impact on businesses and industries attraction, recruiting and retention. Provides the factors to be considered in choosing grant recipients and provides that the state grant dollars shall be evenly matched by the applicant. It provides that money appropriated to the program for a grant shall be deposited in the Economic Development Match Grant Fund, and it shall not lapse... And it shall not lapse into the General Revenue Fund at the end of the fiscal year. Provides that these grants shall be in addition to any other grants that are currently in existence. I'd be glad to answer any questions."

Dart: "Will the Sponsor yield?"

Dart: "Representative, we talked about this Bill in committee, and there was a great deal of concern that was made about whether or not this was going to be adverse to urban areas.

Can you give me your intent on that issue as far as...?"

Dart: "And, as of right now, there is no money set aside for this?"
