As you know, naprapathy is a licensed medical practice in the State of Illinois, and currently they do not have the opportunity to be reimbursed by insurance. This Bill would simply give the people of Illinois broader access to health care providers. Many people, including financially disadvantaged, are denied the opportunity to receive naprapathic care unless they can pay out of their pocket. Patients have an expectation to receive insurance reimbursement on all health care, including naprapathic care, and they don't receive it. Naprapaths are part of a manual medicine, as are chiropractors and physical therapists. These two disciplines are already covered under minimal benefits available under the Illinois Insurance Code, and I'd be
