Acevedo: "I'd like to introduce a former Member of the House, an Alderman of the 12th Ward from the City of Chicago.

Alderman Ray Frias"

Speaker Madigan: "Ray Frias. Mr. Hartke in the Chair."

- Speaker Hartke: "On page 36 of the Calendar, appears Senate Bill #22. Representative Curry. Representative Curry."
- Curry: "Thank you, Mr. Speaker. Pursuant to Rule 58(a), I'd like to move to discharge from the Appropriations and Elementary and Secondary Education Committee, Senate Bill 22 from further consideration and place on the Calendar Order of Second Reading."

Ryder: "Thank you, Mr. Speaker. I noticed the Clerk also doesn't have all the hyphenated cosponsors on the Bill either otherwise it would show that I was a hyphenated cosponsor. I wished to draw the attention of the chamber to this Bill. This Bill was expedited out of the Senate to make the appropriation for the technology fund that all of our schools have been waiting to hear. It's with my encouragement that we would discharge the committee so that we might move this Bill as quickly as possible to the Governor's desk, so that our schools can receive the money. We all passed out of here, I believe last week, a piece of legislation that was intended to do that. The Senate in their wisdom has decided to take this approach. I want to get the money to the schools and for the kids and I'm encouraging you to join in the Motion to Discharge Committee and advance to Second Reading so that I'd do that even as an undisclosed but accomplish this. hyphenated cosponsor."

Speaker Hartke: "Further discussion? Seeing none. All those in favor of the Lady's Motion signify by saying 'aye'; those opposed 'no'. In the opinion of the Chair, the 'ayes' have it and the Motion carries. Clerk announcement."

Currie: "Thank you, Speaker, I believe the rule about assigning measures applies to Bills, not to Resolutions. As Chair of the Rules Committee, I can tell you, we have not yet seen House Joint Resolution 11 in time for a Rules Committee meeting. Nobody is trying to suppress the measure and I'm sure it will be appropriately referred early next week."

Speaker Hartke: "Representative Cowlishaw."

Cowlishaw: "Thank you, Mr. Speaker. I am certainly pleased by your prompt response. I thank you for that very much, and I thank Representative Currie for her declaration about the fact that House Joint Resolution 11 will be assigned to a committee in the early part of next week. I am grateful for that commitment. I shall watch that with great interest. Thank you, Mr. Speaker."

Speaker Hartke: "You're welcome. Ladies and Gentlemen, may I have your attention please? Would the staff please retire to the rear of the chamber? Could we have a little order in here? - Speaker Hartke: "That is your Motion? The Motion to recommit all the Bills passed yesterday, the Four hundred and thirty the Parliamentarian will explain this procedure."
- Parliamentarian Uhe: "On behalf of the Speaker, I believe the Motion is to recommit all the Bills that appear on the Calendar on Second Reading that contained an asterisk next to them."

Speaker Hartke: "Mr. Burke."

- Burke: "Mr. Speaker. In deference to the Parliamentarian, indeed, those Bills, which number some 434, which would appear on today's Calendar, identified with an asterisk, will in my Motion, be recommitted to consideration by the Executive Committee."
- Speaker Hartke: "You've heard the Gentleman's Motion. Is there any discussion? The Chair recognizes the Gentleman from DuPage, Representative Daniels."
- Daniels: "Mr. Speaker, Ladies and Gentlemen of the House. I appreciate Representative Burke's Motion. I believe it's the right thing to do. And I believe that in conjunction with the discussion I had with Speaker Madigan, we'll be sitting down to talk about how some of these Bills should be on the House Floor with agreement and I think we'll be able to reach an agreement. So I appreciate Representative Burke's Motion and thank you very much."

Speaker Novak: "Representative Burke"

Parliamentarian Uhe: "In response to Representative Lang's inquiry, indeed, the matters that have been included in this one roll call were Bills with nonsubstantive language.

Our term is 'vehicle Bills.' Any Bill that had an Amendment on it was not included in this bulk 434 Bill roll call.

Mr. Lang, any matter that you have brought to the attention of the Executive Committee with substantive language will be heard and will be considered in proper form."

Speaker Hartke: "Speaker Madigan in the Chair."

Speaker Madigan: "The matter before the House is a Motion by Mr.

Burke, the Chairman of the committee to recommit a section
of the report of the Executive Committee, on that Motion,
the Chair recognizes Mr. Lang."

Lang: "Thank you, Mr. Speaker. Mr. Burke misunderstood my question. The question relates to Floor Amendments that have already been filed, no Committee Amendments. So, some of the Members have already asked me whether they'll have to refile their Floor Amendments..."

Speaker Madigan: "The answer..."

Lang: "That's all we want to know."

Speaker Madigan: "The answer is yes."

Lang: "Thank you."

Speaker Madigan: "Representative Erwin."

Erwin: "Thank you, Speaker. I'm just trying to understand. There

are some of us, I think particularly Committee Chairs, who normally do a vehicle Bill or two, to assist Members in moving issues, where they may have some difficulty with late issues. I know I was one who inquired as to whether or not, I could have a vehicle Bill recommitted from Executive to my committee, the Higher Education Committee and indeed, I was prepared to do a letter in that event. Then when they all came out, the assumption was that was no longer necessary. Now we're up against a deadline next week, and so, my, my you know ,inquiry, which I think is a legitimate one for Chairmen who are trying to facilitate Members getting their Bills in proper order. We will be left, as Committee Chairs, with no vehicle with which to do those wonderful things that we need to do."

- Speaker Madigan: "Yeah. Representative, Representative Daniels and I met this morning. And our plan is to work on this question and some time next week, there will be a list of vehicle Bills which will be moved to the Calendar and we will work cooperatively with everybody in that regard. Representative Mulligan."
- Mulligan: "Thank you, Mr. Speaker. If we filed substantive Amendments onto a Bill which would indicate that a Bill should go to a different committee other than Executive Committee. Do we have to file a letter with it at the same time asking for it to be recommitted to a different committee? And why would you want Executive to hear something that may be a township Bill or...?"
- Speaker Madigan: "Well I think your point is well-taken, and if there's a vehicle Bill on the Calendar and you wish to file an Amendment to that Bill, if you could advise us as to which committee you would like the Amendment to be heard, please do that, and we'll attempt to accommodate you. But

your point is very well taken. There being no further discussion, the question on the Motion, those in favor say 'aye'; those opposed say 'no'. The 'ayes' have it. The Motion is adopted. Mr. Parke."

Parke: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. I rise in question, the shortness of the committee process and hearing so many Bills. There'll be probably close to 2000 Bills that will probably not be having a chance to be heard in committee, because of the shortened amount of time for committee hearings. Has the Chair given any thought to extending the deadline on those? And if not, do you feel at liberty to share with the Body why we have such a short time line on hearing Bills out of committee... is... and I, what was that four weeks or five weeks, Mr. Speaker?"

Speaker Madigan: "I'm advised that the time lines here are the same as they were two years ago."

Parke: "They are?"

Speaker Madigan: "Right. Mr. Parke, our plan, again, in consultation with Mr. Daniels, is to work cooperatively with all the Members to get hearings on Bills and to get Bills called on the floor. Now, that's going to require some compromise on the part of everybody. Okay, but if we all work together in a solid spirit of compromise, I think at the end of the House Floor consideration of House Bills, why we'll have a reasonable level of satisfaction. Reasonable level of satisfaction. Mr. Daniels. I'm sorry, Mr. Parke. Mr. Parke."

Parke: "I appreciate that. And I think that's... that, I 'm pleased. The only problem I have when we have this, and I think it's still a short time line, whether it was two years ago or not. And what we then have to rely on is a

very hectic Amendment process to try and get in the Bills. And there is a new dynamics, the single subject matter, that the Supreme Court addressed. It gives us even less opportunity to put Amendments on a Bill because of germaneness issue. What worries me most, is that at the end of Session, we 're going to have hundreds of Conference Committees which will be very difficult for the Members to have any input in until it's either a 'yes' or a 'no' vote on the discussion on a Third Reading vote. And that perhaps, philosophically, we may want to look at that now or in the future. But I don't know if that's such good public policy, because it is so difficult for us to put the time in in a short period of time for Conference Committees. Just a thought. Thank you, Mr. Speaker."

Speaker Madigan: "Thank you, Mr. Parke. Mr. Mautino. Mr. Mautino."

Mautino: "Yes, Speaker. On, in reference to the shell Bills which have now been recommitted back to the Executive Committee, if I have substantive language ready next week at the committee is that Bill considered, as of right now, posted? I can walk in and maybe adopt that Amendment and it would no longer be a shell, but substantive? Can they hear that Bill in the committee? Posting requirements."

Speaker Madigan: "Is this a Bill assigned to the Executive Committee?"

Mautino: "Yeah."

Speaker Madigan: "And did you want to hear it before the Executive Committee?"

Mautino: "Well, if the language is ready, I could bring the Amendment right to committee. Would I have the ability at that time to just adopt it in committee?"

Mautino: "Okay. So it could be heard?"

Speaker Madigan: "Sure."

Mautino: "Thanks."

I would ask all Republican Members that are interested in some of these Bills that were rereferred to Exec to review those Bills that were their Bills to determine whether or not they're necessary, and to submit us a memo in my office as to those Bills that they feel are essential. One of my Members just came up, Mr. Speaker, he had 12 Bills on that list. He didn't ask for those 12 Bills to be sent out. He said 'I only need 3'. So already we are nine Bills ahead, without going through that. Now, the purpose here, and I thank you very much, Mr. Speaker, for your cooperation, is to make sure that we handle these Bills before the General Assembly so that each Member can determine the essential nature of the Bills that they have before us. So that they can be called at an orderly manner. And that's the purpose of this. I hope everybody' work in that spirit. "

Speaker Madigan: "So, Ladies and Gentlemen, if we can finish this discussion, and please let me address everybody and say that a point has been made that there are a lot of Bills to be heard in committee and on the floor. If we all go into this with the realization that not every Bill is going to be heard, not every Bill is going to be passed, and if we are reasonable and prepared to compromise, as I said at the end of the process, at the end of House Floor consideration of House BIlls, there will be a reasonable level of satisfaction by every Member, if we operate in good faith and if we are all prepared to compromise.
