If you can make the case that your district requires you to vote a certain way, that's respected, and I appreciate that. also appreciate, as Representative Turner said, that in the last four years, a lot of the partisan rancor has been turned down, thanks to shared chairmanships, bipartisan chairmanships, and calling Bills that all of us introduce. That allows all of us to focus more on important issues, and to do more work for our constituents. All the issues aren't earthshattering, but they're important to your district, to a group of people, or to perhaps just one person that needs some help from the State Government. Thomas Wentworth Higginson wrote in 1871, that 'great men
