I think all of you are familiar with hospice and what it does in allowing people to spend the last weeks or months of a terminal illness with a measure of dignity and being surrounded by family and friends. I think you're all familiar with it. This is an attempt to create a hospice license plate with all of the extra fees. There will be no cost to the state. of the renewal fee would go into a hospice fund and be administered by, if memory serves me correctly, and I may be wrong on this, is the Department of Public Health. I'll be glad to answer any questions that you have."

Speaker Madigan: "The Gentleman moves that the House pass the Bill. The Chair recognizes Mr. Hoffman."

It simply allows the vocational centers enter into their own performance contracts for construction upgrades."

The question raised by Representative Winters, and I don't purport to speak for him, was that why were these plates made at all? We already have a plate on our car that is good until January of 2003. Now, do I take the current valid plate off and put the new color scheme plate on? I don't think so. That was the only question we were raising, is why that that was necessary. duplicative and unnecessary, plus the fact that most of us got a registration with that plate that indicated we owed \$78 for that plate. And when we called over there, we(sic-they) said oh, that was a mistake. You'd already paid for it. So that was the question we raised. thought that the duplicative plate was simply unnecessary exercise, whether it costs \$10 or a thousand dollars, it didn't need to be done and it surely didn't need to be done for Legislators. That we're the last group that ought to have a extra plate made for us in this time of a budget crisis. So, I simply rise to defend Representative Winters in his request that he asked last week."

HOUSE JOINT RESOLUTION

CONSTITUTIONAL AMENDMENT #10

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 2 of Article X of the Constitution as follows:

ARTICLE X

EDUCATION

(ILCON Art. X, Sec. 2)

SECTION 2. STATE BOARD OF EDUCATION - STATE SUPERINTENDENT OF EDUCATION CHIEF-STATE-EDUCATIONAL-OFFICER

(a) There is created a State Board of Education to be elected or selected on a regional basis. The number of members, their qualifications, terms of office and manner of election or selection shall be provided by law. The Board, except as limited by law, may establish goals, determine policies, provide for planning and evaluating education programs and recommend financing. The Board shall have such other duties and powers as provided by law.

(b) A State Superintendent of Education shall be nominated at a general primary election and elected by the electors of the State at the general election every 4 years, beginning in 2004. The State Superintendent of Education shall hold office for 4 years beginning on the second Monday of January after his or her election. To be eligible to hold the office of State Superintendent of Education a person must be a United States citizen, at least 25 years old, and a resident of the State for 10 years preceding his or her election.

The names of the candidates for State Superintendent of Education shall be printed on the ballot directly below the names of the candidates for Secretary of State.

Any vacancy in the office of State Superintendent of Education shall be filled in the manner provided in Section 7 of Article X.

The State Superintendent shall be the chief educational officer of the State. The-State-Board-of-Education-shall-appoint a-chief-state-educational-officer.

HOUSE JOINT RESOLUTION

CONSTITUTIONAL AMENDMENT #11

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 8.1 to Article IV of the Illinois Constitution as follows:

ARTICLE IV

THE LEGISLATURE

(ILCON Art. IV, Sec. 8.1 new)

Section 8.1. Passage of Revenue Bills.

- (a) A bill that would result in the increase of revenue to the State may become law only with the concurrence of two-thirds of the members elected to each house of the General Assembly.
- (b) The General Assembly may not vote upon a bill that would result in the increase of revenue to the State until a public hearing on the bill has been held. Reasonable notice of the hearing, in no event less than 2 weeks, shall be given to the public.
