used for insurance premiums under the Teachers' Retirement This language was inadvertently left out of the System. original Bill and acts as a technical cleanup. addition, it changes August 1st to September 1st, excuse September 15th, the Commission's deadline for publishing a budget summary report of the most passed Senate Budget, State Budget. The Economic and Fiscal Commission is requesting that the change as a result of a budget data that is unavailable 'til after the August 1st deadline. The Commission would like to change this deadline in order to avoid any audit findings and future audits of the agency. I stand ready to answer questions."

Speaker Madigan: "The Gentleman moves for the passage of the Bill. Is there any discussion? There being no discussion, the question is, 'Shall this Bill pass?' Those in favor signify by voting 'yes'; those opposed by voting 'no'. Have all voted who wish? Have all voted who wish? Clerk, would you record Mr. Black as 'yes'. And would someone bring a key to his desk. Have all voted who wish? Have all voted who wish? Three people have not voted. Two people have not voted. Has Mr. Novak voted and has Mr. Brunsvold voted? Is Mr. Giles in the chamber? Mr. Giles. Representative O'Brien, did you wish to call House Bill 3652? Mr. Clerk, read the Bill."

Clerk Bolin: "House Bill..."

Clerk Bolin: "House Bill 3652, a Bill for an act in relation to vehicles. Third Reading of this House Bill."

Speaker Madigan: "Representative O'Brien."

O'Brien: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. House Bill 3652 would provide for an increase in the penalty for speeding in a construction work zone. It would add \$50 and that would be a fee that would be paid into a State Police Hire-back Fund. And it would allow the State Police then to... the Illinois Department of Transportation to hire back some off-duty State Police workers, so that they could sit at construction zones. Because we know that the biggest deterrent to speeding in a construction zone is seeing a police officer with his lights going and slowing down that traffic. And I would be happy to answer any questions."

Speaker Madigan: "Mr. Black."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "The Lady... yields."

Black: "Thank you. Representative, just... just for the record.

There were... many parties had concerns about this Bill in its original form. And I just want to make certain. I sit on the Transportation Committee. And I know what the

Amendment did. But just so those who are still not sure, the Amendment that you added makes this a hire-back proposal."

O'Brien: "Right."

Black: "And with that Amendment I am aware of no opposition to this Bill. Is that your understanding?"

O'Brien: "That's correct. The original Bill, although I can't understand why anybody would be opposed to my idea, but it did have a lot of opposition. This was worked through with all parties. There is no opposition. There is no mandate for having police sit at a work zone. This fund will create compensation to hire-back off-duty police officers. So the State Police are fine with it. IDOT is fine with it and certainly, the construction trades and the road workers are pleased with this Bill."

Black: "And is it your understanding that the State Police intends to use this hire-back provision, should this Bill become law, and I hope that it does. This will be a voluntary situation. It is not something where a district commander can tell an officer who just got off a shift, oh by the way you're going to work six hours on I-57 construction zone. This will be a voluntary hire-back procedure. Correct?"

O'Brien: "That's right. It's all voluntary."

Black: "All right. Thank... Thank you very much. I appreciate the work that you did on this Bill. And I think Members of the House need to know that 30 IDOT workers were killed last year in accidents. And I think more motorists than that were killed in highway construction zones. It was a tragic year. I think this Bill is a positive step in the right direction. I commend you for the Amendment that now has everybody on board and thank you for your perseverance

O'Brien: "Thank you, Representative Black."

Ladies and Gentlemen, if the Chair could have your attention. If we could have your attention for just a few moments. All of you should have gotten a copy of this bulletin which reports the number of Bills which have already been approved for consideration by the Rules Committee and what we anticipate will be approved by the Rules Committee. You can see that we have an extraordinary number of Bills filed and assigned to standing committee. And we've just worked through a consideration where if each Bill were to reach the Calendar and then require ten

minutes on the floor, we'd be able to consider about 372 Bills, rather than over the... rather than over the 1200 Bills which may be assigned to committee. I just bring to your attention because what happens in the committees for the next two weeks will determine how many Bills are on the Calendar during those two weeks for floor consideration of Bills. This is a decision that will be made by all of us in the committees. If the committees don't restrain themselves, then all these Bills'll be up on the Calendar and you'll be struggling with the decision as to what Bills are considered and which ones are not. So, I just bring this to your attention, so that all of us can act reasonably and judiciously over the next several days. The Chair is prepared to adjourn until tomorrow at 11:30. Is there anything further to come before the Body, Mr. Parke? Representative Currie moves that the House stand adjourned until tomorrow at 11:30 a.m. Those in favor say 'aye'; those opposed say 'no'.
