Speaker Hartke: "The Chair recognizes Representative Watson. For what reason do you seek recognition?"

Watson: "A point of personal privilege, Mr. Speaker."

Speaker Hartke: "State your point."

Watson: "Thank you, Mr. Speaker. I would like to welcome the Lady Carrollton Hawks High School Basketball team back-to-back state champions Class 1A. Coach Lori Blade and the team, congratulations."

Speaker Hartke: "Congratulations. Welcome to the Illinois House.

Representative Bellock, for what reason do you seek recognition?"

Bellock: "Point of personal privilege, Mr. Speaker."

Speaker Hartke: "State your point."

- Speaker Hartke: "Third Reading. Senate Bill 1550.

  Representative Watson. Mr. Clerk, read the Bill."
- Clerk Bolin: "Senate Bill 1550, a Bill for an Act in relation to vehicles. Second Reading of this Senate Bill. No Committee Amendments. No Floor Amendments. No Motions filed."
- Speaker Hartke: "Third Reading. Senate Bill 1588.

  Representative Mitchell. Out of the record. On today's

  Regular Calendar, on page #2 appears Senate Bill 151.

  Representative Holbrook. Mr. Clerk, read the Bill."
- Clerk Bolin: "Senate Bill 151, a Bill for an Act in relation to public aid. Third Reading of this Senate Bill."
- Speaker Hartke: "Representative Holbrook."
- Holbrook: "Thank you, Mr. Speaker. Senate Bill 151 simply prevents the Department of Public Aid from reinstituting the IOC's for our nursing homes. If you feel that the care of your loved ones in a nursing home needs to be taken care of rather than paperwork filled out this is the Bill you've been waiting for this Session. These IOC's were a thing of the past, haven't been used for about ten years except on request. And it takes resources from our long-term care facilities. And I'd ask for an 'aye' vote and be glad to take any questions."
- Speaker Hartke: "Is there any discussion? The Chair recognizes

  Representative Black."
- Black: "Thank you very much, Mr. Speaker. I rise in strong support of the Bill. The Amendment to the Bill incorporates some of the language I had in a separate stand-alone Bill. And while the hour grows late, I still think it's wrong for the Department of Public Aid to initiate the inspection of care model after this was on the

shelf for some nine years. They've already moved the starting point of the inspection of care model back at least six weeks, because as we suspected some time ago I think they're having trouble finding staff who know how to do this. They're finding problems with the nursing home industry in that they haven't done it for some period of time. And I fail to understand some six or eight weeks ago why we were rushing into this. I certainly fail to understand it today. And I just simply rise to support the Gentleman's Motion to vote 'aye' on this Bill."

Speaker Hartke: "Further discussion? Seeing that no one is seeking recognition, Representative Holbrook to close."

Holbrook: "I ask for an 'aye' vote."

Speaker Hartke: "The question is, 'Shall the House pass Senate Bill 151?' All those in favor will signify by voting 'yes'; those opposed vote 'no'. The voting is open. Have all voted who wish? Lang 'aye'. Have all voted who wish? Mr. Bob Ryan would you care to vote on this issue? Have all voted who wish? Mr. Clerk, take the record. On this question, there are 116 Members voting 'yes', 0 voting 'no', and 0 voting 'present'. And the House does pass Senate Bill 151. And this Bill, having received the Constitutional Majority, is hereby declared passed. The Chair recognizes Representative Brady. For what reason do you seek recognition?"

Brady: "A point of personal privilege, Mr. Speaker."

Speaker Hartke: "State your point, Mr. Brady."

Brady: "I'd like to have my colleagues in the House recognize and welcome, in conjunction with Representative Keith Sommer, members from the Woodford County Republican group that is down touring the Capitol today. So, a nice Springfield welcome to you."
