- Speaker Madigan: "We shall be led in the Pledge of Allegiance by Representative Terry Parke."
- Parke et al: "I pledge allegiance to the flag of the United States of America, and to the Republic for which it stands, one nation under God, indivisible, with liberty and justice for all."
- Speaker Madigan: "Roll Call for Attendance. Representative Currie."
- Currie: "Thank you, Speaker. Please let the record show that we have no excused absences to report today."
- Speaker Madigan: "Mr. Bost."
- Bost: "Thank you, Mr. Speaker. Let the record reflect that all Republicans are present today."
- Speaker Madigan: "The Clerk shall take the record. There being

- 117 Members responding to the Attendance Roll Call there is a quorum present. Mr. Clerk."
- Clerk Bolin: "Introduction of Resolutions. House Resolution 965, offered by Representative Brosnahan; House Resolution 966, offered by Representative Hoffman. These Resolutions are referred to the House Rules Committee."
- Speaker Madigan: "Ladies and Gentlemen, we've prepared to begin the Committee of the Whole, but before we take the Motion that will put us into the Committee of the Whole, I would like to explain the procedures that we will follow today. I believe that all of you have been given one of these pink pieces of paper that would set out the schedule for consideration. Once we begin, with say Elementary & Secondary Education, the plan will be that people will get five minutes to put questions to the witnesses. We will go back and forth, first a Democrat, then a Republican, then a Democrat, then a Republican until we have hit 10:15. At 10:15, we'll begin Higher Education. At 11 a.m., we'll begin Corrections, on down the agenda. Every agency will be advised to be available at 7 p.m. in the event that there are Members that have further questions that they want to put to any of these agencies. So, again, we'll follow the plan on the pink piece of paper. Each person will get five minutes, first a Democrat and then a Republican. We'll go back and forth until we hit the scheduled time to end that particular section, at which time we shift over to the next topic. With that in mind, the Chair recognizes Representative Currie."
- Currie: "Thank you, Speaker. I move that the House of Representatives now resolve itself into a Committee of the Whole for the purpose of a subject matter hearing on the Fiscal Year 2003 budget in accordance with the schedule set

One of the things that could alleviate this determination of why the tenth riverboat license is languishing in the Illinois Gaming Board and why we don't have a resolution to that matter. As we all know from the numbers, it looks like we could raise half a billion dollars a year if we could issue the tenth license, but of course, we don't have an answer. I think it would be appropriate for the House Revenue Committee to have a subject matter hearing asking the Illinois Gaming Board to come in there and tell them what's going on with that situation and to determine if there could be some resolution to that. I think it would also be appropriate that the Attorney General be asked to come to that hearing because he has immersed himself into this situation. Accordingly, Mr. Speaker, I ask that the posting notice be waived so that the Revenue Committee can meet tomorrow morning and that these folks can be invited to speak to them on subject matter as to the tenth riverboat license."

Chairperson Hannig: "And on this question Representative Black is recognized."

Black: "Thank you very much, Mr. Speaker. In all due respect to the Gentleman's Motion, we have other pressing business and our side of the aisle objects to the waiving of the posting requirement for the Revenue Committee to meet tomorrow morning for a subject matter hearing on a tenth riverboat license. We stand in objection to the Gentleman's Motion."
