I don't know how he knew that the economy was going to go bad two days after he decided to resign, but I was wondering if we could have leave of the House and see if you could bring him back to help with the budget negotiations on the House Republican side. But I doubt if that is going to happen and in the meantime we'd certainly do wish Tom well. I want to really say thanks to Tom and Peg 'cause they were really instrumental in my getting involved in the political process back in... when, you know, Tom came and talked to me and visited with me about the joys of politics and Peg was very, very honest about the impact it has on the family life. I think as others have pointed out earlier, you know, we really owe a thanks to both of them for the contribution they've made and certainly to their two sons, because they've been brought up in this political process and in spite of it have absolutely shown their greatness and I think it's a tribute to Tom and Peg and I just want to say thanks to them and thanks to... look forward to working with them in the future."

Speaker Madigan: "Representative Myers."

Myers: "Thank you, Mr. Speaker. I certainly rise in support of the Resolution. My colleague to the south has been very, very helpful in my short seven years here in the General

Assembly and certainly, my wife and I have developed a very good friendship with Mr. and Mrs. Ryder. - Speaker Madigan: "Mr. Black, have you been advised on this Bill? All right, so the Chair recognizes Mr. Burke for the purpose of moving to suspend the posting requirements so that the Executive Committee can meet immediately after Session to consider Senate Bill 1269. Those in favor of that Motion say 'yes'; those opposed say 'no'. The 'ayes' have it. The Motion is adopted and the posting requirements are suspended to permit the hearing of Senate Bill 1269 in the Executive Committee immediately after Session. On the Supplemental Calendar on the Order of Concurrence there appears House Bill 1973, Mr. Bost."
- Bost: "Thank you, Mr. Speaker. On House Bill 1973, make a Motion to concur with Senate Amendment #1. Basically, Senate Amendment #1 simply removes the back-door referendum portion of the Bill and just makes it all front door referendum."
- Speaker Madigan: "The Gentleman moves that the House concur in the Senate Amendments to House Bill 1973. All right, so there's one Amendment and the Gentleman moves that the House concur in Senate Amendment #1. On that question, the Chair recognizes Mr. Black."
- Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"
- Speaker Madigan: "Sponsor yields."
- Black: "Representative, the Senate Amendment changes...it appears to change the levy and tax rate. Am I looking at the correct Senate Amendment?"
- Bost: "No, it should not change the tax rate. What it should do is... it should simply stop the ability of the tax rate to be moved through a backdoor referendum. All of the tax rate increases will now require a front door referendum."

Black: "Do you have a copy of the Amendment with you? I can give you the LRU or LRB number. It's a... it simply says by replacing line 24 and 25 with the following, 'Section B, the township board may levy the taxes at a rate in excess of 0.125%, but not in excess of;', and on page 4 by replacing lines 4 and 5 with the following, 'from the rate 0.125% to 0.4% of the value of all taxable property within the...', goes on and on. That would appear to be changing the rate."

Bost: "It was my understanding, and I may have to... we may have to pull this out of the record to confer with that and confirm that, but it's my understanding the way this language was put together by the Senate staff that it would simply take away the fact that it would require a backdoor referendum, and so that they would have to lower that rate down, because originally the higher rate would have been required a front door referendum, now they all require a front door referendum."

Black: "If you'd be kind enough to take it out of the record, if
the Speaker would promise to get back to it. I think we
need to have staff look and see if this, in fact, is the
Senate Amendment to this Bill, because it... if I'm reading
it correctly, it's a change in rate."

Bost: "Yeah, I'd be glad to take it out of the record."

Speaker Madigan: "Mr. Clerk, take this Bill out of the record.

Page 2 of the Calendar on the Order of Total Veto Motions,
there appears Senate Bill 74, Mr. Holbrook."

Holbrook: "Thank you, Speaker. Senate Bill 74 is a fairly simple Bill. It allows not-for-profit groups that have had automobiles donated to them to be transferred to people on welfare-to-work programs. Revenue is against the Bill because of the loss of the few dollars, but I don't know of

It was done at the request of the head of the Senate Judiciary, as well as the Senate's Chief Sponsor, Senator Cullerton. I'd be happy to answer any questions. Thank you."
