Hartke: "Representative Bost, in... on line 19 on page 2 of your legislation, it talks about an exemption for 'except those

- Bost: "That is... that is the reason for that... that line in that Bill, yes."

Hartke: "Could a widow of an individual who had received a Purple Heart, the veteran passes away, could she still continue to keep this Purple Heart plate?"

Bost: "It is my understanding that they can still hold that plate because they have qualified for that plate, so..."

Bost: "She... it would... she would not, if she did not meet the requirements."

Hartke: "Okay. Thank you."

Speaker Madigan: "Mr. Black."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Black: "Representative, the only... the only language that concerns me in the Bill is that it appears that you're being retroactive. That existing plates that, for example, one that I sponsored some years ago, Korean War Veterans. As they continue to age and die off they may very well, in fact, may already, I don't know, fall below the 15 hundred issuance threshold. Would that mean that a category of plate... license plate that we authorized under law, prior to the Act you're amending, could literally disappear if they didn't get 15 hundred renewals every year?"

Bost: "First off, the example that you used, as far as the Korean War plate, that meets the requirement of specific eligibility, so that would not be included in this."

Black: "Okay."

Bost: "However, if the plate, for instance, one of the examples brought forth by the newspaper report that first came and brought this piece of legislation into existence is the fact that the Illinois River plate, there's only been less than a hundred of them purchased and every time they renew those they print a hundred more of them at the cost of the taxpayers and no benefit to the original plan. So, yes, they would fall under this and that would be retroactive and after a three-year period they would finally quit printing those unless that group came forward or someone sponsored that group to bond those plates."

Black: "So, that... that would include university alumni plates that we authorized sometime ago, the domestic violence plate. What... what... is there any language in the Bill that provides for constructive notice of these entities that wanted these plates to begin with so that they can contact members of an affiliate group or ya know, to try and save their plate or are they just gonna get a notice in the mail someday that, I'm sorry, but your plate no longer meets minimum issuance standards so you'll have to send your plate back?"

Bost: "There is nothing in the Bill that gives... gives notice.

That would... the only thing that I know that we could is, is

we could request the secretary to do that and... and could

very well do that, I think."

Black: "Okay. Fine. Thank you."

Speaker Madigan: "Representative Currie."
