- WHEREAS, Mr. Lockhart was designated by the Chicago Sun Times as being one of the "Ten Best Lobbyists in Illinois", was elected Speaker of the Illinois Third House in 1980, and was credentialed to cover every Democratic and Republican National Convention between 1964 and 1984; and
- WHEREAS, Mr. Lockhart has authored and published several works including "The Illinois Political Reporter", the article on Illinois for "The Encyclopedia Britannica" in 1974, "The Legislative Process and the Pursuit of Virtue", and "Words Wise and Otherwise", among others; and
- WHEREAS, Mr. Lockhart has shown benevolence and humanity through his donations to the U.S. Holocaust Memorial Museum, The Illinois State Library, and the Allen County Public Library in Ft. Wayne, Indiana; and

WHEREAS, Representative Wirsing was in his sixth term representing the 70th Legislative District; he was active in working on behalf of Northern Illinois University and the people of DeKalb and Sycamore; he was the minority spokesman for the Higher Education Committee and a member of the House Elementary and Secondary Appropriations Committee; he also served on the House Executive and Labor Committees; and

WHEREAS, When entering the House Floor from the Republican side, Representative Wirsing was the first face in view, and he always had a smile; staff and other members frequently stopped by his desk on the Floor to visit and partake of his ever-present basket of orange slices; he was known as everybody's "grandpa", yet he had a youthful exuberance and a wry sense of humor; he distinguished

Well, after the first year, we're home for the summer, I get a call from the Farm Bureau and they brought an award for me and said I won the Friend of Ag award. Well, I had no idea why I won it. They said, well, you had a hundred percent voting record. Well, I had a hundred percent voting record 'cause I voted the same way your dad

He loved this institution with a great deal of... a great deal of love and he liked working with both sides of the aisle. When I talked to Speaker Madigan the night that David passed away, Speaker Madigan said, 'You know, Dave Wirsing always used to come up and talk to me.', and he said, 'I always enjoyed that. He would step up on the podium and talk to me.', and he said, 'I always enjoyed that that he was... he was someone that was willing to cross the aisle and come over to the Democrat side.' The other thing about David is that he recognized this opportunity to learn that we all should take advantage of. Here's a guy that came down to the Illinois General Assembly that was known as the pork producer and the hog farmer. And he... and he continued to have an interest in that community and he represented it very well, but he evolved himself and grew himself over these 12 years in the Illinois General Assembly where he really became one of the gurus on higher education and he was really someone that all of us looked to. And he's someone that we looked to last year, in particular, on higher education issues when the Governor's budget

challenged the universities, challenged them on a fiscal manner of what they could do and David brought people together. And he brought people together from both sides of the aisle, he worked with the Governor's Office, he worked with the university presidents. And it says a lot about the kind of man he was that he could go from just one aspect of his life of being a pork producer to taking care of higher education needs in this state and I think that says about... just so much about David that he was willing to grow and to learn. I had an opportunity to be with David the week that he passed away. And I got to spend almost a day with him up in his district and I remember saying, 'ah, I'm gonna up and spend a... spend a day driving around DeKalb County and Sycamore and I don't know if I really want to do that.' Well, clearly, I'm glad I did it, but what was nice about it was the people in his district understood the love and the caring he had for your community Representative because we had an opportunity to spend some time in a group setting with people from domestic violence shelters, from the business community, from the school community, from the higher ed community, and every one of them unsolicited started talking about how much Dave Wirsing had done for their particular cause and how committed he was and how much they appreciated it. And as you know... as you knew about Dave Wirsing he wasn't a guy that was a 'rah, rah, quy', he was a quy that simply did the right thing and did what he thought was best for the state and what was best for this community... his community

and what was best for his family. That says so much about the kind of guy and the individual and the human being that Dave Wirsing was. To all of you here from his family and to Nancy, who I know is not here today, we're gonna miss your dad and Nancy's husband and friend. He was a good guy and I... we all spent a lot of time with him and we spent ways with him and spent time with him in different ways and he has left his mark on this institution and we, as someone said earlier, will be forever grateful. And I assume, Mr. Speaker, that everyone will join us today as cosponsors on this piece of legislation and support it as it passes and thank you for your time."

The Executive Branch shall include a Governor, Lieutenant Governor, Attorney General, Secretary of State, and Treasurer elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office.

SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, Lieutenant Governor, Attorney General, Secretary of State, or Treasurer, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his or her election.

SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, or Treasurer fails to qualify or if the office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. If the Lieutenant Governor fails to qualify or if the office becomes vacant, it shall remain vacant until the end of the term.

- (b) If the Governor is unable to serve because of death, conviction on impeachment, failure to qualify, resignation or other disability, the office of Governor shall be filled by the officer next in line of succession for the remainder of the term or until the disability is removed.
