Davis, S.: "Yes, Speaker... Mr. Speaker, thank you. I rise on a point of personal privilege."

Davis, S.: "I would like to announce to my colleagues that we have a birthday today for one of the tallest Members in the General Assembly, very... Ricca stand up. Ricca Slone's birthday today, Ladies and Gentlemen. There's cake down front. Please... please join me in congratulating Ricca."

Speaker Madigan: "Ladies and Gentlemen, if everyone could take their seats and if staff could retire to the rear of the chamber. We're very pleased to have with us today the representative of the government of Taiwan to the midwest region of the United States. Thomas Cheng is the Director General of the Taipei Economic and Cultural Office in Chicago. He's joined us today to offer remarks concerning the relationship between his country and the State of Illinois. So, let me give you Mr. Thomas Cheng."

Thomas Cheng: "Thank you. Thank you, Mr. Speaker. Distinguished... Representatives, I'm honored and privileged to speak to you in this august hall of the Illinois House of Representatives. I bring you the goodwill and the greetings of our people from the Republic of China on Taiwan. In the past few weeks we have witnessed the U.S. democracy in action. The caucuses and primaries for the election of Democratic Party presidential candidates. I

was impressed by the eloquent debates among the aspiring presidential candidates and the fervent participation of the party members. And I was particularly moved by the gracious concession speeches made by the losing candidates. Yes, I was also awed by the power of the media which can make or break a candidate. We in Taiwan are also in the midst of our third direct popular presidential election to be held on March 20th. Our election might go unnoticed but because of a first-ever referendum in Taiwan would be held the same day. It has drawn world attention to our part of the world. China's leaders in Beijing alleged that Taiwan is creeping toward independence by holding the referendum and they say that this is crossing the so-called red line that the Chinese Red Army will not tolerate. The communist leaders further demand that all countries, particularly the United States, Japan, France and Germany, must pressure Taiwan to call off the referendum. But only crime our people are committing is to be bold enough to exercise our right in a democracy. In fact, the... referendum questions being put before our people are: one, in the face of China's missile deployment do you agree that the government should acquire more advanced antimissile weapons? And two, you agree that the government should engage negotiations with Beijing? As you can see, these questions have nothing to do with the independence issue. We just want to make sure the status quo is maintained. Chinese hostility toward Taiwan appears even more absurd when you find out that significant Taiwanese contribution

to mainland China's economic development in recent years. Taiwan's trade with China was 41 billion U.S. dollars in 2002 which accounts for 70 percent of Taiwan's total trade last year and China has become Taiwan's third largest trading partner and second largest export market. addition to trade Taiwan's investment in China has been growing steadily and has shifted from labor intensive to high-tech information industries. In 2002 investment project amounted to 3.9 billion U.S. dollars. For the last decade the estimated value of Taiwan's investment in China amounted to 50 billion U.S. dollars. Some reports suggest that that figure... figure could be well over 100 billion U.S. dollars. Representing more than 50 thousand investment projects covering all provinces in mainland China. We wonder why the Chinese would prefer to the goose that lays golden eggs. Ladies Gentlemen, Taiwan's largest trading partner is the United States. Our bilateral trade stood at 51 billion U.S. dollars in 2002. From the U.S. sites Taiwan was America's eighth largest trading partner; its ninth largest export market and the sixth largest market for U.S. agricultural products. Between 1978 and 1993, Taiwan sent 18 agricultural procurement missions to the United States resulting in the purchase of U.S. agricultural products worth 12 billion U.S. dollars. In recent years, Taiwan has sent, has bought as much as 98 percent of its corn and 80 percent of its soybeans from the United States, much of it from this prairie state. Taiwan's agricultural mission

have visit Springfield every other year since 1998. time signing a two-year purchase agreement for Illinois feed grain, corn and soybeans. Taiwan is known to be America's most loyal consumer, having a land area ¼ the size of Illinois and a population of 23 million. was second only to Canada in per capita consumption of U.S. agricultural products in 2002. Also, you might be interested to know that there are 350 McDonalds, 100... 119 Starbucks, and 123 KFC franchises dotting Taiwan's landscape. Yes, I have to report that Illinois' overall exports to Taiwan have dropped off since speaking in 2000, declining 28 percent in value in 2002. I believe there's room for improvement and that my office in Chicago with the assistance of leaders in State Government, business... to this Body can help propel the two-way trade upward again Ladies and Gentlemen, last spring Taiwan was hit soon. hard by the SARS epidemic, following SARS outbreaks in China, Hong Kong, Singapore and other parts of the world. It was U.S. Centers for Disease Control and Prevention that first came to assist us. The World Health Organization failed to send their experts to help us to fight the fatal disease due to obstruction of the government in Beijing. It is self-evident that disease knows no borders and that people and economy suffer if only one country such as Taiwan is excluded from the world health network. We hope that WHO seriously considers including Taiwan in the World Health system so that the global disease prevention network becomes more comprehensive. It is heartening that the

House of Representatives in the land of Lincoln joined U.S. Government in passing resolutions in support of granting Taiwan, observer status in the WHO in the last two years. On behalf of my government and people, I thank you for your generous support. I also thank the people of Illinois who made contributions to purchase medical masks and supplies for our hospitals in the time of need. Distinguished Representatives, if you wish to see a vibrant democracy in Taiwan continue to thrive, if you wish to see stability in the Taiwan Strait and if you wish to see health and prosperity prevail in the Asia Pacific region I urge you to give your continuing support to Taiwan. I thank you for your time and attention. I cherish opportunity today - on behalf of my government I would like to extend a standing invitation to you to visit my country and see for yourself the country and people committed to the same values of freedom and democracy and a country and people who strive to be your best friend and ally. Thank you very much. Thank you."
