We don't need to pay to be here but we need to stay... to pay to stay overnight so a per notte would be appropriate. I wonder if that's an appropriation... an appropriate, a per noche for those who want to sing can call it that. Do you happen to have any knowledge of that to help Mr. Molaro out?"
