Speaker Madigan: "State your point."

Sacia: "Mr. Speaker, my distinguished colleague from the other side of the aisle, introduced the folks from Carroll County, Thomson, Illinois, area and inadvertently failed to mention why they're here today. These folks are from Thomson, Illinois, where the second largest capital investment for a building in this state was spent several years ago in the building of Thomson Correctional Facility. It started under Governor Edgar, it was completed under Governor Ryan and now Governor Blagojevich has it and it sits vacant. Many of these folks expended their life building facilities to savings in deal with infrastructure that would come with Thomson Prison and unfortunately, it has never opened as all of you are aware. I'm sure all of you are aware, as well, of the conditions of Illinois prisons in Illinois. This morning we met with representatives of the Bureau of Prisons and I said I understand that you are about a 140 percent of capacity. Sergio corrected me and he said, 'Representative, you've got it wrong, we're 177 percent of capacity.' And this facility sits vacant, 750 jobs desperately needed in Thomson, Illinois, a correctional facility desperately needed by the Department of Corrections. Please help me in convincing our Governor to open this... this prison and please help these folks really feel welcome for the good work they're doing, trying to bring something back to their district."

- Speaker Madigan: "Mr. Daniels. Mr. Daniels on HR 1237. The Gentleman indicates he does not wish to call the Resolution. Mr. Stephens. Mr. Stephens. Mr. Verschoore. Mr. Verschoore, did you wish to call HJR 97? House Joint Resolution 97 is concerned with Route 92. Mr. Verschoore, please present the Resolution."
- Verschoore: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House of Representatives. What this Bill or this Resolution does is rename a portion of the expressway in my district, and it'll be known as the Rock Island Parkway and I ask adoption of this Resolution. I'd be happy to ask... answer any questions."
- Speaker Madigan: "The Gentleman moves for the adoption of House Joint Resolution 97. There being no discussion, the question is, 'Shall the House adopt House Joint Resolution 97?' Those in favor say 'aye'; those opposed say 'no'. The 'ayes' have it. And the Resolution is adopted. Mr. Joe Lyons on HJR 100. Representative Eileen Lyons."
- Lyons, E.: "Thank you, Mr. Speaker. HJR 100 is a very important Resolution, in as much as it is going to encourage the Department of Energy, along with our congressional delegation, to award the contract for a rare isotope accelerator to our jewel in this state and that is Argonne National Labs. The U.S. Department of Energy will be deciding shortly where to locate this exciting new technology. With the accelerator will come a 6 to 10 year construction contract, worth about \$1 billion and between 100 and 200 million for operation annually. Construction

of this facility is expected to generate about 10 thousand construction jobs. Hundreds of permanent staff positions will be created and the Chicagoland area will be the destinations of thousands of scientists who will come to the accelerator to study. Also this project will generate billions of dollars in economic impact over the years the facility is in operation. The rare isotope accelerator will also give Illinois students a one-of-a-kind opportunity to study physics right in their own back yard. And I would encourage your strong support of this... and a bipartisan support of this Resolution."

Speaker Madigan: "The Lady moves for the adoption of the Resolution. There being no discussion, the question is, 'Shall the House adopt House Joint Resolution 100?' Those in favor signify by saying 'yes'; those opposed by saying 'no'. The 'ayes' have it. The House does adopt House Joint Resolution 100. Mr. Lang. Mr. Lang. Mr. Lang, on the qualification challenge. Mr. Lang on House Resolution 1251."

Those in favor signify by voting 'yes'; those opposed by voting 'no'. The Clerk shall take the record. On this question, there are 116 people voting 'yes', 0 voting 'no'. The House does adopt House Resolution 1251. Mr. Joe Lyons. Are you seeking recognition, Mr. Lyons?"

Lyons, J.: "Yes, Speaker, I do. Stephens: "Thank you, Mr. Speaker. House Resolution... House Joint Resolution 95 is a Resolution in honor of one of our former Members, United States Senator and presidential candidate, Paul Simon. You might know that Paul comes... came from my district, was a newspaper editor in Troy, Illinois, came to the Legislature, met his wife Jeanne, they were married, he went on to become Lieutenant Governor and then United States Senator and served this state and certainly our area in Southwestern Illinois very well. And what this Resolution asks is that a portion of Route 162, which passes through his old hometown, be renamed in honor and as a memorial to Senator Paul Simon. I would appreciate your consideration, Mr. Speaker."

Speaker Madigan: "The Gentleman moves for the adoption of HJR 95. Is there any discussion? There being no discussion, the question is, 'Shall the House adopt House Joint Resolution 95?' Those in favor say 'aye'; those opposed say 'no'. The 'ayes' have it. The House does adopt House Joint Resolution 95. Representative Currie."

Currie: "Thank you, Speaker. I move to suspend the posting requirements so that Senate Bill 218 may be heard in

Executive Committee this afternoon and Senate Bill 81 in Judiciary I."

Speaker Madigan: "You've all heard the Lady's Motion. Is there leave? Leave is granted and the posting requirements are suspended for those two Bills. Mr. Flider."

Flider: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, on Saturday will be a very important day in central Illinois. On Saturday, it'll be another opportunity for the Arthur Lovington Knights High School team to continue their unbeaten streak in football and they'll be playing a team that is from northwestern Illinois in the district of Representative Jim Sacia. And of course, Jim Sacia will be supporting his team from Stockton, Illinois. But in lieu of this important day in central Illinois, when the Arthur Lovington Knights will be continuing their unbeaten streak, I wanted to offer a friendly wager to Representative Sacia, that if indeed, it doesn't turn out the way I believe, I would certainly be... want to offer up something in honor of a victory in Stockton, Illinois, which I don't think will happen, but in the event that it does, I would like to place a friendly wager of some Amish-made Baby Swiss cheese. A wheel of Amish-made Baby Swiss cheese to Representative Sacia for a victory that probably will not occur but just in case it does, wanna offer that up to you."

Sacia: "Thank you, Mr. Speaker. I certainly accept the challenge. The only thing is, is Representative Flider is

going to have to get used to losing. Fortunately, in Stockton, Illinois, we have the Stockton cheese plant, which is the largest manufacturer of Swiss cheese in the nation. And I have in my possession 5 pounds of Stockton Swiss cheese, again, the finest in the nation and I certainly except the challenge. But the Arthur Lovington Knights are going to have to experience their first loss and I'm sad to say that, but reality will set in on Saturday."

Speaker Madigan: "On page 3 of the Calendar, on the Order of
Total Veto Motions, there appears Senate Bill 2196.
Representative Nekritz."

Nekritz: "Thank you, Mr. Speaker. I vote to... I move to override the Veto on Senate Bill 2196. This is the legislation that establishes the Metropolitan Water Reclamation District of Greater Chicago as the stormwater management agency for Cook County. And after this Bill passed both the House and the Senate last May we were reminded in very vivid fashion as to how critical this is for Cook County and the entire northeast Illinois region. After days of rain in Wisconsin, the Des Plaines River overflowed it's banks all the way from the Wisconsin border all the... down through Cook County. Roads were closed, businesses were affected, homeowners spent days sandbagging and then after the stormwaters receded, unsandbagging, costing residents and local governments hundreds of thousands of dollars. And this was only the most recent example of flooding in the county. Every year Cook County

residents spend \$211 million on flooding and spend \$10 million on flood insurance. And currently, we have no one who addresses storm... stormwater in a comprehensive fashion, it is very piecemeal. Each community does it's own thing and we're limited to... by what those local governments can do. Stormwater doesn't affect these municipal boundaries and it is generally acknowledged that the most important thing we can do is establish a regional approach to addressing this issue. Under this legislation, the Metropolitan Water Reclamation District will create a countywide stormwater management plan and that plan will then be implemented. In order to do that, the district has agreed to reduce their current taxing authority sanitary sewer and devote a nickel of that taxing authority to stormwater management. At a maximum, if... if they went up to the maximum, which we don't anticipate will happen for a while, it would be \$17.50 per \$100 thousand of assessed valuation. This is a new service for Cook County and it is a smart investment against that \$211 million we spend every year to address stormwater management. All of the regional municipal conferences support the legislation and... as well as the... a number of the other storm... regional stormwater management authorities. If we do nothing, the stormwater problem will only increase. So, this is very critical piece of legislation for addressing this issue and reduce... actually reducing the amount that we have to spend on this... on stormwater management every year. I ask for your support."

Speaker Madigan: "Mr. Saviano."

Saviano: "Thank you, Mr. Speaker, Members of the House. This override is very important, especially for us Members who represent districts along the Des Plaines River. districts have a lot of property that are included in flood plain areas which have become worthless because of a lack of a plan to address flooding in our areas. We literally have property we cannot build on, we cannot sell. Bill has passed at least pre... twice previously in this chamber. It's very important to us Legislators in Cook County that we would allow the Water Reclamation District implement the stormwater management plan so that we could make properties in our area worth something. And as the Sponsor alluded to it would save our constituents millions of dollars in flood insurance which is... which is required on their mortgages day in and day out, every day of the year. Like I said, we've passed this at least two times, previously. It's very important to us because Cook County's the last county in... in this state that failed, that has not passed the stormwater management plan. So, I would urge my colleagues to really take a close look at this and help us, help us to give relief to our constituencies who are plagued with these flood situations. And I would ask respectively that we override the Veto on Senate Bill 2196. Thank you."

Speaker Madigan: "Representative Krause."

Krause: "Thank you, Mr. Speaker. To the Motion. I also join is asking for support to override this Veto. As has been

mentioned, there is a strong need in... in Cook County to have sound planning so that we can come up with the plans necessary to address the flood control issues that clearly are needed. Again, this year we experience a large amount of damages to a number of the municipalities to many homeowners that cost millions of dollars. This legislation and we have addressed this issue in the past, it has passed But this spring we addressed it, we had the House. meetings in Des Plaines, the Sponsor, Representative Mulligan, myself and others worked with the Reclamation District. They were very amenable to proposals that would be made in this legislation. They also agreed to a cost benefit analysis as to which projects are truly needed to support the need for this legislation. The time has come to pass this legislation. It is sound, it is needed and it will finally address the issue that is needed in Cook County. I also urge for a 'yes' vote to override the Veto."

Speaker Madigan: "Representative Mulligan. Are you seeking recognition on this Bill? There are certain people who wanted to know your views on this Bill. Mulligan."

Mulligan: "Mr. Speaker, you're, ya know, every good thing you desire or, ya know, is my command. Your command is my wish, whatever. Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "Sponsor yields."

Mulligan: "No one is recognizing me."

Speaker Madigan: "The Sponsor yields."

Nekritz: "I... I certainly will."

Mulligan: "Thank you. Representative Nekritz, I think you've done an excellent job on this Bill. In the communities that we represent, you know this has been an ongoing issue for a long time, don't you?"

Nekritz: "Absolutely."

Mulligan: "Okay. I'll probably just speak to the Bill. communities in our area probably spent 10 years trying to agree upon who should be the authority and who should have the oversight in this area. And along the Des Plaines River and communities that any number of us in this Body represent in the whole area, the flooding situation has been insurmountable. From the time you have the great floods, which we would consider '86 and '87, the great floods in our area, it is supposed to take some congressional oversight in all agencies 15 to 17 years to come together. That has not happened. We're past that time. This may be a little bit of difficult Bill, but the Governor should never vetoed it. It was something that was needed for our area. He arrived on the scene saying he was going to help us and then the Bill that has taken the communities 10 years to come together and that was given to Representative Nekritz and Senator Garret to carry, which they did a very good job on and in which they passed originally, should have been passed because it was most important for the whole area to come together under one flood authority. Other counties, such as Lake, have this kind of agreement. They do this. It's worked very well.

We would certainly ask the support of people that live up and downstream from us because what we do is important to what you do. Our ability to manage flood water helps you manage your flood water. If we can't manage ours, it's gonna make an impact on you. This is a very important Bill. I think it was very short-sighted that... that it was vetoed. We would certainly encourage your support of this because it impacts everybody that lives in this area, no matter what county you live in if you're along that river. So, it's most important for this override to go through. So, we certainly ask for your support because we think it important Bill and the oversight a verv Representative Nekritz has explained in the past is there. But it is important for our communities. It will save millions and millions and millions of dollars that we spend every year, particularly for poor people who cannot recover when their properties are flooded. So, I would certainly urge an 'aye' vote and I commend the Representative for all the work she's done. And if you can really dig down and give us this vote we would appreciate it."

Speaker Madigan: "Mr. Black."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "The Sponsor yields."

Black: "Representative, do you have an estimated cost of what this will be over the years to alleviate the flooding that occurs in your area?"

Nekritz: "If the entire nickel were to be levied, which would not be the case initially, it would be about \$50 million collected and that would, again, offset the \$211 million investment that we... that we're... that we're currently making in flooding in Cook County each year."

Black: "How will that be financed?"

Nekritz: "It... it would be through a property tax."

Black: "A property tax without referenda?"

Nekritz: "Correct."

Black: "Well, what rate are you establishing in statute? Are you establishing a five-cent rate by this Bill?"

Nekritz: "This... this takes a nickel, a five-cent rate out of the Metropolitan Water Reclamations District... District's current taxing authority for disposal in treatment of waste water and moves it to stormwater?"

Black: "So, one could perhaps make the argument that while you transfer a nickel rate you're taking a nickel off the other rate. So, would it be a fair assumption to say actually it's a wash? There's no net property tax increase for that first year."

Nekritz: "Well, I think that would be a little overstating...

overstating the case a little bit because currently
they're... they're not... not able to access that nickel under
the tax cap."

Black: "All right. If... if the nickel does not prove to be a sufficient generating source, what provisions do you have for raising it? Will it be raised by the board? Will it

be raised by vote? How... how will that... how will that occur?"

Nekritz: "Since that nickel is set... would be set in state statute. In order to raise that, the Metropolitan Water Reclamation District would have to come back for... to us for additional authority."

Black: "All right. So, the General Assembly then would assume some oversight responsibility for the financing of this flood control project, right?"

Nekritz: "Correct."

Black: "You know, I always get nervous when I... I've been to the Millennium Park in Chicago and it's very beautiful. But as I recall it cost considerably more money than they estimated and took about 3 years longer than they estimated. That's... that's a major concern that I have with this project. It's estimated at 51 million. What assurance do the taxpayers have that it won't turn into a \$2 billion flood control project?"

Nekritz: "The... the initial plan under this legislation is to be developed by local authorities, local elected officials along with the Metropolitan Water Reclamation District and there are stated provisions in the legislation for public input. So, there are opportunities for the public to... to speak directly to the Metropolitan Water Reclamation District on the... on the size of the... and scope of the plan. And the... this is not just one project, Representative. This is an on... this is an ongoing... this is

an ongoing venture to address these issues 'cause we're not gonna to address it in the first year."

- Black: "Oh, no and I understand that. Do you... do you have an approximate time line?"
- Nekritz: "There's no time limit. I mean, once... once we... once we give them this authority, in many ways it's like the sanitary sewer that... sewage that they address now. It's an ongoing problem and... and an ongoing... and there will be ongoing solutions. This is... this is a very... this is identical to what Lake County, DuPage County, and Kane County already have in terms of stormwater management, where there's no time limit and there's no dollar limit."
- Black: "So, I... I guess the only oversight would be if you... if the project mushrooms and continues for years then the... the oversight would be with the General Assembly in not authorizing an increase in the base tax rate? Would that... would that be fair?"
- Nekritz: "That... that would be part of it. But in addition, the... the members and the president of the Metropolitan Water Reclamation District are elected officials and I assume if they get to out of hand..."

Black: "Okay."

- Nekritz: "...the electorate can speak to them and tell them that their actions are inappropriate."

- Black: "Is there a fair geographic representation of the current board or are they concentrated in the metro area of the city itself?"
- Nekritz: "No. There are... there are suburban and... and city representatives from that... on that."
- Black: "All right. And that... that means that I've been following the debate. Are all of the outlying suburban communities onboard with this?"
- Nekritz: "I don't... I don't think they all are. But all of the municipal conferences: the Northwest Municipal Conference, the Southwest Conference of Mayors and Managers, the Southside Mayors and Managers and I believe the West Suburban are. All of those COGS, the Councils of Government, have signed on."
- Black: "All right. I just have one... one last question. Growing up in a farm area, I know that whenever somebody does a great job of drainage on their 600 acres somebody else gets the water. Now, when all of this is done, in particularly what caught my eye or caught my ear, what were dikes and perhaps dikes along the river that would channel that water and that increases the speed of the water. Where does the water end up? Does it go into Will County or... or where does this empty eventually?"
- Nekritz: "In... in addition to having this regional approach, the Department of Natural Resources and the Federal Army Corps of Engineers still have jurisdiction over any project that... that we would undertake and it is the job of those agencies to make sure that any project that we would undertake would

not affect a downstream community. And so that oversight is still there. And that's... that's specifically contemplated in the legislation."

Speaker Madigan: "Mr. Black..."

Black: "All right."

Speaker Madigan: "...could you bring your remarks to a close?"

Black: "Was that a request or..."

Speaker Madigan: "Yeah, it's a request."

Black: "Strongly... or a strong request."

Speaker Madigan: "Simple request."

Black: "Well, thank you, I will. Thank you very much, Mr. Speaker. To the Bill. Ladies and Gentlemen of the House, I think it's disingenuous as someone said earlier for the Governor to veto this Bill. Yes, there is a tax involved. Would there any... is anybody in this chamber so naive to think you can do this kind of a project and not have a funding source? Do you think the money is just going to automatically appear? Flooding occurs in almost every region of the state. And those of us who have problems downstate will reach out to you to help us. occasion those of us who live downstate have to reach out to help you. I think when all is said and done this project has been negotiated with the vast majority of people who live in this area that suffers from these floods. I intend to vote 'aye'. Yes, somebody's gonna put out a campaign brochure sometime and say I voted to break the property tax cap. Well, I... all I would ask is that people who have their houses ruined, their furnishings

ruined and, in fact, on occasion their lives ruined are probably willing to pay the tax in order to eliminate and alleviate the flooding concerns. It is part of government's responsibility to do that. I intend to vote 'aye'. I urge my colleagues to vote 'aye' as well."

Speaker Madigan: "The question is, 'Shall this Bill pass, the Veto of the Governor notwithstanding?' The Motion requires 71 votes. And this is final action. Mr. Clerk, take the record. The Clerk shall take the record. On this question, there are 73 people voting 'yes', 44 people voting 'no'. This Motion, having received the required Three-fifths Majority, the Motion to override prevails and the Bill is declared passed, notwithstanding the Governor's Veto. Mr. Daniels.
