The Bill requires an individual who's conditionally admitted as a student to a medical school located in Illinois to submit to a criminal history records check for certain felony and sex offenses. This Bill went out of the House with 117 votes before it went to the Senate, but I didn't concur with some of their changes. Since then, we've had a Conference Committee and I will share with you the changes. Now the background check are performed on matriculants, these are individuals that have been conditionally accepted. The background checks are mandatory. We have included civil immunity for the medical schools, except for willful or wanton misconduct. medical school under the provisions of this Act shall be civilly liable. Section 20 deals with the medical schools' admissions and decisions. We've also added the following offenses from the House Bill as amended: predatory criminal sexual assault of a child, aggravated criminal sexual assault, criminal sexual assault, and kidnapping. And this Act does apply to all matriculants but does not apply to all applicants admitted as of the effective date of this Act. We worked with SIU Medical School and also the Illinois Trial Lawyers, and the University of Illinois Medical School is onboard. And we will work with the Med Society on a trailer Bill as they see fit as far as more civil immunities. I can answer any questions."

Kelly: "It's any student that's applying, but it can only be searched in the United States."

Davis, M.: "Okay. I'm just concerned that we don't allow people from out of America to come and don't go through the same background check..."

Kelly: "Um hmm."

Davis, M.: "...to go into certain fields."

Kelly: "Um hmm."

Davis, M.: "And I commend you for your legislation."

Kelly: "Thank you."

Speaker Madigan: "Again, the Lady moves... Mr. Black."

Black: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "The Sponsor yields."

Black: "Representative, why is this limited to a student applying for medical school? When you have bad days around here, and we all have them, it's really nice to know that
