It's completely discretionary. The member has to request it. There's no cost to the state. There's no change in any retirement funding that the member would receive. It basically allows them to move up one rank. seems to be something that is very, very important to the members of the National Guard. I was deliberating whether to include this as my... one of my top three Bills, and then after speaking to many National Guard members it meant so much to them. And in the last couple of years they've been called on to do so many things that truthfully, the reason I'm running the Bill is that it means that much to them.

And if it means that much to the members of the National Guard, I think it's something that we should do. So, I would... it came out of committee 8 to 1. And I would appreciate your support."

Speaker Madigan: "The Gentleman moves for the passage of the Bill. The Chair recognizes Mr. Bost."

Bost: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Madigan: "Sponsor yields."

Bost: "Kevin, when... when you said that... now, it's an honorary rank, they... they don't receive an increase in retirement or anything like that?"

McCarthy: "Correct. Correct."

Bost: "Okay. When... and... and I'm just trying to weigh this out because as a... as a... when I served, ya know... Actually, the... the week I was getting out... I chose to leave, I was picking up the rank of... of E5. And I would've loved to had that rank but that's the way the military is set up that, you know, I... I was a corporal and I was going to remain a corporal unless I got a promotion. And... and I don't understand the reason, I mean, you are what you are. Why do we change this then after they get out?"

McCarthy: "Well, as I said, ya know, I talked to these people, I know how important it is to them. And the thing is, today it is allowable for commissioned officers and warrant officers, but it's not for enlist... for, ya know, sergeants."

Bost: "Wait a minute."

McCarthy: "To... today you can do this. This includes the Els through E7s, that they can request this. It's just an honorary rank. It's for, ya know like, they... they can wear...

the... the Department of Military Affairs would describe the rules for how they wear the rank and everything else, and some people would want it. I know, I've talked to like Representative Stephens, he said he's an E5 and he wants to be an E5."

Bost: "Right. And I was an E4..."

McCarthy: "Now..."

Bost: "...and I feel like that I accomplished that rank and... and did everything I was supposed to, but then all of a sudden we're gonna give an honorary rank to the next level makes..."

McCarthy: "Well, you know truthfully, they can... like I said, commissioned officers can do this today, can request it. This actually adds more time in service they have to have in order to... to request the rank. And there is no cost, your original... you know, your first question about it, the cost as far as... there's nothing changed as far as their retirement. This at least says they have to have 20 years of service to ask for this..."

Bost: "And..."

McCarthy: "...and... and 10 year... you know, the last 10 years in the Illinois service."

Bost: "And... and the only thing I'm concerned about is, is those people who... who achieved their rank and... and did it based on... on the criteria set forward and serving their time in grade. And I... I'm wondering how others will feel that, you know, haven't received that honorary..."

McCarthy: "Well, the mast... you know, the master sergeants who testified at committee, and I think, were wonderful witnesses. They... they talked about today in the National

Guard, because of the certain ranks being filled, no matter what you do when you get to a certain level like E5, you could be the best soldier, you could, ya know, serve for years for that rank, and there's no slot available at E6."

Bost: "What..."

McCarthy: "So, you'll never, ever get it."

Bost: "Sure..."

McCarthy: "Okay."

Bost: "...and I... and I understand that..."

McCarthy: "And..."

Bost: "...'cause that's the way it was whenever I was in. If... if you didn't have an opening slot above ya, you didn't pick up that next rank. And... and that wasn't anything disgraceful to your character, but the reality is you were not that rank. And... and, you know, I mean..."

McCarthy: "Yeah. I... I understand..."

Bost: "...I... I kinda wonder then... then should we also say that, you know, I had a... I actually filled their billet and did a... did the work of an E6 or an E7. Should I go back and say, 'Hey, you know what, I really carried a staff sergeant's position and... and a gunnery sergeant's position, really I should probably go ahead and do that 'cause I did their work.' But... but I... it's always been a thing that... that... let the military make these decisions not government..."

McCarthy: "Yeah..."

Bost: "...come in and say give ya an honorary... rank."

McCarthy: "Right. Well, like I... you know, truthfully, Representative, and I know you have a lot of respect for the military like I do..."

Bost: "Yeah, I do."

McCarthy: "...and..."

Bost: "And I know you do."

McCarthy: "You see by the number of the Bill, I let this thing sit for a long time."

Bost: "Yeah."

McCarthy: "And it was only from calls from these guys that they told me how important it was to them that I..."

Bost: "Right."

McCarthy: "...I didn't want to include it as my top three."

Bost: "Right."

McCarthy: "But the main reason I'm pushin' the Bill, and 'cause I... I never would want, I mean, I wasn't in for 20 years so I wouldn't be eligible for any of this either, you know. And I actually think we make it a little bit tougher because we add that 20-year requirement where today it's only 10 years for the commissioned officers, you know. And plus, I think if we have this for the commissioned officers, we should have it for the enlisted men as well."

Bost: "Right."

McCarthy: "So, and it does have like an enlisted man cannot go above sergeant major and the… the highest in the commissioned officers, they can go from colonel to brigadier general."

Bost: "And..."

McCarthy: "So, you know, I... I don't think I've given you a great explanation, but I know it's important to the men."

Bost: "...and... and I appreciate... and I appreciate your Bill, I... I do. I appreciate what you're trying to do. I can't support

it based on the fact that I am a... a veteran and... and that's the way I saw the ranks whenever I was in. And... and to say that after... after you leave we can all of a sudden apply and get promoted that's a little strange to me. But... but thank you."

McCarthy: "I... I do think you have some very valuable points."

Bost: "Thank you for answering the questions."

Speaker Madigan: "Mr. Stephens."

Stephens: "Thank you, Mr. Speaker. To the Bill. The... well,

excuse me. Would the Gentleman yield for a question?"

Speaker Madigan: "Sponsor yields."

McCarthy: "Yes."

Stephens: "Representative, where's the Department of Military Affairs on this Bill?"

McCarthy: "They have not weighed in."

Stephens: "I... well, I would just tell you what the Republican staff analysis tells us about the Department of Military Affairs. Our staff says that they oppose the Bill because it... it believes that giving, for example, the next highest rank to... of general to a colonel who retires after 20 years is just improper. Now, I... I don't want to misrepresent the department's position and... and I was the one... the one Member of the..."

McCarthy: "Committee."

Stephens: "...State Government Administration Committee that voted 'no'. Is it... am I wrong, did they... you're saying they just don't have a position?"

McCarthy: "I... I can only tell ya they have not spoken to me."

Stephens: "Okay. Well, that's fair."

McCarthy: "The members of the Guard that testified there, they certainly implied that the department was okay with this and that they said they would be willing to make the rules. But I... I've never heard that they were..."

Stephens: "Okay."

McCarthy: "...proponent or opponent."

Stephens: "All right. Well, okay. Well, be that... be that as it may, I don't want to misrepresent their position so I will just speak on behalf of myself as a... as a retired veteran, as someone who like Representative Bost, an enlisted man. I attained the rank of sergeant. And as I told you in committee, if you tried to give me a promotion when I retired to... to put that rocker under my arm, I would've... I would've been upset. The rank of sergeant, a buck sergeant is what I was, three stripes, just three simple stripes that meant the world to me. They represented every bit of sacrifice that I made for my country in uniform in combat. I would be insulted if you said, 'Well, you know what, you're retiring now so we're gonna... we're gonna make you a staff sergeant.' And I would've told you what to do with that rocker because I felt so strongly and still feel so strongly that on behalf of especially the enlisted men, the enlisted men of the United States military earned their stripes. That... that phrase is a part of Americana, you have to earn your stripes. It means so much to so many who have paid such a sacrifice that I told you as I told the gentlemen who were your witnesses in committee, offended. I think this about a few retired officers or guys who wanna be something that they aren't quite, that I'm

offended. And that I thought that their... they were wrong to stand before the State of Illinois, the Legislature and say, 'Give me something that I didn't earn.' It's about carrying it in your wallet. That's all it's about. It's about being at a party somewhere and being about to say, 'Look at me. I'm a general.' Well, no you're not, you're a colonel and you should be proud to have been a colonel. That's a huge rank and you earned it. I wanna be a sergeant... when I'm buried, on my marker it's gonna say United States Army, E5. That's all I ever wanted to be, it's all I ever was, and I'm proud of it."

Speaker Hannig: "Representative Hannig's in the Chair.

Representative McCarthy to close."

McCarthy: "Well, thank you and I... I would just like to say that Representative Stephens made a lot of good points in committee, made a lot of good points today. But I tell ya, the two men that testified this meant so much to them and they're chief master sergeants that aren't even eligible for this thing 'cause that's the highest you can go as far as an enlisted man. And as I stated in my opening remarks, I would not have used this Bill as one of my top three if it wasn't so important to them. And maybe I'm not doing the best job explaining why it's so important to the men and women who serves us, but I think if they think it's important, it's something worthy of passage. So, I'd appreciate your support."

Speaker Hannig: "The question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed 'nay'. The voting is open.

Eddy: "Point of pers... personal privilege."

Speaker Hannig: "Yes, state your point."

Eddy: "Ladies and Gentlemen of the House, if you could help me welcome a group from Crawford County, Illinois. If you'd stand up up here, the Crawford County Leadership Group is here to visit Springfield. Welcome to Springfield."

Speaker Hannig: "Representative Bost, for what reason do you rise?"

Bost: "Point of personal privilege."

Speaker Hannig: "State your point."

Bost: "If I could get everybody to look up in the gallery to our right, we have a group from Murphysboro and Nashville that's here for Jobs for Illinois Graduates, if they'll stand up and be recognized."

Speaker Hannig: "So, we're going to continue on page 5 of the Calendar under the Order of House Bills-Third Reading. Representative Delgado, you have House Bill 4242. Representative Delgado, do you wish to call this on Third, 4242? Mr. Clerk, read the Bill."

Clerk Bolin: "House Bill 4242, a Bill for an Act concerning State Government. Third Reading of this House Bill."

Speaker Hannig: "Representative Delgado."

Delgado: "Thank you, Mr. Speaker and Members of the General Assembly. House Bill 40... 4242 was recommended by the Cook County Public Defender. This Bill amends the Children and Family Service Act regarding the placement of children with relatives. Kinship care to require that in... that in determinations regarding the possible placement of a child with a relative, the Department of Children and Family Services must base its decisions on the factors stipulated in its rules and also on the basis of the child's best interest as defined in Section 1-3 of the Juvenile Court Act. And I would ask for your 'aye' vote on this piece of legislation."

Speaker Hannig: "This Bill's on the Order of Short Debate. Does anyone stand in response? Then the question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Granberg? Okay. Mr. Clerk, take the record. On this question, there are 116 voting 'yes' and 0 voting 'no'. And this Bill, having received a Constitutional Majority, is hereby declared passed. Representative Brosnahan, do you wish to read... for us to read 4315? Okay. So, we'll take that out of the record. Representative Bellock, you have House Bill 4383. Mr. Clerk, read the Bill."

Clerk Bolin: "House Bill 4383, a Bill for an Act concerning families. Third Reading of this House Bill."

Speaker Hannig: "Representative Bellock."

Bellock: "Thank you very much, Mr. Speaker and Members of the House. House Bill 4383 addresses the issue of child support

in the State of Illinois with over 50 percent of custodial parents still receiving no support. So, what this Act does is amend... what this Bill does is amend the Illinois Marriage and Dissolution of Marriage Act, requiring the noncustodial parent to reimburse the custodial parent for 50 percent of the cost incurred when the custodial parent must add the child onto their health insurance plan. This Bill was amended with reference to the Illinois State Bar Association giving the judge the discretion with other factors if they see fit. I don't know of any opposition."

Speaker Hannig: "This is on the Order of Short Debate. Does anyone stand in response? The Gentleman from McHenry, Representative Franks."

Franks: "Representative... Will the Sponsor yield?"

Speaker Hannig: "She indicates she'll yield."

Franks: "One hypothetical that's been brought to my attention, hopefully you can clear up. What happens if there's two state workers and there's no court order and they're receiving benefits? What happens in a situation like this if there's no court order?"

Bellock: "Two state workers... no court order... I don't know in reference to this, this was just upon a court order."

Franks: "I'm wondering if you might want to go farther, you know, if kids aren't being covered maybe we can look at this. I'm not trying to derail your Bill, I'm just... I wanna make sure... I know what you're trying to do, I'm just trying to make it bulletproof."

Bellock: "I think I'd just like to move the Bill as it is.

We've worked a long time on this Bill with the Illinois Bar

Association..."

Franks: "Okay."

Bellock: "...and if you want me to improve on it and strengthen it next year, I'd be glad to do that."

Franks: "Maybe we could do it in the Senate if we can possibly do an Amendment."

Bellock: "Yeah..."

Franks: "Okay."

Bellock: "...that's okay."

Franks: "Thank you."

Bellock: "Um hmm. Thank you."

Speaker Hannig: "Representative Bellock to close. Did... did you wish to close?"

Bellock: "Yes. Thank you very much. We've worked hard on these Bills as trying to improve the child support system in Illinois, to address the issues of 60... close to 60 percent of custodial parents not receiving any support whatsoever. Medical insurance seems to be a major item to help people deal with the issues of providing a good quality of life for their children and that's the main issue that we're trying to address here. So, I thank you and I appreciate your support."

However, this law had been ruled unconstitutional in... invalidated on single subject grounds. It first was created in 1994 by Public Act 88-669. When the Public Act is stricken by the court, it places in legal jeopardy all actions taken in reliance on those enactments. So, what we find ourselves here today is a situation in which many seniors are depending on us in the General Assembly to reinstate this law. It was thrown out by the Supreme Court on a technicality, but this law has been the policy of the State of Illinois, it's very

important to many seniors who have come to depend on it. I'm sure we've all been receiving calls about this. law validates and reenacts the senior citizen In addition, what this law does is assessment freeze. increases the maximum allowable household income purposes of determining the eligibility for the senior freeze from 45 thousand to 50 thousand dollars, so more seniors would be eligible to take advantage of this freeze In addition, it increases the senior citizens situation. homestead exemption from \$3 thousand to \$35 hundred. Therefore, all seniors who are homeowners would be able to get a new benefit as the result of this legislation. And in addition, the legislation increases the maximum allowable household income for the purpose of determining eligibility of the senior citizens real estate tax deferral program, increases that eligibility from 40 thousand to 45 thousand dollars beginning in 2006 year after. And this is a very important piece of legislation and I would ask for your support."

Speaker Hannig: "The Gentleman has moved for the passage of House Bill 4789. This is on the Order of Short Debate. And in response, Representative Black."
