One of them addresses an issue of sibling contact that we had a hearing on. Another has to do with setting guidelines and standards for adoption subsidies for foster parents. Another portion of this Bill requires disclosure to prospective foster and adoptive parents about a child's social health and behavioral health. And I would be glad to answer any questions."

One was about postadoption sibling contact that Representative Annazette Collins and Senator Mattie Hunter called and also, a second set of hearings that the Adoption Reform Committee heard on an issue of compensating adoptive and foster parents on their subsidies."
- Parke: "So, it's a bipartisan. Representative Froehlich was a Member of your commission (sic-committee)."
- Feigenholtz: "Unfortunately, Representative Froehlich is not on that commission. I... I'm... I don't know how he got on this, but I'm glad to have him. But Representative Lindner is on this committee and she and I have been working very closely together."

Parke: "So, it was Republican and Democratic House Members?"

Feigenholtz: "I'm sorry, Terry, I can't hear you."

Parke: "I said Republican and Democratic House Members."

Feigenholtz: "Yes. Yes."

Parke: "And the crux of what you heard from the foster parents was that they needed better communications?"

Feigenholtz: "There... They had been trying to negotiate with the department about subsidies. It seems as though there were some foster families who felt that their subsidies and the decisions made around them were somewhat arbitrary. And it was the collective... the collective response from a lot of us on the committee was that we should reestablish guidelines

and ask the department to draft a rule about those guidelines."

Parke: "Okay. And is... Do you know if anybody's in opposition to this Bill?"

Feigenholtz: "No, I do not. There was no one in committee in...
opposed to the Bill and I believe the department is neutral

Parke: "Thank you very much, Representative."

Speaker Hannig: "Representative Feigenholtz to close."

Feigenholtz: "I'd appreciate an 'aye' vote."

Speaker Hannig: "The question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Representative Granberg, do you wish to be recorded? Mr. Clerk, take the record. On this question, there are 114 voting 'yes' and 0 voting 'no'. And this Bill, having received a Constitutional Majority, is hereby declared passed. Representative Durkin, do you wish us to read... Okay. Out of the record. Clerk Bolin: "House Bill 4315, a Bill for an Act concerning regulation. Third Reading of this House Bill."

Speaker Hannig: "Representative Brosnahan."

Brosnahan: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. The House Bill 4315 addresses a very booming industry in the State of Illinois. Actually, not just in

the State of Illinois but throughout the country and that is the business of charitable car donations. What happens here in the State of Illinois, as in many other states, charities will accept motor vehicles, boats, anything from people that wanna donate them to the charities. What the charities do in turn then is they actually hire a company that will be responsible for going to these... the donor's house and picking up the car or the item and then they would be responsible for giving it to the charity. Currently, there are no regulations imposed upon those for-profit persons and entities hired by the charities to receive and process the charitable contribution of vehicles in Illinois. Instead of actually performing the work, many of these not-for-profit companies hired by the charities subcontract out the work to the various towing companies and auction houses who have no direct relationship with the charity and that have no obligation to account for the cars that they collect. Currently, the Solicitation For Charity Act defines a professional fundraiser as a 'person who, for compensation other consideration, manages or carries on solicitation drive in this state for the purpose of soliciting contributions for or on behalf of any charitable organization.' The definition does not include a person hired by the charities to receive or collect contributions of property and thus, none of the registration reporting requirements imposed on these professional fundraisers by the Solicitation Act applied to these non... these for-profit entities and the towing companies who pick up and process the donated vehicles. So, what this legislation does it

changes the definition of 'professional fundraiser' to include those entities that also receive and collect the motor vehicles. It also changes the definition of a 'professional solicitor' to also include those people that receive and collect these motor vehicles. Another provision of this legislation is it not only forces them to register with the Attorney General's Office, but it also is gonna require them to keep records, keep records of what they collected, the VIN number of the motor vehicle as well as how much money they received for the motor vehicle when they resold it, how much money actually went to these charitable organizations. I have received notice from nobody saying they oppose this Bill. There's no opposition as far as I I'd like to thank the Attorney General's Office for working with this legislation me on as well Representative Randy Hultgren who was involved with this. And I'd be happy to answer any questions. Thank you."

Speaker Hannig: "Representative Brosnahan has moved for the passage of House Bill 4315. This is on the Order of Short Debate. And in response, the Gentleman from DuPage, Representative Hultgren."

Hultgren: "Thank you, Mr. Speaker. To the Bill. Just very quickly, I wanna thank Representative Brosnahan as well. This is an important issue. I encourage all of you to support this. This is really important for us to protect those people in our communities, our constituents, who have a charitable mindset, who want to donate their car to benefit charities. We've heard of literally hundreds of stories throughout the state where there's been misuse and

abuse of this process. I think the Sponsor has done a great job of tightening this up, along with the Attorney General's Office, again, to make sure that our citizens are protected, that their charitable interests are... are truly being abled to be followed through. So, I encourage your support. Thank you."

Speaker Hannig: "So, in response, Representative Will Davis."
Davis, W.: "Thank you, Mr. Speaker. Will the Sponsor yield?"
Speaker Hannig: "He indicates he'll yield."

Davis, W.: "Representative, I'm reading in the analysis here and it says that they must register, meaning, I guess, professional fundraisers and cannot be felons or have been convicted of a misdemeanor involving fiscal wrongdoing. If I'm a college student and I bounced a check when I was in college, does that preclude me from doing this?"

Brosnahan: "I'm sorry. I couldn't hear that, Representative."

- Davis, W.: "If I... if I bounced a check when I was in college, does that pre... does that preclude me from being a professional fundraiser based on this Bill?"
- Brosnahan: "Well, I've just been informed... I guess this matter did come up in some prior discussions and I've been told that, if you bounced one check, this will not apply to you at all. It's... it's more of a..."
- Davis, W.: "Well, if... but... but if I've been convicted of being a misdemeanor and... and specifically what I'm getting at is, I went to school in Southern Illinois. As an African American attending school in Southern Illinois, things like that didn't go unpunished. If you got caught bouncing a check at the grocery store or some place like that, you were

prosecuted for it. And I know people who still have that on their record. Even though this was 20 years ago, they still have it on their record. So, my simple question is, if I'm in that situation, based on the definition that I read here, does it prevent me from being a professional fundraiser?"

Brosnahan: "If you were convicted, the answer is 'yes'. I thought the original question was if you were arrested or picked up. But if you were convicted of the crime, then the answer would be 'yes' you wouldn't be allowed."

Davis, W.: "Okay. It is 'yes'?"

Brosnahan: "Yes, upon a conviction."

Davis, W.: "If you're under a..."

Speaker Hannig: "So, Representative Sacia is recognized for 5 minutes."

Sacia: "Thank you, Mr. Speaker. I'll be brief. First of all, Representative Brosnahan, I... I applaud you for this legislation. I... I really think it's exceptional. I was out of the chamber for a little bit and I don't know if it was mentioned but there are a large number of charities out there that are doing this on their own that are very, very legitimate. And... and the reason I share that with you, Sir, I was so impressed with your legislation that I wrote about it in my weekly column that I write in my newspapers and one of the local charities contacted me just to emphasize that there are a lot of good ones out there that are taking a minimal amount of money, ya know, the cost of a battery, the cost of running it through the auction, what have you, and... and I, again, it may have been said when I was out of the chamber but there are some very honorable charities doing

some very honorable work for all the right reasons. But, again, I applaud your legislation. I think it goes directly to the heart of a bad situation."

It amends the Code of Criminal Procedure regarding bailable offenses. An offense that would require registration under the Arsonists Registration Act if a person was previously convicted of arson, aggravated arson, residential arson, or place of worship arson, possession of explosive or explosive, or incendiary devices or an attempt to commit these offenses. And the burden would be on the state to prove that the

Rose: "Ya know, Representative, I don't believe they are. I'll tell ya what. This was brought to me by the Fire Caucus.

Bost: "Just check and see as it goes over to the Senate and see what we can do."

Rose: "Mr. Speaker, will you pull this from the record?"

Speaker Hannig: "Okay. You wanna take it... We'll take it out of the record then at the request of the Sponsor. Representative Meyer, do you wish us to read 5249? Mr. Clerk, read the Bill."

Clerk Bolin: "House Bill 5249, a Bill for an Act concerning criminal law. Third Reading of this House Bill."

Speaker Hannig: "Representative Meyer."

House Bill 5249 provides it is a Class IV felony for a child sex offender to knowingly operate, manage or be employed or to volunteer, be associated with or knowingly be present at a daycare center, a part daycare or child cent... day... a part day child care facility, or a school providing before or after school programs for youths under 18 years of age. It also prohibits a sex offender from residing within 500 feet of certain facilities, including a child care institution, daycare center or part day child care facility."

Speaker Hannig: "The Gentleman has moved for the passage of House Bill 5249. This is on the Order of Short Debate. And in response, the Lady from Kane, Representative Lindner."

Lindner: "Thank you, Mr. Speaker. Representative, when we've done these school Bills before, there is an exception for

"Thank you, Speaker, Ladies and Gentlemen. This is the Hamos: Comprehensive Housing Planning Act which looks very much like a Bill that we already passed here 2... 3 years ago and put on the Governor's desk. And at that time, we negotiated with him that he would veto that, and we would create this concept by Executive Order, but now there's quite a bit of interest in codifying this and it's working pretty well. This really requires the state... Illinois Housing Development Authority working with a slew of state agencies to look at all of our housing resources that come into the state and to create a housing plan that actually focuses on some of the underserved populations. And I... It goes on into some detail about what the housing plan would contain, who would be on the housing task force which we've now had in place for 3 years, who... what would be the intergovernmental committee that... that helps work on this, the interagency committee, subcommittee. And I'm available for any questions."

Speaker Hannig: "The Lady has moved for the passage of House Bill 5268. This is on Short Debate. Does anyone stand in response? Then the question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed 'nay'. The voting is open. Have all voted who wish? Mr. Clerk, take the record. On this question, there are 114 voting 'yes' and 0 voting 'no'. And this Bill, having received a Constitutional Majority, is

- hereby declared passed. Representative Winters, for what reason do you rise?"
- Winters: "Yes. A correction on House Bill 5249. My vote was cast... voting the wrong way and would like the record to reflect that I should've been a 'yes'."
- Speaker Hannig: "Okay. The record will reflect your intentions, Representative. Mr. Clerk, read House Bill 5274."
- Clerk Bolin: "House Bill 5274, a Bill for an Act concerning transportation. Third Reading of this House Bill."
- Speaker Hannig: "Representative Reitz."
- Reitz: "Thank you, Mr. Speaker. House Bill 5274 is similar to a number of Bills we've heard over the year. It deals with the redistribution of weight for concrete trucks. Representative Kosel had this Bill last year. I think we've debated this a number of times. I think it's a good Bill. I'd appreciate your support."
- Speaker Hannig: "This is on the Order of Short Debate. And in response, the Gentleman from Vermilion, Representative Black."
- Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"
- Speaker Hannig: "He indicates he'll yield."
- Black: "Representative, this Bill passed last year and as you know... well know, vetoed by the Governor, we were not able to override the Veto. Do you have any insight as to whether the Governor will sign the Bill or will he veto it again?"
- Reitz: "I don't, but we are working with the Illinois Department of Transportation trying to work out any issues that they may have. As I said, I think it's a good Bill and they're

trying to accommodate us with some of the concerns that we have. And as this moves through the process, I'd be surprised if this was the final package, but I'm hopeful that we'll get something back from the Senate that the Governor will sign and IDOT will sign off on."

Black: "All right. Thank you very much, Representative. Speaker, Ladies and Gentlemen, to the Bill. I support these Bills as a matter of convenience in my district. I know what's happening when cement trucks can't get to a subdivision because of weight restrictions on certain roads. And it... and it brings back and many of you were kind enough to vote for my Bill last year that created a uniform weight law in Illinois with local ordinances and... and exceptions certainly being included. And that Bill passed the House and unfortunately, died a horrible death in Senate Rules. But at some point, we're going to have to address the issue... We're one of the last Midwestern states that does not have a uniform weight law. And so, we pass Bills like this year after year after year. Cement trucks one year, solid waste trucks a few years back, getting an 8 thousand pound variance and the list goes on and on and on and on. And at some point, rather than do this piecemeal, it would behoove, I think, all of us suburban, urban Legislators and rural Legislators to come together, do what most Midwestern states have done... and I've spoken to the Sponsor and I know he doesn't have any objection to this. At some point, we have to enter the 21st century, come up with a uniform truck weight Bill like all of our neighboring states have and that's gonna be the solution. If we don't, then we're gonna

pass Bills like this year after year after year, some get vetoed and some don't. I intend to vote 'aye', but I think at some point I would hope we'd join together and pass a uniform weight Bill."

Speaker Hannig: "Representative Feigenholtz."

Feigenholtz: "Will the Sponsor yield?"

Speaker Hannig: "He indicates he'll yield."

Feigenholtz: "Representative Reitz, is... I think it's Groundhog

Day. Is this Bill similar to the Bill that's been vetoed

500 times about trucks going faster?"

Reitz: "No."

Feigenholtz: "No. This is heavier, right?"

Reitz: "Yes, going heavier at the same speed."

Feigenholtz: "And could you tell me a little bit about this Bill. Why is it different from the form... the Bills that the Governor had vetoed?"

Reitz: "There's not much difference in the language. We're working with IDOT to try and come up with their... address their concerns. Their... they have been talking over the summer trying to figure out ways to accommodate them. IDOT was still opposed to this legislation, but I think as it moves through... I'm just hoping that we move this through the process and work with them and come up with something that works. As Representative..."

Feigenholtz: "Can you... can you tell me when you change the allotted rate of weight for a truck, does it have any effect on allowing it to go faster? Is there going... I mean, does this Bill include anything about raising the speed limit?"

Reitz: "No. It just deals..."

Feigenholtz: "Will it ultimately result in that by changing..."

Reitz: "No."

Feigenholtz: "You're sure?"

Reitz: "Positive. And this deals... this strictly deals with concrete trucks, the weight that is allowed on bridges. And Representative Black brought up a good point. The problem we have is going from system, to county, to state, to federal highway systems. There's a tremendous variance in those and it causes the problem on trying to get concrete, in this case, to the worksites."

Feigenholtz: "I see. I also see that the City of Chicago, the Illinois Department of Transportation, the Municipal League, DuPage Mayors and Township Officials are opposed to this. Is that correct?"

Reitz: "I believe that's correct."

Feigenholtz: "Do you know why?"

Reitz: "Because well, probably the same reason as IDOT. They think it will cause additional stress on the bridges and... and have to be replaced at a sooner time. My belief is that the technology is such that, you know, we haven't changed this city rule in years. That the weight limits in rules and the redistribution that we have included in this Bill will not cause the undue burden on the bridges that I think they allege that it does."

Feigenholtz: "Thank you very much."

Speaker Hannig: "So, we're going to put this on the Order of Standard Debate so... so some additional Members can debate the Bill. Next on the list is Representative Bost."

Davis, W.: "Now, is that... is your feeling on that based on current technolo... current technology that's being used to build bridges?"

Reitz: "Not so much the technology to build bridges. It's the technology that's available on the trucks theirself that redistribute the weight. We have not addressed this by legislation in a long time and I think we need to update... have IDOT update our laws to reflect the technology... the technological changes that the concrete industry has made in their trucks."

- Davis, W.: "Well, I'll... I'll tell you what my concern is, is that if there is a possibility that implementation of this Bill can cause stress on bridges, particularly old bridges, when you're in a district like mine where infrastructure is not as good as some other districts and bridges are in need of repair but unfortunately there's not resources available through IDOT to repair those bridges and I'm concerned if this Bill will cause additional damage to bridges in my district still without additional resources to make the adequate and necessary repairs to the bridges. So... so... so, my... my thought is, is that... is that my communities won't be able to afford any damage to the bridges."
- Reitz: "Right. And I... I appreciate that concern. We're trying to... to make that... IDOT has the ability to post a bridge if they think if it's in disrepair or it can't handle certain weights. Holbrook: "Thank you so much."

Mr. Clerk, what is the status of House Bill 4451? 4451. I believe we had moved it to Third Reading, is that correct?"

- Clerk Bolin: "House Bill 4451 is on the Order of House Bills-Third Reading."
- Speaker Hannig: "And the Sponsor requests that we return it to the Order of Second Reading, Mr. Clerk. Mr. Clerk, would you read the Agreed Resolutions."
- Clerk Bolin: "Agreed Resolution. House Resolution 934, offered by Representative Ryg."

Her tireless work, dedication, and long-time fight for equality helped build a platform and put... upon which the country will stand forever. And with that thought in mind, I wanted to invite or to remind all of the Members that on next Thursday, the 23rd of February, we'll be celebrating Black History Month, our annual soul food soiree. Members are invited to attend. It's going to be at the Governor's Mansion.
