Speaker Hannig: "On page 9 of the Calendar, under the Order of House Bills-Third Reading, Representative Boland, you have the first Bill, House Bill 4079. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 4079, a Bill for an Act concerning government. Third Reading of this House Bill."

Speaker Hannig: "Representative Boland."

Boland: "Thank... thank you, Mr. Speaker. House Bill 4079 is a... deals with a very important group of people, a small group of people, but a very important group of people, and that is the employees in our child advocacy centers. And what this Bill does is allow them to buy insurance for... buy the... allows the centers within the State of Illinois to buy insurance for their employees, annuitants, and their dependents under the state... group insurance program. Under this Bill, which... they see this as a solution to a very serious problem facing the children's advocacy centers, and that is the inability to obtain affordable health insurance

for their employees. Most of Illinois's 36 children's advocacy centers operate with a small staff, fewer than 10 employees. With such small staffs, they are unable to benefit from cost breaks that are offered by insurance companies to larger employee... employers. And as a result, many of these children advocacy centers cannot afford to offer health insurance to their employees. This would give them an option. And there is no... there is no fiscal impact on the Department of Children and Family Services and also the Department of Commerce and Economic Opportunity says that House Bill 4079 does not create a state mandate under the State Mandates Act."

Speaker Hannig: "The Gentleman has moved for the passage of House Bill 4079. And on that question, the Gentleman from Cook, Representative Parke."

Parke: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hannig: "He indicates he'll yield."

Parke: "Representative, let... let me understand this now. You're telling me that this legislation is gonna allow a group of people, those that work with child... children advocacy centers, to go into the CMS group insurance policy?"

Boland: "Yes, they will buy into it and it's called on a noninsured basis. That means that basically they pay all the costs of it."

Parke: "Now, do they have to go through underwriting like any new person would be if... what if they have a heart condition? Will they be... is it mandatorily accepted or do they have to go through underwriting and it could be declined?"

Boland: "So, as... as I understand it from my staff here, they go in on a... baseline... when they go in, HMS and CMS sets a fee that they pay."

Parke: "That's not the answer to my question."

Boland: "Repeat your question."

Parke: "I asked you the question, do they have to go through underwriting like everybody else? And... are they able to be declined? Do you want to take this out of the record and get that..."

Boland: "Yes. No. No. No. No, we're... we're gonna answer your questions. As I understand it from the staff here that they go... I'm not an insurance expert so I have to have their help."

Parke: "I understand. Sometimes it's difficult when you... What I want to do is I'd rather have you not guess. Do you wanna..."

Boland: "No, they're... we're not guessing. He's... he is advising me well. He says that they go in and then a baseline is set within a year and then... and then they're put into a pool."

Parke: "Guys, you're guessing. I'm sure the Speaker'll get back to this."

Boland: "Okay. Yes, let me... Okay. I'm... as I said, I'm not an insurance expert."

Parke: "I appreciate that."

Boland: "I'm getting the... the... hopefully the expertise here from our staff. He says that when they go in, if there is somebody with a condition then that rate for that particular CAC is fixed at a different rate. It will go up after the first."

Parke: "They will what?"

Boland: "If... if after that first year somebody in their group has a condition or something, then their rates of that group would go up."

Parke: "The range for what group?"

Boland: "If... if they group, as you asked, if somebody has a heart condition or something..."

Parke: "Yeah."

Boland: "...then after a year they would... their group, if they had somebody with a condition like that, their... the group... the rates for that group would go up."

Parke: "All right. Let me... let me ask you this. If you're telling me... let's say that we have a children's advocacy center that has 50 people in it."

Boland: "Okay."

Parke: "Are you telling me that that group..."

Boland: "They're all much smaller than that, incidentally."

Parke: "Very good."

Boland: "There are none of 50."

Parke: "Very good. I'm using an example. Let's say it's 10 people."

Boland: "Yeah."

Parke: "And those 10 people bring somebody in that has a major heart problem that's gonna require major surgery. Are you telling me that in the first 12 months the CMS group will have to pick up the expense of that or are you telling me that group of 10 people going in, if somebody has a million dollar claim, that that's gonna be spread out by 10 people? That's what you told me."

Speaker Hannig: "Representative Parke, your 5 minutes have expired."

Parke: "Give me a break. The Gentleman has not answered my question."

Boland: "I'm trying to answer it. Just a second, here. All right."

Parke: "I understand, it's difficult."

Speaker Hannig: "Representative Eddy, I think, wants to yield you 5 minutes, Representative."

Parke: "Thank you."

Speaker Hannig: "So... so we'll give you 5 more minutes."

Boland: "Premium... premiums for noninsured groups, such as the advocacy centers, have typically been determined by setting a baseline for the group by using the claims history of the individual offices within the group. Or if the offices were previously uninsured, as many of these might be, using demographics of the group. After the initial year, each individual office is rated in a tiered form using their claims from the previous year. Groups with a high rating, those that are making fewer claims and in good health, pay rates that are lesser than the baseline. Groups with a low rating pay higher rates than the baseline. And I might add, if I... if I can add one thing."

Parke: "Okay. Do it."

Boland: "And that is that they provided me some demographics with this. Almost all of their employees are under the age of 35. They are a young, healthy group."

Parke: "All right. Representative, what you've just got through telling me that is in the first 12 months, if an individual

has a major heart attack that requires major surgery and the bill is a million dollars, that in 10... 12 months from the time that they went into that group, it will split out for the 10 people and there's no way that those people are gonna go on the group plan. There is no way that there will be minimal expense to the plan. If you bring a couple people in with a couple million dollar plan, which is, again, high... highly unlikely, I admit. But it could happen. Even one could be a half a million or a million dollar in claims, and that will have an effect on the overall group insurance for CMS, 'cause it has to be shared with all the members of that group."

Boland: "Okay. Could... could you repeat that, please? I... I think I understand it, but this time the experts didn't."

Parke: "I'm saying if it happens to be a half a million dollars..."

Boland: "Yeah."

Parke: "...or a million dollars and it goes into a... into a claim and they're in the CMS plan, one, the small group of people cannot absorb that increase, and... if you want me to talk to you ya gotta look at me like you're interested in what I have to say."

Boland: "If... you're absolutely right in that if, for some reason, they can't cover that, their rates would go up and, unfortunately, probably, the... the group would end up dropping out."

Parke: "So, let me tell you what's gonna happen. You're gonna have people that have health insurance, they're gonna drop their health insurance, they're gonna go into this plan,

somebody's gonna have a major catastrophe and a major expense. They cannot assume that in the first 12 months, they're gonna lose all their health insurance, and they're gonna have to start all over. And woe is any of them that might have high blood pressure or a diabetic or anything during that 12-month period, 'cause now they have a preexisting condition. I... I think you better take a good, hard look at your legislation and make sure this is really what you wanna do. 'Cause today it's this group, which I have the highest respect for all of those people that work in that arena, as you do. But I'm just concerned about what we're doing to 'em with this. And tomorrow, it could be another group that another Legislator wants to put in. The way you're doing it is... could be very expensive and it could be a catastrophe to some of these small groups of people wanting to get into this plan. I think you better think hard and long to whether or not this is what you really wanna do."

Boland: "Well, Represent..."

Speaker Hannig: "Okay, Representative Boland to close."

Boland: "Thank you, Mr. Speaker, Ladies and Gentlemen. This Bill is a very important one. It was brought to me by the children's advocacy centers. It's modeled after the domestic violence shelters, their employees, which have bought into the state plan. And these folks would like to be able to do this so that their employees have an option as far as health insurance. It's very important to be able to retain good employees. Thank you. I ask an 'aye' vote."

Speaker Hannig: "The question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this question, there 113 voting 'yes' and 0 voting 'no'. And this Bill, having received a Constitutional Majority, is hereby declared passed. Representative Lindner, did you wish to do the... do House Bill 4081? Representative Lindner. Okay, out of the record. Representative Lindner, did... did you wish to do the Bill for Representative Mitchell? Apparently not. Representative Boland, you're up again. 4238. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 4238, a Bill for an Act concerning animals. Third Reading of this House Bill."

Speaker Hannig: "Representative Boland."

Boland: "Mr. Speaker, I'd like to take this back to Second for the purposes of an Amendment."

Speaker Hannig: "Okay. So, Mr. Clerk, let's return this to the Order of Second Reading at the request of the Sponsor. Representative Beaubien, 4293. Representative Beaubien? Mark? Do you wish... Out of the record. Representative Collins, you're next with 4338. Representative Collins, do you wish to call this Bill at this time? Out of the record. Representative Holbrook has House Bill 4363. Okay, out of the record. Representative Brauer is next with 4370. Mr. Clerk, read the Bill."

Speaker Hannig: "The Gentleman from Menard, Representative Brauer."

Brauer: "Mr. Speaker, I'd like to take this out and put it back to Second for the purpose of putting an Amendment on it."

Speaker Hannig: "Okay. So this, Mr. Clerk, goes back to the Order of Second Reading at the request of the Sponsor. Representative Ron Wait on 4396. Representative Wait. It looks like Ron's gettin'... gettin' some birthday cake. Do you wanna... Out of the record? Okay. Representative McGuire, you have House Bill 4404. Out of the record. Representative Franks on 4649. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 4649, a Bill for an Act concerning criminal law. Third Reading of this House Bill."

Speaker Hannig: "The Gentleman from McHenry, Representative Franks."

Franks: "Thank you, Mr. Speaker and Members of the House. This is a Bill that Representative Bellock is a cosponsor with me, and we both had the same idea... the genesis of the same Bill. And we think it's very important, dealing with the domestic violence issue. Currently, there are eight states in the country that require a bail hearing when one is charged with domestic violence, but Illinois does not require it. In... few domestic violence cases result in convictions, often because the power the abusers have over their victims. That's according to my state's attorney, Lou Bianchi. He says the offender most often makes promises to the victim and the case is dropped. Domestic violence convi... convictions are also infrequent because they're often pled down to simple battery. But domestic violence is a

very serious crime and it can't be minimized and it can't be ignored. What this Bill will do is it deals with bail with people charged with a violent crime against a family or household member. It'll require a judge to look at 11 considerations and basically have a checklist to determine what the bail should be. And what's important about this is it creates a paper trail to reduce the... the ability for repeat offenders to continually get a diversion program because there is no history that they have been through the courts before. I'd be glad to answer any questions."

Speaker Hannig: "And on that question, Representative Gordon."

Gordon: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hannig: "He indicates he'll yield."

Gordon: "I'm sorry, Representative Franks, did you say that for... when someone's arrested for domestic battery that they don't go in front of a judge?"

Franks: "No. No, I'm saying there's not always the bail hearing because it could be lower... it could be a lower charge. Or we have a very small incidence of domestic battery getting convictions because oftentimes it's pled down or the... the perpetrator has such power over the victim."

Gordon: "I... I understand that. But I just wanna make very clear that if someone is arrested for domestic battery, they are not able to bond out that same night. They must appear in front of a judge..."

Franks: "Correct."

Gordon: "...the next day."

Franks: "Correct."

Gordon: "Is that correct?"

Franks: "But this would have a paper trail of these 11 considerations that we would have, and it would show that one is charged with domestic battery. Because that would be one of the considerations should that individual be charged again in the future. And as you know, the recidivism rate is... is very dangerous. Because oftentimes when there's a repeat offender, it's much more violent than the first time. But what they found is when you get a conviction the first time and it's a misdemeanor, the second time, as you know, it becomes a felony. Oftentimes, the perpetrator get the... gets the message then, because if he's charged with a felony, loses his job among other things."

Gordon: "So, you're saying with these 11 individual items for... for the person... and in all instances, you know, the State's Attorneys office to look at during the bond hearing, you don't feel that what's currently in the statutes to take into consideration with setting bond is good enough for domestic battery cases. Is that right?"

Franks: "Correct. That's correct. And we have the support... I'm looking for my notes here. But we have the support of the State's Attorneys' organizations, of the Cook County State's Attorney, McHenry County Sheriff's Department, the State's Attorney Appellate Prosecutor, the Coalition Against Domestic Violence. All those organizations and others agree."

Gordon: "I understand you the support. But what you're saying with this Bill, it's going to spell out specific instances that maybe investigators are going to have to bring to the attention of the... of the State's Attorneys Office before the

bail hearing takes place. Is that correct? One of the things, I know, on that list is any mental health history of the defendant, correct?"

Franks: "Correct."

Gordon: "So, if... if you're not able to find that out before the bond hearing, the person bonds out, and then later on it's determined that that person does have a mental health history, violent or not violent, is someone at fault in that case? Is... I mean, how..."

Franks: "No, I think it's a checklist, and hopefully, they'd be able to find out... we're not looking for additional liability for someone who's doing their job."

Gordon: "Okay."

Franks: "I know you're doing this for legislative intent, obviously."

Gordon: "Yeah, I... I know. I just... I just wanna make sure that someone... that the intent of this Bill is to... to make sure that all circumstances are taken into consideration when... when bond is being discussed in front of the judge, correct?"

Franks: "Correct."

Gordon: "And that if something is... is not known at the time of the bond hearing, that... that later on is not going to come into play as someone who was not doing their job or is liable in some incidence or... or then, you know, becomes..."

And I looked into this and shame on me for not going far enough to come up with... with something that would pass a test and get the State's Attorneys' blessing. Believe me, until you have seen what has happened in a particularly violent domestic violence case where there are still very strong feelings between the once in-laws and now the person accused of the crime, this Bill makes eminent good sense. It addresses a situation that I wished we didn't have to address, but it's there. And to turn our back on it and pretend that it isn't is not doing due diligence at Legislators. I commend the Sponsor on the Bill. I urge an 'aye' vote."
