Currie: "Thank you, Speaker. Please let the record show that Representatives Acevedo, Delgado, Feigenholtz, Hamos, Jones, and Patterson are excused today."

Speaker Madigan: "Mr. Bost."

Bost: "Thank you, Mr. Speaker. Let the record reflect that Representative Daniels, Representative Mathias, and Representative Black are excused today."

Speaker Madigan: "The Clerk shall take the record. There being 109 people responding to the Attendance Roll Call, there is a quorum present. This Bill represents 14 months of bipartisan work to examine issues that relate to referenda in tax cap counties. It provides for a consolidated form of questions to be presented to the voters that build on the fundamentals of the tax cap, which is dollars, CPI, and voter empowerment. In essence, it's a truth in taxation Bill. It combines two Bills that came out of this chamber last year unanimously, House Bill 3602, which closed

loopholes in rate manipulations that some districts had take advantage of, and it also includes House Bill 1041, which equates all referendum to be presented to the voters and what it will cost for... for a hundred thousand dollar residence. We think that these... this new approach to referenda will make it easier for voters to understand exactly what's contained in the proposition and how much it And it will make it easier for taxing will cost them. districts to ask for smaller amounts of revenue for longer periods of time and fixing the loopholes that have existed since the inception of the tax cap that has allowed for over almost \$400 million more to be collected in some taxing districts than what was advertised in referendums. short, it makes good government policy to take the current form of propositions and equate it to the property tax cap law. And I think it'll be supported widely and unanimously through... through all the almost organizations. organizations that have agreed and have lended its supports: Illinois Manufacturing Association, the Illinois Association of County Clerks and Recorders, Illinois State Chamber, Illinois Federation of Teachers, the Management Alliance, SCOPE, LEND, ED-RED, the High School District Organization of Illinois, and the Large Unit District Association of Illinois. So, I would certainly entertain any questions that you may have."
