Now, if that has changed considerably since their last report, why wouldn't they, in the form of transparency and information, why wouldn't... why don't we have a sheet from them showing how much of the current \$2.8 billion in unissued bonds are in fact obligated and where they're obligated? I mean, I'm not comfortable on these kinds of issues when people are asking me to increase their bonding authority when they have almost \$3 billion in unissued bonds and then they tell you, 'Well, we've almost used those up.'"

And so, this is a part of the Bill that we believe that we can move forward on and that's why it's in front of us in this... in this manner today."

Black: "All right. Well, I... I know the individual that I talked with regarding that Amendment felt very strongly about it, and I... I was in agreement. I thought it was never the intent that those bonds become the obligation of the State of Illinois. But it's been removed, so I won't beat that issue over the head. Let me go back then to the original line of questioning. The only information that I can work off of is the last report issued by IFA. I haven't seen anything that would tell me how much of the 2.8 billion they've used up, where... where is it obligated, and what is it obligated for. And... and without that documentation, I'm not extremely comfortable saying, well, ya know, what the heck.

another 2, 3 billion dollars among friends? If... if, in fact, the Illinois Finance Authority has recently used up some of their bonding authority, why don't we have that information or why can't we get it? Where is it?"

Hannig: "Well, Representative, we know that historically there are a number of projects that are under review by the agency and that we know historically that about 70 percent of those projects are approved and 30 percent, obviously, are rejected. So we took the amount of money that's already in... we took the amount of projects that are in-House and applied the 70 percent of value towards those projects, added it to the amount that's already been authorized, and obviously they're basically out of money. So, we were able to calculate that if we authorize this additional amount of money, that this could get them to April 1 of next year. So, Representative, it's based on what's in-House and what we know has historically been the amount of money that they've needed."

Black: "Representative, I... I have worked with you for a long time and I have great respect for you. This Bill has some controversy attached to it. All I'm... all I would like is something from the agency that says, 'Here are the projects we've obligated in the last quarter or the last six months. Here is the current unobligated bond... bonding authority and we think by Labor Day, 2006, that'll be gone, and that's why we need the new appropriation.' As I said earlier, I'm not... I'm just not comfortable voting for a blind bond authority increase when I don't know how much of the 2.8 billion is obligated. And I don't even have a..."

He no longer understands that coalition at all and he's making a mockery in our state. I'll support the Lady's Resolution, I'm sure her local board needs it, but I think what the Governor's done to workforce development in the state is horrible."

Speaker Lyons, J.: "No one further seeking recognition, the Chair recognizes the Gentleman from Bond, Representative Ron Stephens."

Stephens: "I'm kinda having a flashback to a couple years ago and we had a... this Resolution kinda reminds me of a time when the Speaker put up a... an easel down front how much money we were wasting on a daily basis. I think he was using that to criticize the administration. Maybe he should reinstate that. I know that didn't come out of state funds and I'm asking you as the Speaker pro tem, I guess you are, could we use your campaign fund to reestablish that daily

In the opinion of the Chair, the 'ayes' have it. House Resolution 1067 is adopted. Mr. Clerk, on page 12 on the Order of Resolutions, Representative Barbara Flynn Currie has House Resolution 943. 943. The Chair recognizes the Lady from Cook, Leader Barbara Flynn Currie."

Currie: "Thank you, Speaker and Members of the House. We're all very enthused about the prospect of reducing our reliance upon foreign oil when we produce energy, and one of the things we are talking about enthusiastically possibility of wind farms. I'm as enthusiastic about that as anybody else in the chamber, but I think it's important before we install a lot more wind farms in Illinois to make sure we know that we're putting them where they're not going to interfere with bird nesting and seasonal migration areas. Iowa has done a good job of showing us how we can increase wind energy without causing damage to the ecological system. This measure, House Resolution 943, would ask the Department of Natural Resources, in conjunction with the Commerce Commission, to do a study of the possible effects of wind turbines and where they might be located so as not to create problems with... with birds and endangered species. I would

be happy to answer your questions and I'd appreciate your support for this measure."

Speaker Lyons, J.: "No one seeking recognition... the Chair recognizes the Gentleman from Vermilion, Representative Bill Black."

Black: "Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. It's not an easy task to rise in opposition to this rather general Resolution, but I... I'm probably much older than Majority Leader Currie and I've just seen things in my life. Folks, some of you need to read the paper. Gasoline is headed to \$3 a gallon, maybe three and quarter by Memorial Day. Electric rates will no doubt increase because of the cost of generating electricity continue to go up. And I don't think we've built a new electrical generating facility in this state for decades. We haven't expanded our oil refineries in this state for decades. Why? Because of things like this. We have to do a study. We have to make sure that the... the... what was the one that killed the reservoir in my district? The blue salamander or the wide-eyed chub or the horned toad or the tufted owl or God knows what. Study, study, study. every time you'd do a study, the implementation of new energy creation devices goes slower and slower and slower, and pretty soon those people just go to another state. I have no intention of trying to kill the Resolution, but some of you are gonna have to figure out on a cost benefit ratio what you wanna do. Do you want to find additional sources of energy and go after them aggressively or do you wait and wait and wait as we have done to create new electrical

generating facilities, new supplies of natural gas, new places to drill for oil, and, heaven forbid, new places to refine oil? We can't even get Bills out of the Rules Committee that would give people a sales tax incentive to buy a flexible fuel vehicle. We can't get Bills out of the Rules Committee that would give retailers an income tax credit to install ethanol 85 percent blend pumps, but we've got time to pass a Resolution that says before you put in any wind turbine electrical generating facilities, you have to study what impact it may have on birds. I can tell you what impact it's gonna have on birds. Some birds are gonna fly into 'em. And they aren't gonna win that battle. Some birds fly into the Hancock Building. Some birds fly into various skyscrapers in Chicago. Some birds get eaten by cats. Some birds may be carrying bird flu, but whatever. We... we tend to worry about energy prices when it's politically convenient to worry about energy prices, and yet we continue to delay, obfuscate, and make it literally impossible to do anything about the expansion of energy alternatives. And this Resolution, no matter how general, no matter how well-meaning, will have the ultimate impact that we delay and delay. And one of these days we're gonna look in the mirror and find out we've met the enemy as far as energy costs. And guess what? It's us."

Speaker Lyons, J.: "The Chair recognizes the Gentleman from Cook, Representative Terry Parke."

Parke: "Thank you, Mr. Speaker. To the Bill. Ladies... to the Bill... Resolution. I normally am in support of my colleague that just spoke, however, one must remember that we're

talking thousands of birds that die. And I'll remind the agricultural community of this state that birds are our best friend in the eating of insects that affect our crops. And I think if there's ways that we can come up with protecting these birds, not only for the aesthetic quality that they bring to our environment and to our lifestyles, it's that they also are really good in terms of keeping down the insect population. This is something I think is necessary. I support the Lady's Resolution and would ask the Body to pass this Resolution so we can take a look and find if there's any way to protect these birds. It's something that I think we have an obligation to do."

Speaker Lyons, J.: "The Chair recognizes the Gentleman from St. Clair, Representative Tom Holbrook."

Holbrook: "Thank you, Speaker. This Resolution doesn't stop any construction whatsoever. Many states have already done this and all they're looking at is for migratory patterns of the migratory waterfowl and wildlife. It'll just make us a little bit smarter on our feet when we locate these things around our state. We're not gonna stop 'em going in. All we're gonna do is put 'em maybe in a little better spot. Other states have done it. In fact, I believe Iowa, which is one of the largest wind farm states of all, has this same Resolution. I believe it's Iowa, I'm not absolutely positive. It is Iowa, yeah. But we went through this in committee and I'm going through my memory. So, I would hope everyone would support this. Thank you."

Speaker Lyons, J.: "Representative Currie to close."

No oil refinery has been built in the United States in the past 30 years and the United States is reliant now on imported supplies of refined petroleum products. The U.S. refining industry runs at nearly 100 percent capacity in order to keep up with the demand. House Resolution 843 creates an Oil Refinery Task Force, which is made up of 12 members. One member appointed by the director of Environmental Protection Agency, one from the Commerce and Economic Opportunity, one representing the interest of the petroleum industry, one representing the

state's petroleum marketers, two Members appointed by the President of the Senate, two by the Minority Leader of the Senate, two by the Speaker of the House of Representatives, and two by the Minority Leader of the House of Representatives. And the purpose of this task force is to study the lack of sufficient gasoline and diesel fuel refining capacity in Illinois. Provides that the task force shall make recommendations on ways to improve the condition of the oil refinery business in the State of Illinois."

Speaker Lyons, J.: "The Chair recognizes the Gentleman from McHenry, Representative Jack Franks."

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lyons, J.: "He indicates he will."

Franks: "Representative, what's the genesis of this Resolution?"
Meyer: "Well, I... I introduced it... quite honestly, I believe that
part of our problem here in the United States is the fact

that with the rise in gas prices is the fact that we need more oil refinery capacity. Quite honestly, I don't think the Federal Government has taken the lead on this. We in the State of Illinois, though, I believe, should be looking within our own state to see what our own capacity is. Oil refineries can be safe, they can be good neighbors. I've represented a district that had one in it and it was a good neighbor in that district, provided a lot of good-paying jobs. And it is away from the Gulf of Mexico, which is where we saw during Katrina the devastation that was caused there and the amount of oil refinery and its capacity was taken offline. I just think it's something we here in this state should be interested in and... and should be evaluated."

Franks: "Well, how much gasoline... or oil, I should say... how much oil was pumped from Illinois in the last fiscal year?"

Meyer: "How much was pumped?"

Franks: "Yeah. How much..."

Meyer: "You mean at the gas stations?"

Franks: "No, not... I don't mean at the gas stations. How much oil was taken from the ground in Illinois in the last fiscal year?"

Meyer: "You know, I don't have those figures, but the fact that we are in an area where oil is refined, in the Chicagoland area for instance, we have major... some major refineries up in that area. I don't have the capacity that was pumped here. I do know that south of Springfield, if you drive along you see oil pumps working. I suspect they are pumping at the same level that something out in the Gulf of Mexico is."

Franks: "Well, I guess my question is what are our reserves?

I'm sure geologists know what are reserves are, or an approximation."

Meyer: "I would say, Representative, that this is one of the things the task force should be looking at. Again, my concern is... is trying to make certain that we have the capacity, it's distributed around the United States, Illinois has played a role in that, good-paying jobs here... located here from it. And all these things that would help to focus on this issue, well, I think this task force would be involved with."

Franks: "I understand what your goal, but I'm reading what the Resolution does and that's not what it does. What I'm

reading is it says it studies the lack of sufficient gasoline in diesel fuel refining capacity."

Meyer: "That's right. That's quite right."

Franks: "Maybe... it sounds to me like it would need to be amended to answer the questions that we have, how much is our reserve... how much reserves we have, how much we've been pumped, and then maybe get to the refining issue. Because I'm wondering if we're putting the cart before the horse."

Meyer: "Well, again, most of the oil that is refined here in this state is not pumped here, it's brought in from other locales. For instance, the refinery in Lemont, Illinois, which happened to be in my old district, that's Venezuelan oil and that... that refinery's set up for sweet crude. Different refineries are set up to produce... to refine different types of oil. In other words, you couldn't take oil from the North Sea and refine it in that... in that facility because it's just not set up for it, it's set up for sweet crude. But again, those are things that this would take a look at."

Franks: "Do we need a task force for essentially... it sounds to me like it's more of a business decision. Has any... have you reached out to the businesses who used to refine and ask why they aren't refining in Illinois? Maybe they've got valid reasons for that."

Meyer: "Well, Representative, quite frank... quite honestly, there's been no refinery built in the entire country in the last 30 years."

Franks: "Well, I don't mean built, but you were saying they used to refine here in many locations and they stopped refining.

I'm wondering has anyone spoken to the… the business entities that previously refined to find out why they don't do it now here in Illinois instead of ordering a governmental task force."

Meyer: "Our... our problem is certainly further than Illinois.

Illinois is where, I think, we can control is in terms of what we look at. Refining capacity in the United States over the last 3... 30 years has declined, which is part of the problem. No new oil refineries are being built. Again, I think this refining... or this task force will be looking at the issue here in Illinois and what should we be doing here in Illinois for this. I think it's an economic issue that would benefit us."

Franks: "All right. Thank you."

Speaker Lyons, J.: "Representative Meyer to close."

Meyer: "All right."

Speaker Lyons, J.: "Representative Meyer, excuse me for a moment. Representative Black just put his light on. The Gentleman from Vermilion, Representative Bill Black."

Black: "Yeah, than... thank you very much, Mr. Speaker. And since there's no more lights, let me be very brief. I rise in strong support of the Resolution. In contrast to one earlier, read the Resolution. There hasn't been a new oil refinery built in this country in the last 30 years, and the reasons are, I think, as Representative Meyer has said it very clear, we study, we study, we study, we put restrictions, restrictions, restrictions. And, of course, nobody wants any refinery built or added on to if it's in their neighborhood. But we all want cheap gas. Well, we

can't have it both ways. We're finally learning that problem. And I think the Resolution simply is... is timely as gasoline continues to go up, crude oil closed at an all-time high price yesterday. I think the Gentleman has a timely and necessary Resolution and I hope you can all vote 'yes'."

Speaker Lyons, J.: "Representative Meyer to close."

Meyer: "No, Ladies and Gentlemen, you heard the debate. I believe that this is a necessary task force that should be implemented and I just ask for an 'aye' vote."

- Black: "Thank you, Mr. Speaker. I'd rather be discussing the budget, but this is what we have. So, will the Speaker... or will the Sponsor yield?"

Speaker Lyons, J.: "The Sponsor yields."

- Black: "Representative, is the Department of Health (sic-Healthcare) and Human Services opposed to the Resolution or have they come off of that and are now neutral? Or what's their position?"

- Black: "All right. Are you sure that there could be a misunderstanding in this administration? I... I just didn't think that ever happened."
- Feigenholtz: "I think you're setting me up here again, aren't ya?"

- Black: "...and tell people I voted for something that was suggested by BS. Who's BS? What do they do?"

- Feigenholtz: "And I think that they wanna help us do a better job at collecting data on birth outcomes. That's what I'm saying."
- Black: "Are they in Illinois con... firm or are they from out of state?"
- Feigenholtz: "I really..."
- Black: "I mean, I'm... seriously, I've never heard of Bull Services US. Are they from Illinois or from out of the state?"
- Feigenholtz: "I can't answer that, I don't know."
- Black: "All right. Well, I... I appreciate you answering the questions, Representative, as always. But I... I'm just fascinated. Maybe it just kind of sums up the whole Session that this good idea has come from BS Inc."
- Speaker Lyons, J.: "The Chair recognizes the Gentleman from Peoria, Representative David Leitch."
- Leitch: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. While we've been whiling away a lot of time on perhaps trivial issues, I would commend the Lady for this Resolution because it truly is one of the more important things that's come before the Body. Until we actually got a

data warehouse about 4 to 5 years ago for a portion of what was then public aid, we could not manage the \$10 billion Medicaid budget. Were we to look for fraud or do other investigations, the people at public aid would've had to have gone through individual hospital bills, doctor bills, pharmacy bills, and on and on and on. We had one of the worst systems in the United States, and with the advent of the data warehouse we quickly established ourselves in the country as having one of the very best systems in the United States. The purpose of this Resolution is to urge that the law that we passed last year be actually implemented. And let me tell you why that is so important. when we were creating the Department of Human Services, many us in this Body required that Governor Edgar not accomplish that by Executive Order. Instead, we wanted to have legislative input, oversight, and direction in that decision. To make a very long story short, many of us spent a lot of time on respective committees to implement the Department of Human Services. And it's important for the Members to know that one of the most primary reasons to make that consolidation of those agencies was to actually be able to provide one-stop service throughout the entire Human Services offices and other access points throughout the state. One-stop service, which means you could go into any place in the state where there were Human Services, pull up a screen, and understand, even use a common application form, and in a very efficient fashion be able to proceed to secure what you thought to... need to get for your family and so forth. That cannot be accomplished without a computer

That vision cannot be implemented without a data spine. We have the best data warehouse in the United warehouse. States. Our shortcoming is we are not expanding it enough. The most progressive and best functioning human service systems in our country, specifically in Michigan, New York, and Minnesota, have comparable systems to the one that we have to the extent that we have it, only in their states they have taken the system to include school records, public health records, virtually every kind of record that they have in the state so that they can access this information, make the decisions, be able to very efficiently manage the information that they have. We stunt that access to information by not aggressively moving forward to expand the data warehouse. In the first year that we had the data warehouse we saved a billion dollars in fraud, which is not my speculation but the number from the Inspector General at the Department of then Public Aid. We shortchanged ourselves of the economy. We shortchanged ourselves from access to information. We shortchanged ourselves from implementing a one-stop vision that was adopted so many years ago. So, I would strongly urge support for this Resolution and I compliment the Lady for bringing it to us. Thank you."

Speaker Lyons, J.: "The Lady from Cook, Representative Julie Hamos."

Hamos: "Thank you, Speaker. Ladies and Gentlemen, I also stand in strong support of this, especially in light of the fairly sarcastic remarks earlier. You know, I... we don't have a good sense of how data can help us, and actually in foreign

He and I have been working on this issue for the entire 8 years that I've been here. He worked on it even before then. And this is the approach to take and I urge an 'aye' vote."

Mulligan: "Thank you, Mr. Speaker. I, too, stand in support of this. You can look it up, and if Representative... one of the former Representatives who is concerned about this.
