But what it does is that right now there is two service people that have been killed in the line of duty and the state is holding their money in probate, even though they've requested the money going to a different member. So, this clears up some of that and it goes with the service member who has fallen last wishes to

get the money to the appropriate people. And I'd appreciate an 'aye' vote. Thank you."

Clerk Mahoney: "Senate Bill 3086, a Bill for an Act concerning government, which may be referred to as the Facility of Eminent Domain Act. Third Reading of this Senate Bill."

Speaker Hannig: "Representative Bradley."

Bradley, J.: "Thank you, Mr. Chairman... Mr. Speaker, Members of the House of Representatives. Ever since the Supreme Court case of Kelo, the people of the State of Illinois and of the United States have asked the deliberative Bodies of the different and various states to go back and reconsider and think about the concept of public takings, particularly in the context of takings from private landowners to other private individuals or groups. Over the last several months, beginning in the Senate with the efforts of Senator Garrett and Senator Cronin and others, a Bill came over attempting to deal with a certain aspect of eminent domain proceedings, namely blight. As a result of looking at that Bill, thinking about it and working on concepts, we now have an eminent domain Bill which deals with all aspects of eminent domain. We have taken all the different eminent domain or condemnation proceedings from throughout the statutes put them into one location, an eminent domain statute, for convenient... convenience and ease for people that are trying to work through these very complicated issues and we made substantive changes. Basically, we broke down the different takings into different categories of

takings. For instance: public to public, like for an airport, a railroad, a highway; public to private, with public ownership of private control; the taking of private land with private control but public ownership; public control but private ownership; the context of blight. then we created the default provision, which has the highest legal civil standard available to us in the State of Illinois, which says that a condemning authority that wants to condemn property under this default provision when none of the exceptions applies must do so with a clear and convincing evidentiary standard. In addition to that, we shifted the burden of proof to the condemning authorities. These are substantial wins for private landowners in the State of Illinois. In terms of changing valuation, we also increased the value of property that might be condemned in terms of additional potential attorney's fees, relocation costs, and changes to the valuation date which can be, in many cases, preferable to private landowners. This is a significant piece of legislation, which required the efforts of many, many people. I'm humbled to have been a part of that and I wanna express my sincere thanks to the Members of both caucuses, to the Members of both chambers, and to the various groups that are affected by this throughout the state in terms of creating a Bill, which helps private landowners but which the municipalities and others that have been opposed to the Bill indicated was livable. Having said that, I will open the floor then... to answer whatever questions that might come up. And I would ask for an 'aye'

vote on this important piece of legislation to swing the pendulum back in favor of the private individual landowner."

Speaker Hannig: "The Gentleman has moved for the passage of Senate Bill 3086. And on that question, the Gentleman from Madison, Representative Beiser."

Beiser: "Thank you, Mr. Speaker and Members of the House. Will the Sponsor yield?"

Speaker Hannig: "He indicates he'll yield."

Beiser: "I'd like to thank Representative Bradley for bringing this forward and I know for a fact the many hours that he and many others put into this, but I do have a question. In Section (c) of the Bill, general references are made to the eminent domain procedures conducted after the ICC's grant of a certificate. Is it the intention of the Bill that the reference to certificates created under the Public Utilities Act include certificates issued under all portions of that Public Utilities Act including the common carriers by pipeline law?"

Bradley, J.: "Yes."

Beiser: "Thank you very much. Thank you, Mr. Speaker."

Speaker Hannig: "Representative Parke."

Parke: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hannig: "Indicates he'll yield."

Parke: "Representative, this is a Bill that all of us have gotten a lot of correspondence from, especially from our municipal government. And they've brought up concern and I have, in some of my towns, have brought up concern that the effective date will interfere with some projects they have. Can you tell us the effective date of this legislation?"

Bradley, J.: "We spent about two weeks... the effective date is January 1, 2007. We spent the better part of the last two and half weeks negotiating with the groups that you're concerned about, and I didn't wanna do anything in terms of grandfathering or dealing with that. But we did put that in the Bill and there is a grandfather provision for certain TIF districts as of April the 15th, 2006. We did push the effective date back to 2007 at their request. So, to my knowledge... to the extent we could without undermining what we wanted to do, which was strengthen individual property owners' rights to the extent we could, we accommodated the municipalities to the extent possible. And that's why I think that they've backed off in terms of their strident opposition to this Bill."

Parke: "So… well, last night I was lobbied by a local… local community in opposition to this Bill. And so, I… what I'd like to know is have you found that there's been a real compromise with municipal government and the City of Chicago to the degree that maybe they don't like conceptually but…"

Bradley, J.: "Yes."

Parke: "...in principle they understand what we're doing here?"

Bradley, J.: "Yes. What I told them was we're gonna do something, so it's my opinion that you should work with us to try to get it in a manner that you can live with. And that's what I think we've done."

Parke: "All right. To the Bill. Ladies and Gentlemen of the House, I think that this is a major piece of legislation. I believe that all of you should pay attention to make sure you know how you're gonna vote on this Bill. But I will

remind this Body and the people of Illinois and of the United States that the reason, one of the major reasons that this country was formed was under the basis of private ownership of property. And I rise in strong support of the Gentleman's legislation. I think that we'll find this passed overwhelmingly in all 50 chambers in the United States because people want the ability to negotiate in good faith for their property that they own and that they have for themselves and the future of their families. I think it will make it up more difficult for municipal government to move forward projects that might relate to eminent domain and what is in the common good of the general public. But ultimately, we must protect individual property owners. I commend the Sponsor of this legislation, this is what it does, and I rise in strong support of the Gentleman's legislation."

Speaker Hannig: "Representative Nekritz."

Nekritz: "Thank you, Mr. Speaker. Representative, you and I spent a lot of hours discussing this piece of legislation and I commend you for the work that you've done, and I was delighted to be a part of that process. I just have one question that's... that's come up since all that discussion. You mentioned in your opening remarks the highest standard..."

Bradley, J.: "Yeah."

Nekritz: "...the clear and convincing standard that has to be met in certain circumstances."

Bradley, J.: "Yeah."

Nekritz: "Can you... can you described what situation that might occur in?"

Bradley, J.: "Well, there's... there's... as you know, Representative, there's four exceptions carved out in the Bill. There's the truly public for public with highways, airports, railroads, et cetera. Then you get into these other contexts where you go into blight which would be one of the exceptions would be preponderance. Then you get into other exceptions in terms of the Starbucks Coffee that's in the county hospital, the Avis Rent A Car that's in the... in an airport. Ya know, we don't wanna have to put those at necessarily at a higher standard than what would be necessary on a truly public taking. And then if something doesn't fall into one of those four categories of exceptions then there's just a default provision, which would be the clear and convincing standard, and that would apply to private takings for other private development."

Nekritz: "So what..."

Bradley, J.: "It's in the context when you can't proceed under one of the other exceptions. It's a catchall."

Nekritz: "Okay. And... and any of the... any of the... if someone were condemning pursuant to a redevelopment ordinance, a TIF district, an industrial park... one of the industrial park ordinances and so forth, which stand... standard would they be under?"

Bradley, J.: "Well, they... they could avail themself of any of the exceptions would apply, but I would assume they would probably go under the blight exception. And that would be for new ones coming on, not for existing ones as we hashed out over the last two and a half weeks."

Nekritz: "Right. Right. Right. Okay."

Bradley, J.: "Yeah."

Nekritz: "Thank you very much. Ladies and Gentlemen..."

Bradley, J.: "Thank you for your help."

Nekritz: "...this is a good compromise. The City of Chicago and many of the municipal groups were engaged in very lengthy dis... discussions on this and did come to an accommodation and something that they consider to be livable. And I'd like to thank the Sponsor for... for making those accommodations. And with regard to the effective date on this, the effective date was moved back because this is a 400-piece... 400-page piece of legislation. It's gonna take everyone awhile to absorb it and understand it. So, if there are some technical changes and so forth, we will have an opportunity to come back and look at that again before it goes into effect. So, I urge an 'aye' vote."

Speaker Hannig: "So this is on Standard Debate. We've had three speak in favor: Representatives Bradley, Parke, and Nekritz. One in response. Representative Black, would you like to speak in response?"

Black: "I don't have a clue, Mr. Speaker. I just wanted to ask the Sponsor some questions."

Speaker Hannig: "That would be in response."

Black: "Okay."

Speaker Hannig: "The Lady will... the Gentleman will yield."

Black: "Fine. Thank you very much. Representative, the… the Bill that started all of this controversy… the Supreme Court… Hello? Hello? They not only stole the chandeliers, they're trying to steal the microphones. Whatever. The Supreme Court case <u>Kelo v. New London, Connecticut</u> would

really have had little, if any, impact in Illinois, the way Illinois case law reads, correct?"

Bradley, J.: "Well, we don't know for sure. And there's...
there's no assurance that... SWIDA was the law of the land in
Illinois and the Kelo case said it did not restrict the
states from going back and putting further restrictions on
eminent domain."

Black: "Okay. All right."

Bradley, J.: "And we don't know for sure, Representative, that the Kelo case wouldn't have been held differently here in Illinois."

Black: "All right."

Bradley, J.: "And so, I think that was... that was part of it."

Black: "Do you see, as I possibly do, some irony in the fact that we rolled out a eminent domain Bill so if... if a municipality doesn't like its water company it can condemn it and buy it? And now here we're doing an eminent domain Bill that says, well, wait a minute, let's be real careful here."

Bradley, J.: "Yeah."

Black: "I... maybe the water company was owned by... it was a foreign-owned company, so maybe that's different."

Bradley, J.: "Well..."

Black: "But I... some of the things we do here... on one day we'll do something and then the other... and I'm not criticizing you... the next day we come back and we do something that appears to me just the opposite. But I... I just wanna thank you for the work you've done. Mr. Speaker, if you'll permit me the... an opportunity to speak to the Bill. The..."

Speaker Hannig: "Proceed."

Black: "I just want to commend the Sponsor, first and foremost, for working with the proponents and the opponents in a calm and reasonable matter... manner. That's not always happened this year and we appreciate his outreach to Republican staff so that we can be aware and our staff can be made aware of what's going on with legislation. As corny as that sounds, she is the only one there for me whenever I need her. Even though she had her own stuff to deal with, there seriously is no better person that I know', in lieu of impending Mother's Day. His brother, Anthony, 'I lost my wingman, my drinking brother. I wanted more for him. He could've been so much more after he had came back.' We go through our proceedings day in and day out and we have some very vigorous debates about all types of issues. But this young man sacrificed something that I have never... have not done, my father has not done, and I pray my children will not do, but in the name... for all of us here in this esteemed Body. Today he's being buried in Abraham Lincoln National Cemetery today. And I just wanted to say to everybody, regardless as if you believe in the war or not, regardless if you believe what can be said and what isn't, I believe and his family believes that God loves him, God loves us, God loves America and all the struggles and everything that this young man has believed in and tried to accomplish in his short life.
