Clerk Bolin: "Senate Bill 1305, a Bill for an Act concerning government. Third Reading of this Senate Bill."

Speaker Lyons: "Representative Elaine Nekritz."

Nekritz: "Thank you, Mr. Speaker. Senate Bill 1305 is a pretty substantial piece of legislation. It's got a lot of components to it. So I will run through those. As we are all too well aware in recent years the news has been filled with stories about investment advisors and consultants taking advantage of their relationships with those working with the state pensions, to take large referral fees and otherwise benefit financially from the state pensions. Senate Bill 1305 started life as a pension reform Bill to address these ethical concerns. The legislation is comprehensive in this regard and includes provisions that require all the pension board members to file statements of economic interest. Currently, many of the large city and

county pension funds don't do this at all. It restricts contracts with bond companies that use consultants for the purpose of retaining bond business in the state. Ιt requires quantifiable goals for emerging fund managers. Ιt prohibits a fiduciary from engaging in an investment where fiduciary stands to gain financially from requires competitive procurement Ιt investment consultants and it expands the Gift Ban Act for board members of pension and retirement funds and prohibits contingent fees for investment advice. In addition to these provisions, Senate Bill 1305 now includes a number of other ethics and good government measures. They include the of Bill 1 language House that was sponsored Representative Fritchey that passed overwhelmingly in this House, regarding the pay-to-play campaign contributions. Includes the provisions of Senate Bill 157 that I sponsored giving expanded oversite to the Executive Ethics Commission and includes the provisions of House Bill 742, the Whistle Blower Act that has passed both Houses, that was sponsored here by Representative Hamos. There have been concerns raised about some of the provisions of Senate Bill 1305 regarding one of the changes to Pension Code that's specifically is Section 1-110. We'd just like to state that for purposes of legislative intent, this Section is only intended to apply where the fiduciary and the investment advisor are two (2) separate people or entities. It's not intended to cover all investment advisors. Self-dealing by investment advisors and fiduciaries is already prohibited

under another portion of the existing law. I'm ready to answer any questions and I ask for your support."

Speaker Lyons: "Chair recognizes Gentleman from Cook, Representative John Fritchey."

Fritchey: "Thank you, Speaker. Will Sponsor yield?"

Speaker Lyons: "She indicates she will."

Fritchey: "Representative, as you indicated and which I sincerely appreciate, this legislation has, I believe, verbatim the language from House Bill 1. Is that correct?"

Nekritz: "I'm sorry. Yes, it is verbatim from House Bill 1."

Fritchey: "Have you by any chance, and I'm not asking this factiously, have you talked to anybody over in the Senate as far as the prospects of this legislation?"

Nekritz: "I have had numerous conversations with the Senate Sponsor, Senator Schoenberg. And he has every intention of calling the Bill. And I know he is working with Leadership to see if that could happen."

Fritchey: "Well, I don't question for a second Senator Schoenberg's intentions but as you, I think, are aware and as Members of this Body maybe, the Senate President over there has already essentially hijacked and stalled House Bill 1. He took another one of Senator Schoenberg's Bill's, he took an initiative of Treasurer Giannoulias, wrapped all of those together and could not get that Bill out of a committee. My concern is what we have here is a conglomeration of a number of laudable and worthwhile and necessary ideas for the State of Illinois. I would believe that this legislation can and should receive the same vote as House Bill 1 did, which is a unanimous vote. And I think

it's just very frustrating that the will, the unanimous will of the House of Representatives, the overwhelming demand of the people of the State of Illinois, is being singlehandedly thwarted in the State Senate. Fritchey has said ethics Representative about the provisions. However, there's... some pension language that many downstate pension administrators have some concerns with. And I'm going to make sure that that, if in fact I'm reading it correctly, it's my understanding that all the municipal funds, which includes over one thousand (1,000) downstate police and fire funds, puts them into the Illinois Procurement Code. They feel that it's completely unworkable for municipalities to comply with that code. And in the Municipal Code it puts it in conflict with their own procurement provisions. I'm wondering if you, number one, if share that concern. Number two, if you do, could we do a trailer Bill on that particular issue if necessary?"

"Representative, I have had a lot… number discussions with some of those downstate pensions on this very issue, and there seemed to be some conflicting Our staff felt that with the Article 3 and Article 4 pensions were not covered by the Procurement Code under this legislation, except they must procure their investment advisor in a manner substantially similar to the Procurement Code, but it doesn't ... it was our staff's feeling or belief that it did not subject them to the entire Procurement Code. The opinion that you're talking about, it was my understanding that that was coming from someone the Department of Professional and Financial within Regulation or whatever the name of that entity is now. And because of that conflict, we approached the Attorney General's Office about this. They took a look at it and agreed that they did not think that the Article 3 and 4

pensions would be subject to the entire Procurement Code as the… in the way that this is currently drafted."

Black: "Okay."

Nekritz: "It's not their practice to issue written opinions on pending legislation, but they've indicated that if this legislation becomes law they will be happy to issue such an opinion."

Black: "Okay, I appreciate your response and unfortunately, late... particularly late, we're in overtime Session, the underlying ethics provisions make this a very difficult Bill to vote against and I don't intend to vote against it. However, I believe you're a Legislator of great integrity. If we do get into some serious problems with municipal retirement funds, I would... I would think you would be willing to sit down with them and correct whatever mistake may be made. I'm not saying that there is a mistake being made but there is a perception that perhaps we're putting municipal retirement funds under a system that would be very difficult if not impossible for them to comply with. If that is the case then I look forward to working with you on correcting that issue."

Nekritz: "Certainly, Representative, and I... and having... again having many discussions with the Senate Sponsor about this very issue, I don't believe it's... it was his intention or my intention to subject them to the entire Procurement Code."

Black: "Okay."

Nekritz: "We have conflicting opinions. I believe the lawyers are saying 'no' and someone at DPFR or whatever that... again

whatever the acronym is, is saying 'yes' and I believe that, I guess, I would trust the lawyers on that one."

Black: "My, you're in a very wonderful mood today, you're going to trust the lawyers on that one? Okay."

Nekritz: "And certainly, Representative..."

Speaker Lyons: "Go ahead, Representative Black, finish your thoughts."

Black: "If we do run into a law of unintended consequences, I look forward to working with you and addressing concerns that municipalities may have. Thank you very much, Representative."

Speaker Lyons: "The Gentleman from Cook, Representative David Miller."

Miller: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lyons: "She indicates she will."

Miller: "On our analysis it says and I'll quote it, 'when the lowest responsible... and responsible bidder's not chosen in competitive bidding an explanation must appear in a Illinois procurement bulletin.' I think that's important. What's circumstance would that be?"

Nekritz: "Representative, I'm... can you... can you ask that again?

I'm not sure I got... that I followed all that."

Miller: "The... essentially there will be an announcement if a lowest... if the lowest bidder was not chosen in a competitive sealed bid. An explanation of why that person was chosen would appear in a bulletin and I asked why... what would that explanation sort of consist of?"

I don't know what it might consist of because it would depend of the circumstance of why the lowest responsible bidder was not selected and I... there could be a myriad of reasons I think that that could occur. - Miller: "Well, it happens and I think part of all this reform measures is to try to explain why a lowest bidder may not be chosen. Could it be because of a minority or women-owned business requirements? Would that be part of it?"
- Nekritz: "I guess it could be, potentially, Representative, and...

 but... and this legislation also contains some expansion of
 those requirements with regard to the procurement of
 investment advisors and so forth. So, I think we're trying
 to strengthen those things in this legislation, as well."
- Miller: "Okay. When you said 'trying to strengthen', could you repeat that?"
- Nekritz: "I believe... unfortunately, this legislation is a hundred and twenty-five (125) pages long, so I can't always keep everything in my mind... but I believe that there are some... there are requirements for the pension... under the... under the expansion of this procurement... procurement... responsibility to the pensions, that the pensions have to set some goals for minority and women-owned businesses that don't currently exist in the law. - Nekritz: "Representative, if I could just respond. I think that that is the part of the goal of that provision is to allow firms that may not be, you know, the Goldman and Sachs of the world of the or JP Morgan Chases of the world to compete and to get awarded some of these contracts."
- Miller: "That's... that's what I wanted to hear. Last question is dealing with the higher education chief procurement. Why is that... why was that changed, dealing with the Higher Board of Ed?"
- Nekritz: "Representative..."
- Speaker Lyons: "Representative Miller, we'll give you another minute and Elaine can respond to that question."
- Miller: "Thank you. She can just respond and I'll close on that."
