- Speaker Turner: "Seeing no questions, the question is, 'Shall the House pass Senate Bill 363?' All those in favor should vote 'aye'; all those opposed vote 'no'. The voting is now open. Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question, there are 108 voting 'aye', 0 noes', 0 'presents'. Biggins: "Well, thank you, Mr. Speaker. Question of the Chair, I guess. If... these days we've been doing things every day they're called Special Session days. Now, I was wondering over these days why they're called Special Session days. Now tomorrow, it appears that we're doing a major piece of legislation. Will that make tomorrow an extra special day?"

Speaker Turner: "With lights."

Biggins: "Oh. Well, I'll look forward to that. Thank you."

Speaker Turner: "The Gentleman from Vermilion, for what reason do you rise?"

Black: "Mr. Speaker, an inquiry of the Chair."

Speaker Turner: "State your inquiry."

Black: "Has the Electric Deregulation Bill, whatever that is since nobody on our side of the aisle has seen it, has it been posted? It hasn't even been filed yet."

Speaker Turner: "As we speak, the final version is being completed right now. It will be posted today."

Black: "Then you need to... then you need to waive the posting requirement. You're not gonna have 24 hours. I assume you're gonna hear it at 1:00 tomorrow in committee."

And you know, I'm sick and tired of coming down here, driving 2 hours and 15 minutes, spending eight, nine, ten dollars (\$8, \$9, \$10) a day for gasoline to come here and we do absolutely nothing unless you all are ready to include us in whatever surprise you have for us tomorrow. My motherin-law is 95 years old, in the hospital, had a stroke. my spouse is the sole caregiver. I don't need to be down here. Now, I don't know what surprise you have in store for the ratepayers tomorrow. They got the shaft 10 years ago. You might as well finish it tomorrow, but at least be honest and tell them and tell the media this isn't any rate reduction, this isn't any solid money in their pocket. What are they gonna save, eight bucks a month? Hell, I hope everybody in my car... in my district goes out and buys a new car with your benevolent Bill that you've kept from us and worked once again in secret. Congratulations."

Speaker Turner: "The Gentleman from Bond, Representative Stephens, for what reason do you rise?"

Stephens: "I don't know why the Gentleman from Danville is so upset. Representative, the Leaders of the Democratic Party from Chicago in the House and the Senate, the Attorney General, all Democrats from Chicago have joined with the utility leaders who obviously have our best interest at heart. I'm sure that the people of Danville have the utmost
