- Speaker Madigan: "You've all heard the Lady's Motion. Is there leave? Leave is granted, and the posting requirements are suspended for Senate Bills 77, 198, and 381. Chair recognizes Mr. Black for the purpose of a Motion. Mr. Black, there is a Motion filed to table House Bill 4122."
