Speaker Madigan: "The regular Session shall come to order. Is there leave to use the Attendance Roll Call of the First Special Session for this Session? Leave is granted. Mr. Clerk. Representative Currie for a Motion."

Currie: "Thank You, Speaker. I move to suspend the posting requirements so that Senate Bills 48, 198, and 381 may be heard in the Executive Committee and Senate Bill 77 in the Revenue Committee."

Speaker Madigan: "You've all heard the Lady's Motion. Is there leave? Leave is granted for the purpose of the suspension of the posting requirements. On page 11 of the Calendar, on the Order of Senate Bills-Second Reading, there appears Senate Bill 1400, Mr. John Bradley. Mr. Clerk, what is the status of the Bill?"

Clerk Mahoney: "Senate Bill 1400 has been read a second time, previously. Amendment #1 was adopted in committee. Further Amendment #4, offered by Representative John Bradley, has been approved for consideration."

Speaker Madigan: "Mr. Bradley, on the Amendment."

Bradley J.: "This basically does a couple of TIF extensions and an annexation extension. Normally, we get to this stuff in November or January, but since we're here we thought we'd go ahead and try to knock it out."

Speaker Madigan: "The Gentleman moves for the adoption of the Amendment. Those in favor say 'aye'; those opposed say 'no'. The 'ayes' have it. The Amendment is adopted. Are there any further Amendments?"

Clerk Mahoney: "No further Amendments, no Motions filed."

Speaker Madigan: "Put the Bill on the Order of Third Reading and read the Bill for a third time."

Clerk Mahoney: "Senate Bill 1400, a Bill for an Act concerning revenue. Third Reading of this Senate Bill."

Speaker Madigan: "Mr. Bradley."

Bradley J.: "As I said, a couple of TIF extensions, an annexation extension. I know of no opposition to the Bill. I'd ask for an 'aye' vote."

Speaker Madigan: "The Gentleman moves for the passage of the Bill. There being no discussion, the question is, 'Shall this Bill pass?' Those in favor signify by voting 'yes'; those opposed by voting 'no'. Have all voted who wish? The Clerk shall take the record. On this question, there are 96 people voting 'yes', 1 person voting 'no'. This Bill, having received a Supermajority vote, is hereby declared passed. Mr. Clerk."

Clerk Mahoney: "Two committees have been canceled for today. The Revenue Committee and Executive Committee have both been canceled for today. The Disparities in Education Achievement Special Committee will meet immediately following the Republican Caucus, immediately following the caucus."

Speaker Madigan: "Representative May."

May: "Thank you, Mr. Speaker. One of the pleasures of being in Springfield in the summertime in Special Session is to celebrate the birthdays of summer special people.
