- Clerk Mahonev: "Representative Barbara Flynn Chairperson from the Committee on Rules, to which the following legislative measures and/or Joint Action Motions were referred, action taken on August 07, 2007, reported the same back with the following recommendation/s: approved for floor consideration, recommends 'be adopted' Amendment #2 to Senate Bill 770. Representative Barbara Flynn Currie, Chairperson from the Committee on Rules, to which the following legislative measures and/or Joint Action Motions were referred, action taken on August 07, 2007, reported the same back with the following recommendation/s: approved for floor consideration, recommends 'be adopted' Amendment #2 to Senate Bill 689."
- Speaker Turner: "Page 9 of the calendar, on Second Readings we have Senate Bill 689. Read the Bill Mr. Clerk."
- Clerk Mahoney: "Senate Bill 689 has been read a second time, previously. No Committee Amendments. Floor Amendments 1 and 2 have both been approved for consideration."
- Speaker Turner: "The Gentleman from White, Representative Phelps, on Amendment #1."
- Phelps: "Thank you, Mr. Speaker, and Ladies and Gentlemen of the House. This is just a technical Amendment. I'd like to ask for its adoption."

- Speaker Turner: "The Lady from Cook, Representative Krause, for what reason do you rise?"

Speaker Turner: "The Lady from Kane, Representative Chapa LaVia, for what reason do you rise?"

Chapa LaVia: "Point of personal privilege."

Speaker Turner: "State your point."

Chapa LaVia: "I'd like the General Assembly to acknowledge these two wonderful men in front of me. Mr. O'Brian and Mr. Mautino, give a hug. It's their birthdays today, so everybody give a round welcome. Happy birthday guys. First time they've ever been in Session together so..."

Speaker Turner: "The Gentleman from Williamson, Representative Bradley, for what reason do you rise?"

Bradley, J.: "Point of personal privilege."

Speaker Turner: "State your point."

Bradley, J.: "Mr. Speaker, it's August 7, 2007. Electric rates increased on January 1, 2007. Now maybe that legislation wasn't everything that everybody wanted, but it was something, and it provided relief to people. And the bottom line is, regardless of whatever kind of deadline or politics are going on, our people still do not have relief. Seven months later and people still do not have relief, they need it now. This is not over until they get relief. It's August 7, lets get it done."

Speaker Turner: "The Gentleman from McLean, Representative Brady, for what reason do you rise?"

Brady: "Thank you very much Mr. Speaker. I see where we can purchase our former House chairs. And I see also on this that we're to contact Polly O'Brien regarding this. My seatmate, Roger Eddy, has graciously donated his pickup truck, and my thought was if you could check for us that if

each Member could come up with gas money, is there any reason why Ms. O'Brien cannot drive around the State of Illinois delivering these chairs? Can you just check on it for us?"

Speaker Turner: "We'll get back to you on that."

Brady: "Thank you. Thank you, Mr. Speaker."

Speaker Turner: "We're checking to the cd... we're checking her CDLs. The Lady from Cook, Representative Mulligan, for what reason do you rise?"

Mulligan: "Thank you, Mr. Speaker. Although I mentioned the Representative's name so that he may speak again, he obviously has wonderful things to say, I do not know why Representative Bradley suddenly thinks that the Governor will become a rational human being that does things that he ought to do. At this point, I would think at this point he would absolutely understand that whatever the Governor does is to obtain the most publicity he can, and for that matter probably not do what he thinks he should do or what would be rational. But I think that Representative Bradley ought to know that by now, he's been here long enough, and that perhaps he'll understand that. Even jogging him is giving the guy publicity. Black: "Mr. Speaker, just to add my voice of support to the Gentleman from Marion, the honorable Representative Bradley. I share his concern, I find it shocking, shocking, that the Governor has not taken action. Do you

But I'm sure he will in due time, in due time, in due time."

- Speaker Turner: "Page 10 of the calendar, Second Readings, we have Senate Bill 770, Representative Moffitt. Read the Bill Mr. Clerk."
- Clerk Mahoney: "Senate Bill 770 has been read a second time, previously. Amendment #1 was adopted in committee. Floor Amendment #2, offered by Representative Moffitt, has been approved for consideration."

- Moffitt: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. This goes back to the original Bill. It's a transfer of 2 parts..."

- Moffitt: "I move to table Amendment #1."
- Speaker Turner: "That's correct. The Gentleman asks leave to table Amendment #1. All those in favor say 'aye'; opposed say 'no'. In the opinion of the Chair the 'ayes' have it, Amendment #1 is tabled. Mr. Clerk, further Amendments."

- Speaker Turner: "Just a minute. Representative Krause, on Floor Amendment #1."
- Krause: "Well if I could just on the underlining Bill, which is on Second Reading, it amends the Municipal Code and provides that the corporate authorities of a municipality may take up to ten years rather than one year to repay a loan from a bank. It's an initiative of the Illinois Municipal League. Mr. Phelps can proceed with Amendment 1."
- Speaker Turner: "The Gentleman from White, Representative Phelps, on Amendment #1."
- Phelps: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I'd still like to ask for the adoption of Amendment #1. It just clarifies the Bill. It's a technical Amendment and I ask for its adoption."
- Speaker Turner: "The Gentleman asks leave to adopt. The Gen... sorry, the Gen... the question is, 'Shall the House adopt Floor Amendment #1 to Senate Bill 689?' All in those in favor say 'aye'; all those opposed say 'no'. In the opinion of the Chair the 'ayes' have. And Amendment #1 is adopted. Further Amendments?"
- Clerk Mahoney: "Floor Amendment #2, offered by Representative Hannig, has been approved for consideration."

Speaker Turner: "The Gentlemen from Montgomery, Representative Hannig, on Amendment #2."

Hannig: "Yes, thank you, Mr. Speaker and Members of the House. This is very similar to a Bill that we passed earlier in the Assembly. It deals with the Springfield medical district. Number it changes the name. Number two, it provides that a number of counties that surround Sangamon County would be a part of this group. Number three, it gives the Governor two additional appointments and suggests... or demands that he make the appointments from the outlying area. So I worked with Representative Brauer and Representative Poe and they're in agreement with this, and so I move for the adoption."

Speaker Turner: "The Gentleman from Vermilion, Representative Black, for what reason do you rise?"

Black: "Thank you, Mr. Speaker. Will the Sponsor of the Amendment yield?"

Speaker Turner: "Indicates he will."

Black: "Representative, why... why is it necessary to give the Governor two more appointments?"

Hannig: "Well Representative, in the effort to try to work with the district here in Springfield, and to expand it into the areas that are outside of Springfield, and give him an opportunity to appoint some members from outside of that area, we felt that is was... that the best way to do it is simply give him two more appointments. So what it boils down to is my area is one of those areas, Representative Watson's is one of those areas, we would like to see someone from these... outside of Sangamon County appointed,

and we think that that would be quicker than to simply wait for some..."

Black: "All right."

Hannig: "... of these other appointments to expire."

Black: "How many counties do you envision being included in this Springfield medical district?"

Hannig: "It's not a... first of all let me point out it's not a taxing district, and it will have no authority to tax..."

Black: "Well, I understand that."

Hannig: "But it would add... it would add... okay, it would add five counties I'm advised."

Black: "So what... correct me if I'm wrong. But I thought when we started it the Springfield medical district was basically the City of Springfield and Sangamon County. What... was it expanded or did I just... do I not recall the original Bill correctly?"

Hannig: "Yes Representative, the district... for example, the area that I live in to a large degree, if we go to a local hospital, and we're in need of a specialist, usually we're told to either go to Springfield or St. Louis. So what his would do is to say that it would recognize that the Springfield area serves a number of these counties outside of Sangamon County and consequently try to... try to bring us into this medical district. So what we're asking is that the district, that we include a number of these counties that are normally served by the Springfield medical district."

Black: "Okay."

Hannig: "...and that they get an appointment."

Black: "So you're actually changing the name to the, from what staff tells me, to the Mid Illinois Medical District, correct?"

Hannig: "That's correct. It would be a more of a regional approach."

Black: "Okay."

Hannig: "That's correct."

Black: "And then were giving the Governor two more appointees to this. The five counties don't go anywhere near Cook right?"

Hannig: "They all touch Sangamon County I believe, or very close to Sangamon County."

Black: "I find it somewhat amusing that the Governor will get two more appointments to a Mid Illinois Medical district, five Counties around Springfield. Does he know some people in the Springfield area?"

Hannig: "Well Representative, I'm going to send him some names..."

Black: "Ah, well..."

Hannig: "...and probably Representative Watson..."

Black: "All right."

Hannig: "... will probably send him some names, and Senator Demuzio will send him some names."

Black: "You're going to call him some names?"

Hannig: "No."

Black: "Or you're send him some names by calling him?"

Hannig: "We will give him some recommendations and advise him as to what we..."

Black: "I see. So..."

- Hannig: "... would think are good appointments and then he will make a decision."
- Black: "Yes. Well then that begins to make sense because I... I thought it was on almost a contradiction of terms that the governor would appointment somebody to a district that basically exists in the City of Springfield. So you're going to give him some names and Representative Watson will give him some names, just as an aside, just between you and I off the record. Does the Governor listen to your recommendations?"

Hannig: "I hope so Representative."

- Black: "All right, well could you see me afterward and tell me how you get that done? I could use a pointer or two. And I appreciate your indulgence. Thank you."
- Speaker Turner: "Seeing no further questions, the question is, 'Shall the House adopt Floor Amendment #2 to Senate Bill 689? All those in favor say 'aye'; all those opposed say 'no'. In the opinion of the Chair the 'ayes' have it. And the Amendment is Adopted. Any further Amendments?"

What you're borrowing and the concept of needing cash for a short term project is one thing, but to allow municipalities to engage in borrowing for up to ten years, which would that theoretically not just obligate the municipality but future administrations of that municipality, is a very different shift, no?"

Krause: "I don't think so. This is patterned after the authority we gave to the townships in the past. And I think the Amendment establishes and addresses the concerns that you have raised."

Fritchey: "I understand that, but it may well be in... it may be in the municipalities consistent with that of the townships, but it's a pretty significant shift though, I think. Now would the municipalities have to go... they would still be obligated under whatever restrictions they have, as far as getting the authority from their voters, correct?"

Krause: "That is correct, and it's a discretionary and gives them flexibility, but that is correct."

Fritchey: "Okay. Thank you, thank you for your answers."

Speaker Turner: "The Gentleman from Vermilion, Representative Black, for what reason do you rise?"

Black: "Yes. Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Black: "What a novel idea for the State of Illinois to follow.

What an outstanding... could we just amend the Bill on its face to include the State of Illinois in this?"

Krause: "I'm all in favor."

Black: "Thank you."

Speaker Turner: "Seeing no further questions, the question is, 'Shall the House pass Senate Bill 689?" All those in favor
