Pritchard: "Thank you, Mr. Speaker. Ladies and Gentlemen of the House, there has been a program for the last few years in the State Board of Education where they've had grants to assist schools in aligning their curriculum with state standards. It's very critical that districts are teaching the important lessons that they'll be tested on so they can see if they're meeting the No Child Left Behind requirements. These grants have been funded by the State Board of Education. And a year ago they had placed in the budget as a separate line item a request for 1.4 million dollars (\$1,400,000) to... to a provide these grants. As the budget moved through the process this line item was dropped and the board only continued the grants at a very small level this last year. This Bill would allocate that 1.4 billion... million dollars (\$1,400,000) to help provide

grants across the state so that districts can align their curricula with state standards, teach students appropriately the things they need to know and be able to do, and therefore when they're tested be able to pass and do the kind of work that they're capable of doing. I will ask for your support in this Bill. Thank you."

Speaker Hannig: "This is on the Order of Short Debate. Does anyone stand in response? Representative Franks."

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hannig: "Indicates he'll yield."

Franks: "Representative, is this Bill basically to restore funds that have been cut by the Governor's office to the regional office of... to the... I think there's twenty-two (22) regional offices of superintendent. Is that what this is about?"

Pritchard: "So this... the grant funding is allocated through the regional offices of education, yes. The dollars were not appropriated in the full appropriate amount this last year as the budget was adopted. Therefore they weren't able to allocate them. And I think it was more a process of the budget negotiation than something that the Governor had removed. At least that's my understanding."

Franks: "What do they do with this money and why do they need an additional seven hundred thousand dollars (\$700,000)?"

Pritchard: "There are a number of school districts that have multiple sections and classes and different teachers that deal with a particular subject that's a part of our state standards. They don't often have an opportunity to collaborate to make sure that all of those sections and all

of that... those courses are aligned exactly with the classroom. And I've got one district in particular that has found this very helpful and has aloud that type of calibration and that type of alignment that was not possible before and their students are doing much better as a result of that."

Franks: "I'm concerned though about the efficiency of this. If we have twenty-two (22) separate regional superintendents woul... I'm sorry forty-five (45). Wouldn't it be easier to do it through the Illinois State Board of Education and have one uniform policy, if you're trying to align curricula? Because it seems to me there could be duplication of efforts here with, you know, forty-five (45) different regions that would be splitting approximately seven hundred thousand dollars (\$700,000) additional."

Pritchard: "Well, there wouldn't be duplication because the state board has designated that the ROEs would be that administering of the grants to make sure the go to the most needy or the most able to take advantage and... and benefit from this. There is, though, you know, a need for this type of alignment to make sure that those classes are being taught appropriately and I think it's been demonstrated through the history of this program that it does produce the desired results."

Franks: "Okay. Thank you. I want to... if anyone else has a question I'll listen, but thank you for your answers."

Pritchard: "Thank you."

Speaker Hannig: "Representative Eddy."

Eddy: "Thank you, Mr. Speaker. To the Bill. Representative, I strongly support this simply because of the fact that it has proven to be such a good program. The reason the additional appropriation is needed is because the program is expanding from a small number of schools where a pilot occurred and success was shown. This is work done by a Dr. Richard Stiggans and it's very well accepted in educational circles as one of the premiere programs in school improvement. So last year during the budget negotiations the expansion money was taken out. This is an opportunity to include it so that the program can be expanded and actually it's pretty efficient program. It's a train the trainer program where teachers... teams of teachers get trained, come back to the building, and train additional... So, I would strongly support the appropriation. Hopefully, it's something we can expand on in future years. you."

Speaker Hannig: "Representative Pritchard to close."

Pritchard: "Ladies and Gentlemen, this appropriation would definitely be the front-line delivery of educational services and help our students achieve to the level that they're capable. I would ask for your support."

Clerk Mahoney: "House Bill 4588, a Bill for an Act concerning elections. Third Reading of this House Bill."

Speaker Hannig: "Representative Flider."

Flider: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. This Bill just simply allows municipal officers, who are members of electoral boards, to conduct their hearings at the location where the governing body regularly meets. So, for example, in the city council chambers instead of at the county court house. And this law is already in effect for townships and we just like it also to apply for municipal electoral boards, and ask for your support."

Speaker Hannig: "This is on Short Debate. Does anyone stand in response? Then the question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this question, there are 105 voting 'yes', and 0 voting 'no'. And this Bill, having received the Constitutional Majority, is hereby declared passed. Representative Currie, you're recognized on House Bill 4590. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 4590, a Bill for an Act concerning State Government. Third Reading of this House Bill."

Speaker Hannig: "Representative Currie."

Currie: "Thank you, Speaker and Members of the House. This measure deals with the ... with the problem that Illinois foster care rates are not meeting the standards set by national organization. So by the year 2012, sometime down the road, this measure would require that the state meet those standards, which would require some increases in foster care rates, but those... those numbers come from the University of Maryland, some important social service groups and they do define what it cost to take care of a child at various ages and stages of that child's life. The standards do not include everything. They don't include, for example, the cost of transporting a child to see other relatives or to go to medical care, but it does offer what you might call a Chevrolet standard of living for foster care children. And I would be happy to answer your questions and I think that it is important that we give our foster parents the wherewithal they need to do the job our foster children need doing for them."

Like I said, this the inequality is that under the first Bill that we passed that a transfer from police to IMRF there was... it only allowed them to transfer whatever the cost equaled to in terms. So it didn't give them the full service benefit if they wanted to pay the difference, it does not allow that. So that's what this does. Be happy to answer any questions. It comes to me from a constituent in Metamora, Illinois, Mr. Jim Underwood, who with many of his colleagues from the greatest generation have long wondered why we don't have such a plate. I would suggest this would be a very important thing to do since so many of the World War II veterans, especially are aging and won't be with us for much longer. So, I would ask for your support."

Leitch: "Thank you very much, Mr. Speaker, Ladies and Gentlemen of the House. About six (6) or eight (8) years ago the State closed down the Hanna City work camp, located outside Hanna City, Illinois, six (6) miles from the Peoria County jail. The Peoria County Sheriff is very interested in securing this thirty-five (35) acre tract for a series of uses, not the least of which is to deal with jail overcrowding, as well as potentially develop some beds for incarcerated individuals who are suffering mental illness. It's a very exciting program that's being developed in the community and I would ask for your support."

Speaker Hannig: "This is on the Order of Short Debate. Does anyone stand in response? The Lady from Cook, Representative Hamos."

Hamos: "Will the Sponsor yield?"

Speaker Hannig: "Indicates he'll yield."

Hamos: "Are you proposing to sell it to Peoria County or what is the mode of conveyance here? What is this?"

Leitch: "At the moment, the Department of Corrections either has or is in the process of acquiring this as surplus property."

Hamos: "I'm sorry, the Department of Corrections is what?"

Leitch: "I believe this property is been declared surplus property."

Hamos: "Oh. It's been abandoned as surplus property?"

Leitch: "I'm not sure technically where it stands in that process, but it is the Department of Corrections signed in in committee in favor of this Bill."

Hamos: "But... so is it... again, I think my question was are we selling this land, are we giving it away, or the property this land with a building. Are we giving it away?"

Leitch: "Well, there... Let me say that the structures that are on this are in various states of extreme disrepair because of their disuse for the last six (6) or eight (8) years. This is also the case, while the state had invested some money in the sanitation system and so forth, all that has deteriorated. The good buildings that are there have asbestos. So we are in the process of working with the Department of Corrections to transfer the property to Peoria County so that this property can be restored to productive use. There is a provision that were this not to be used for public purpose, it would be returned to the State."

Hamos: "Well, I think that's what I was looking for, Representative Leitch, is some kind of limitations on this because the last time I looked you're one of the people who always points out that our state budget is in kind of tenuous position, and I was wondering why we giving land away instead of trying to sell it. And secondly, what limits there would be put on this property so that Peoria County couldn't just decide to sell it for a condo

development. Or thirdly, whether you were going to come back to the Legislature to get state funding to restore and rehab this for some other use. I... it just... none of this seems to be really spelled out."

Leitch: "Well, it's clearly spelled out because of the reversion clause that's in the Bill. And secondarily, you're one of the persons in this House that allegedly is very interested in mental health reform and in our jails, especially throughout Illinois and the correction system we have got to do a better job of taking care of mentally ill people who don't belong going in jails."

Hamos: "Well, you were… you were doing great…"

Leitch: "Out of the eighteen thousand (18,000) bookings in Peoria County, our sheriff will tell you that at least 30 percent of those individuals should not be in jail. Our state's attorney will tell you that 30 percent of the customers that he has don't belong in the criminal justice system, they belong in a community treatment center. We are working very hard with the county, the sheriff, the state's attorney, and other community members to create a comprehensive system in our community that extends from the judicial system, to the police chief, to the sheriff, to the jail, to the whole system and deal perhaps as a model one day for the rest of the state in having a very effective system."

Hamos: "Well, I... I... that's why I wanted to stand to ask those questions, because I did now find on page 9, I did find some language that the land reverts to the State. And you were doing great with that answer until you said I was

allegedly interested in mental health. I did pick that up. Thank you."

Leitch: "Thank you."

Speaker Hannig: "Representative Franks."

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hannig: "Indicates he'll yield."

Franks: "Representative, could you tell us again what's this land going to be used for by Peoria County?"

Leitch: "I'm sorry, Sir, I didn't hear your question."

Franks: "What will the land be used for by Peoria County once they receive it?"

Leitch: "The land right now is in a very poor condition. There are some facilities that had been used at the Hanna City work camp. Those two (2) are in great disrepair. To specifically answer your question, what the County of Peoria wants to do is to have this property so that over time it can address overcrowding and mental health issues in the criminal justice system."

Franks: "It will be for public use."

Leitch: "Yes."

Franks: "It won't be for private..."

Leitch: "Absolutely."

Franks: "...they won't be selling it."

Leitch: "Absolutely not."

Franks: "Well, I... I stand in favor of your Bill. We had a very similar issue in McHenry County and you helped me on it. At that time we had a fish hatchery, which Department of Natural Resources could no longer uphold, because it cost them too much for the fish hatchery. So, we passed a Bill

here that allowed the local municipality, Spring Grove, to get that fish hatchery. Because if taxpayers have already paid for it..."

Leitch: "Right."

Franks: "...there's no reason for them to have to pay for it twice. This is basically an intergovernmental loan, because if they don't follow up with what they promised then it reverts back to the State. So, I don't believe, and the previous speaker was talking about the State receiving money, I think that would be improper since the taxpayers have already paid for it and it's remaining to be a public use. So, I wish you very... I wish Peoria County well on this endeavor."

Leitch: "Thank you very much."

Speaker Hannig: "Representative Fritchey. Representative Fritchey."

Fritchey: "After the Bill. I'll wait."

Speaker Hannig: "Okay. Any further discussion? Then the question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this question, there are 104 voting 'yes', and 0 voting 'no'. Clerk Mahoney: "House Bill 4664, a Bill for Act making appropriations. Third Reading of this House Bill."

Speaker Hannig: "Representative Leitch."

Leitch: "Thank you very much, Mr. Speaker. In our community we hundred and sixty have about one million dollar (\$160,000,000) Peoria river front program that is in the course of being developed and funded. Of that amount, over fifty million (50,000,000) of it is a Caterpillar Visitor Center. The bulk of the funds for this will be matched and raised privately. It's my hope that we can secure funding through the same fund that has for many years funded the museums in Chicago. And to that end I have introduced this Bill. I might also add that I had a conversation with Larry Suffredin this week and in the Senate it's my intent to hold this Bill as well for other projects that might be helpful to other parts of the State. So I would ask that you help me send this Bill to the Senate. Thank you."

Franks: "Representative, our analysis indicates that this Bill will appropriate twelve million dollars (\$12,000,000) from

- Leitch: "Well, it's actually through the… yeah, ultimately that's the case and I would… you're… probably your next question is where's the money. Well, this would anticipate hopefully, at some point a capital Bill. But at the… My goal in doing this was to get this out now so that there where… it was in the hunt if you will. And to secure other museum interests around the state so that we might have a critical mass of vision to accomplish it."
- Franks: "How much of the twelve million (12,000,000) would go towards a new Lakeview Museum in Peoria?"
- Leitch: "The entire twelve (12) out of about a hundred and thirty to a hundred and forty million dollar (\$130,000,000 \$140,000,000) project."
- Franks: "Okay. I just... thank you, it's in the Bill. I just wanted to make sure that we understood that this was a twelve million dollar (\$12,000,000) appropriation for a museum in Peoria. So, thank you."

- Bost: "Thank you, Mr. Speaker. We just need to make the record... have the record reflect that Representative Sacia is now excused for the day."

- Clerk Mahoney: "House Bill 4727, a Bill for an Act concerning education. Third Reading of this House Bill."

- Reitz: "Thank you, Mr. Speaker. House Bill 4727 amends the School Code. This simply changes the term from a school term to grading period to allow for more flexibility for school districts to charge tuition if someone does happen to move out of the district during the school year. And I'd be happy to answer any questions."
- Speaker Hannig: "This is on the Order of Short Debate. Does anyone stand in response? Representative Monique Davis."
- Davis, M.: "Thank you, Mr. Chairman... Mr. Speaker. My I ask will the Sponsor yield?"

Davis, M.: "Say for example, most school districts' grading periods are every ten (10) weeks. So are you saying that the say the first ten (10) weeks the student is in a particular school and the next ten (10) weeks you find that the school… the student has moved or his or her residence has changed, so is it that… during that second period they have to move or pay tuition?"

Reitz: "They don't..."

Davis, M.: "They have to transfer."

Reitz: "...have to move. They would have already moved. They would of... They can either transfer or pay... or pay tuition. That's correct. It simply allows the flexibility to the school district to ask those people to pay tuition if they've moved and they're not transferring to another district."

Davis, M.: "How do you know they've moved? How do you know that their residency has changed?"

Reitz: "We haven't changed any of that. It's up to the school district, whatever means they use to determine if someone has moved or does not live in a district. That all stays the same. The only thing we're doing is allowing them to use the grading period instead of waiting the entire year before they can make a change."

Davis, M.: "Well... to the Bill, Mr. Speaker. In all due respect to the Sponsor and I do know the problem that he's attempting to alleviate. I believe it will be disruptive to two (2) schools. It'll be disruptive for the school

where the student is being forced to leave and it'll be disruptive to the school who must take in a new student during the middle or the second or third grading period. Now, I think the current practice of having student be allowed to remain until the end of a school year was so that we could protect the stability of a classroom and the stability of enrollment in a school. Now I know there are many districts that are having problems with people coming in living... because of family situations, because of divorce a child may live with one parent for awhile and then have to stay with another parent for a certain period of time. Because of working situations a child may have to stay with grandma during the day because mother doesn't get home from work at night. And I know the speaker, the Legislator has very excellent intentions and I may be the only 'no', but I think this is not a good piece of legislation. I think the Legislators in this Body need to really think out how to deal with residency issues in the State of Illinois. do we deal with residency issues. A lot of mistakes will be made. A lot of families will be hurt. education of children will be disrupted through no fault of their own. A teacher in a classroom will find, I thought I had thirty (30) children, I have prepared for thirty (30). Now I have two (2) new ones and it's just the tenth week of school. It is not a wise move at this time. I urge a 'no' vote."

Speaker Hannig: "Any further discussion? Representative Eddy."

Eddy: "Ladies and Gentlemen of the House, I strongly support

the Representative's Bill. It will provide for school

districts the flexibility they need locally to address an issue that's become a problem, when someone moves into a school district simply to establish residency and then leave. Right now the law allows them to stay one day and then move out of the district, but that district then becomes responsible for that nonresident student for the rest of the school term. What Representative... what the Representative's language does is allow the school, it doesn't require them, it allows them on an individual basis, to look at the situation and after a residency hearing, which can be held, they may or may not be able to It doesn't automatically send them out. all the due process that they have always been entitled to. Clerk Mahoney: "House Bill 5511, a Bill for an Act concerning regulations. Third Reading of this House Bill."

Speaker Hannig: "Representative Fritchey."

Fritchey: "Thank you, Speaker. I've been informed that the Gentleman to my left may know a little bit about this issue. So in the deference to the Body I would like to turn it over to Representative Miller to discuss the Bill. Thank you."

Speaker Hannig: "Representative Miller."

Miller: "Thank you, Mr. Speaker, Ladies and Gentlemen of the Today, I present House Bill 5511 it essentially House. does three (3) things and I would ask for a favorable vote. Davis, M.: "Thank you, Mr. Chairman. House Resolution 669 is a Resolution that urges the state and local law enforcement agencies to share information. They already provide this data for the Federal Government and we're asking them to provide it for the Illinois officials once a year. imposes absolutely no substantial additional administrative cost and it helps Illinois to qualify for federal criminal justice funds and that's what we're attempting to seek. The Resolution asks that the State will receive from local law enforcement agencies the total number of civilians killed by police officers, the race and ethnicity of the officer, the race and ethnicity and gender and age of the victim, and the method by which the victim was killed. This data is already collected and reported and, we as a state, if we require it, we can capture a grant from the Federal Government on the criminal justice issues. And I ask for your support."

Speaker Hannig: "The Lady moves for the adoption of House Resolution 669. Is there any discussion? Then all in favor of the Resolution say 'aye'; opposed 'nay'. The

The General Assembly is required to convene a commission to prepare a objective report as to the pros or cons of a Constitutional Convention. The Constitution provides for us putting together this committee and for the composition of the committee. This is really more a procedural matter than anything else. This is not anybody taking a position on, the question of a Constitutional Convention, but simply us fulfilling our obligation under the Constitution to give voters information on the question. Thank you."

Speaker Hannig: "The Gentleman moves for the adoption of the Resolution and on that question, the Gentleman from Crawford, Representative Eddy."

Eddy: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Hannig: "Indicates he'll yield."

Eddy: "Representative, I have a question about the April 4 date in the Resolution. Do you feel like that, that date that's listed is something that's realistic, that's possible, if you take a look at the language of it?"

Fritchey: "Representative, that's an excellent question. I... I wish I had an answer as good as the question. I imagine every effort will be made to get something prepared. My personal opinion, I think that may be a tough day for us to

Research right now funding for research is inadequate. Scientists do believe a cure, if properly researched and funded, can be found within a decade. We're just asking for a modest increase in food allergy funding. And this
