passes. On page 17 of the Calendar, on the Order of Third Readings, we have House Bill 4190. Read the Bill, Mr. Clerk. Representative Hannig."

- Clerk Mahoney: "House Bill 4190, a Bill for an Act concerning public aid. Third Reading of this House Bill."
- Hanniq: "Yes. Thank you, Mr. Speaker and Members of the House. This was a Bill that was given to me by our colleague, Representative Watson, before he departed for his service in Iraq, and it's identical to a Bill that he had passed last year by a unanimous vote of the House. The Bill would provide for a 10 percent increase... the Bill would provide for a 10 percent increase in the rates that the State of Illinois pays to sheltered care clients. They have not had a rate increase for a number of years. My records indicate that a... it's been several years since they've last had a rate increase. The total impact of the proposal, if we would enact it, is less than a quarter of a million dollars (\$250,000). So, it's a rate increase for those people who provide services from sheltered care. It's a 10 percent increase, and it's an effort to try to provide some additional moneys for these facilities. I'd be happy to answer any questions and I'd ask for your 'yes' vote."
- Speaker Turner: "The Gentleman from Bond, Representative Stephens, for what reason do you rise?"
- Stephens: "Thank you, Mr. Speaker. To the Bill to... to thank Representative Hannig for carrying this piece of legislation. If the... if the Body would just pay a little bit of attention to the Bill. It's a Watson-Hannig Bill, and I would remind the Body that Jim Watson is in Iraq.

For those of you who... who wish, if we could just bring a moment of... of attention to Representative Watson as he... He's about eight (8) hours ahead of us so it's... the sun is setting in Iraq, and Jim Watson is on guard, and we appreciate each and every one of your efforts to help him with his package of legislation in his absence, to fill in for him in committee, we appreciate that. And I would invite each and every one of you if you have a moment a day when... that you can spare, if you want to contact me, we can set you up for office hours in Jim's district. If you want to come and visit any of the cities in his district or his district office and pay respects to what he's doing in that manner, we will certainly assist you with that. And again, my... my thanks to Representative Hannig for carrying this Bill."

Speaker Turner: "Seeing no further questions, the question is, 'Shall the House pass House Bill 4190?' All those in favor should vote 'aye'; all those opposed vote 'no'. The voting is now open. Have all voted who wish? Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question, 108 voting 'aye', 0 'no', 1 'present'. And this Bill, having received the Constitutional Majority, is hereby declared passed. On the Order of Third Readings, we have House Bill 4130, Representative Dugan. Read the Bill, Mr. Clerk."

Clerk Mahoney: "House Bill 4130, a Bill for an Act making reappropriations. Third Reading of this House Bill."

Dugan: "Thank you, Speaker. House Bill 4130 addresses an issue that we continue to address. And it reappropriates the

hundred and fifty million (150,000,000) for the school construction grants from the FY02 year. We did, of course, as many remember at the end of last Session did a supplemental to appropriate the hundred and fifty million (150,000,000). Unfortunately, because of paperwork glitches, by the time the Governor signed it, the schools were not able to receive their money. So, I'm just asking for this Bill to again reappropriate the hundred and fifty million (150,000,000). As we know, as a state we've owed these schools since 2002. Certainly be happy to answer any questions, but I would like an 'aye' vote. We passed this from the House before and I would just like to continue to pass it on to get it to the Governor."

Speaker Turner: "The Gentleman from Crawford, Representative Eddy, for what reason do you rise?"

"Thank you, Mr. Speaker. I rise in support of the Eddy: legislation. These school districts, as everyone in here knows, have been waiting now for several years to complete projects for which they were sent letters of entitlement by the State of Illinois. We don't have to look very far actually to... to find one of these. Rochester, Illinois, has been waiting. I have a district (sic-school) in my legislative district at Stewardson-Strasburg that has been waiting, and the fact of the matter is this is a tarnish and a shame on the State of Illinois. The fact that for going on six (6) years now this state could not keep a promise to the school children of these communities, and I appreciate the Representative's work on this. We've worked together. I think last year this Body sent the Governor a

piece of legislation that quite frankly he found a way not to fund, rather than looking for a way to do the right thing and fund these districts. Hopefully by starting early in the process and this Body showing that they have the same concern and the same priority for these school districts now as they did last year when we passed this appropriation, the Governor will get the message and whatever... whatever technicalities that... that he came up with last year regarding paperwork supposedly that schools were not turning in on time, there'll be plenty of time for all that paperwork to be turned in so the Governor will not again be able to come up with some lame excuse for not keeping the promise to the school children of these communities. Thank you."

Speaker Turner: "The Gentleman from DeKalb, Representative Pritchard, for what reason do you rise?"

Pritchard: "Yes. Would the Sponsor yield, please?"

Speaker Turner: "She indicates she will."

Pritchard: "Representative, I know you have been very passionate on this issue and you've been working with the Governor's Office. Do you have any assurance that if we pass this appropriation, the Governor will, in fact, release the funding?"

Dugan: "Representative, the only thing that... that I can go by is a statement that the Governor made in September of 2007 when we passed the original supplemental. And unfortunately because of paperwork, he said it wasn't able to be accomplished. And in September of 2007 after that Bill and that communication process broke down, the

Governor said he would support a Bill that gives a hundred and fifty million dollars (\$150,000,000) to schools for long awaited construction grants as long as it isn't loaded down with other spending, his office said, and so therefore this Bill is only about the hundred and fifty million dollars (\$150,000,000). That was a quote from the Governor's Office in September. So we're giving back to him the Bill that strictly just has in it the hundred and fifty million dollars (\$150,000,000). I would assume he'll live up to his word and the quote that he made in September."

Pritchard: "Well, he... Representative, if you have an intent to go see the Governor, I would be happy to go with you and see if we can deliver that kind of message and see if we can extract some kind of follow-through to this issue. It is an important issue that I think has affected a number of districts. My district used the authorization, one it had with a local referendum, added the classroom spaces that it desperately needed five (5) years ago. And it's had to borrow money, paying higher interest charges because the state didn't follow through with its share of this agreement. I heartily support this Bill and urge all of you to support it as well."

Speaker Turner: "The Gentleman from Cook, Representative McCarthy, for what reason do you rise?"

McCarthy: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Turner: "Indicates he will."

McCarthy: "Representative, same old question. Is this for FY09 or is this a... an addendum to FY08?"

Dugan: "This is FY08."

McCarthy: "So your hope would be that this could be distributed out of the current budget?"

Dugan: "Correct."

McCarthy: "And do you know if there's been revenue that is available for that distribution?"

Dugan: "Again, I'm just going by the statement made by the Governor that if we gave him a Bill for this hundred and fifty million (150,000,000) that he would support it. And I also take into account some of the statements made by the Governor in the last couple of weeks of money that he was able to come up with, so I would believe that, therefore, the Governor knows that there is money available to pay these schools that have been waiting since 2002."

McCarthy: "So you're assuming that if we pass this Bill and the Senate passes this Bill, he will be able to fund it this year. Will that put us another hundred and fifty million dollars (\$150,000,000) in the hole as far as the budget deficit that we already have for this year or anticipated budget deficit?"

Dugan: "I don't believe so, Representative. Of course, again, I'm just going by some of the statements made by the Governor himself that said we had money available for other things out of this fiscal year. So I'm assuming whatever would need to be done, whether it be bonding or what it would be to come up with this hundred and fifty million (150,000,000). I'm assuming it's there since the Governor did have other things that he was going to release funding for this fiscal year."

McCarthy: "Okay. And do you have a Senate Sponsor already picked out for this?"

Dugan: "I'm going to be talking to Senator Halvorson, who carried it last year."

McCarthy: "Okay. Senator Halvorson?"

Dugan: "Carried it last year."

McCarthy: "Okay. Well, she has the... she has the ear of the Senate President, so hopefully it would be carried over there as well."

Dugan: "Well... And I'm assuming because, of course, as you know two of the schools on this particular list include two (2) schools in Senator Halvorson's district and mine, and she's been very supportive in the past few years when we've tried to get it passed."

McCarthy: "Okay. Thank you."

Speaker Turner: "The Gentleman from McHenry, Representative Franks, for what reason do you rise?"

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?

Looks like she's going to yield. I... I appreciate you adding me as a cosponsor. This is an important piece of legislation. My question... You... you had just mentioned that there's a list of schools that would be getting the money.

My question is specific to the Loop Lab School, would the Loop Lab School be getting... Did they get their million dollars (\$1,000,000) out of this pile of money or is that a separate pile of money where they got their funds?"

Dugan: "I think that's a separate pile of money, Representative."

Franks: "Are there any funding that go in here for where the Governor would have his own discretion for schools on any of these?"

Dugan: "No, this particular piece of legislation clearly spells out which schools it has to go to."

Franks: "Okay. Thank you very much."

Dugan: "You're welcome."

Speaker Turner: "The Gentleman from Rock Island, Representative Boland, for what reason do you rise?"

"Thank you, Mr. Speaker. I rise in strong support of Boland: this Bill. One of the school districts in... that is on the top twenty-three (23) that should be getting funds and that has not for the last five (5) years is the Silvis School District and they have waited and waited and waited. Governor has come there. He's promised them their money. They still have not gotten it. We need to do something. I really appreciate the... the Sponsor, Representative Dugan, for sponsoring this Bill, and I'm glad to be a cosponsor and strong supporter of it. We need to send the Governor message that, you know, school construction... the Particularly when these schools are needed, they're new or they're in need of big repair. We cannot wait five (5) years and we cannot be held hostage to photo opportunities. We need the cash and we need the cash now. So with that, I hope everyone will give their 'aye' vote to this legislation. Thank you."
