I heard from constituents with Hannah Montana tickets that they couldn't get them, they were sold out within minutes. So this would prevent that from happening and give consumers a chance to get the tickets."

Speaker Hannig: "Is there any discussion? Then the question is, 'Shall... excuse me. The Gentleman from Cook, Representative Fritchey."

May: "The software cuts in line, it sort of overrides the Ticketmaster site so that they can bump in line and grab lots of these tickets. What happened with Hannah Montana

Fritchey: "Only... did Amendment 4 become the Bill?"

May: "Yes. No, no, no, no, no, no. Amendment 3 and 4 were withdrawn."

Fritchey: "So the Bill is then what... is it... Amendment 2 amends the Bill or Amendment 2 becomes the Bill?"

May: "Amendment 2 I think just amends it. Amendment 2 amends
Amendment #1, but the basic introduced Bill is the same.

Three and 4 were the Amendments that altered it
drastically, were offered by Representative Saviano and he
withdrew them."

Fritchey: "And what happens if an individual is using this software without realizing it? So somebody's trying to buy tickets from their home and they're doing it off a site that violates this?"

May: "I don't think they would... I don't think they would use it without realizing it. They would have to buy the software."

Fritchey: "Do you see that there's a problem with the fact that this may be... you may have either an out-of-town purchaser buying tickets through an in-town site or vice versa? How do you see us regulating these transactions online? Where's the cause for action here?"

May: "Would be reporting."

Fritchey: "No, no, no. From a jurisdictional issue, if I... if you are... if I'm sitting in Milwaukee and I'm using this software to buy tickets for a concert in Chicago, have I

- committed a violation? I'm not subject to Illinois's law then, correct?"
- May: "You're correct. It would have to be an Illinois person."
- Fritchey: "And if I'm in Chicago and I'm going through a server that's out-of-state, AOL... a lot of AOL servers are in Virginia."
- May: "But the action would be taking place in Illinois. This...
 you're right. This would apply to Illinois people,
 Illinois action."
- Fritchey: "So... so it would prohibit Illinois residents from using the software but not out-of-state residents from using the software."
- May: "Well if... you know, it wouldn't be an individual resident, this would be a company. Let's make that very clear."
- Fritchey: "No. That's not what you said before. You said if an individual uses the software they're liable."
- May: "But I... just clarifying that it would be a company. I don't know the cost of this software, but I don't think that individuals own this software. This was... you know, this instance..."
- Fritchey: "But if a company is using it, and I'm just trying to make sure that we understand what we're doing here, because if a company is using this software and the company is not located in Illinois, they can continue to use the software. To use your Hannah Montana example, they can continue to use this software, buy up all the tickets that they want for an Illinois concert, Illinois residents would not be able to do the same thing. The company that did it would not be liable under this law, so all we've done then is

"Thank you, Mr. Speaker. House Bill 2748... just a second please... is the Mercedes McCully Law. Mercedes McCully was murdered by her ex-boyfriend while leaving church on April 6, 2008. He was an ex-felon on parole and was being prosecuted for domestic battery of Mercedes late last year. This Bill requires the parolees to notify their parole agents within twenty-four (24) hours of service of an order of protection and requires the Department of Corrections to issue parole violation warrants if the parole (sic-parolee) is charged with a new domestic violence crime including domestic battery, aggravated domestic battery, stalking, aggravated stalking, violation of an order of protection or any offense requiring sex offender registration. Under this law, after a new charge for these crimes, a parole violation warrant would be issued, removing the guess work, holding abusers accountable and making victims safer."

Speaker Hannig: "The Lady has moved for the passage of House Bill 2748. Is there any discussion? The Gentleman from DuPage, Representative Reboletti."

Reboletti: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Hannig: "She indicates she'll yield."

Reboletti: "Representative, I know that we had talked about this legislation and I'm going to vote for the legislation, but could you tell the House way you had to file this piece of legislation, what occurred?"

"Yes, I will reiterate what I said earlier. Young lady Howard: by the name of Mercedes McCully was murdered by her exboyfriend while leaving church. The current law with the Department of Corrections says that the Department of Corrections is required to issue a parole violation warrant if a parolee commits a felony with a knife or firearm or does not register as a sex offender. Arrest for all... the offenders are then taken back into custony... custody, that is. Arrests for all other new charges of parolees are decided on a case by case basis. This would require the parolees to have notified their parole agents within twenty-four (24) hours of service of an order protection. So that we're trying to protect those individuals who have filed an order of protection or asked for an order of protection to be filed to benefit their safety."

Reboletti: "Representative, I appreciate you bringing this piece of legislation. I had talked to the Department of Corrections regarding the death of this young lady and I know that you have other legislation that I'd like to join you on and add me as a cosponsor on this one because the Department of... the parole agent made a mistake, a very grave mistake and that lady lost her life because a warrant should have been issued. And hopefully this measure will

save lives so we don't have this repeat itself. So I thank you for bringing the measure."

Speaker Hannig: "The Gentleman from Cook, Representative Fritchey."

Fritchey: "Thank you, Sponsor. To the Bill. Just real quickly. Ladies and Gentlemen, this is an excellent Bill. This is how we get at the issues of women who are attacked when we've seen the warning signs and ignored them. All too often when we're trying to deal with how to punish these people, how to punish the offenders after the fact, what we really need to try to do is protect the victims beforehand. This Bill gets directly at that. I commend the Sponsor for bringing this. And I urge an 'aye' vote. Thank you."

Sullivan: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House Bill 4548 extends a tax increment financing House. district in the City of Libertyville... town of Libertyville up in Lake County. This is a unique TIF extension up to twelve (12) years, in that the city is not asking for all the money back. So for the first time since I've been here, we have a TIF extension where a majority of the money that's going to be raised will be allocated back to the respective districts through a process already... already implemented. They're looking for about 30 percent of the money over the twelve (12) years and they will give back 70 percent that will go to the schools and other taxing Over the life of this extension, one of the bodies. schools is going to receive above and beyond what they would have, up to two million dollars (\$2,000,000). this is a unique way of doing a TIF. And I urge an 'aye' vote."

Speaker Hannig: "Is there any discussion? Then the question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Speaker Hannig: "Representative Smith."

"Thank you, Mr. Speaker, Ladies and Gentlemen. an initiative of the National Board Professional Standards for teachers and also an initiative of the Business Round Table. And the intention is to correct changes made to the certification that would adversely affect those teachers who seek National Board Certification. And it's also intended to get 10 to 20 percent of Illinois teachers to be National certified. The groups hope that making teachers part of the report card will help make administrators and parents take interest in their certification. We amended it last week on a... with a technical nature on the effective date to be January 1, 2009. Fritchey: "Thank you, Speaker. I rise on a point of personal privilege. Ladies and Gentlemen, we all have the honor from time to time to have our students from our districts come down here to visit us. I'm honored and I hope you all will be, too, to have some of the students from Lincoln Park High School, one of the fine high schools in my district, up in the gallery. Right now, if we all just give them a warm Springfield welcome. Lincoln Park High School."

Speaker Hannig: "Is there any... Okay. Representative Mendoza on House Bill 4464. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 4464, a Bill for an Act concerning State Government. Third Reading of this House Bill."

Speaker Hannig: "Representative Mendoza."

Mendoza: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 4464 creates a Trade and Tourism Study Commission Act. It's identical to a Bill that passed out of this chamber unanimously last year. It establishes a commission appointed by the Governor and Legislative Leaders to examine and evaluate the state's programs and expenditures for the promotion of Illinois trade and tourism. Basically the commission would be made up of twelve (12) members: four (4) Members would be from the House of Representatives appointed by both the Speaker and the Minority Leader, and four (4) Members from the Senate

with two being appointed by each Legislative Leader, and an additional four members appointed by the Governor that represent Illinois trade and tourism organizations. Again, this is the exact same Bill that passed out of the House last year unopposed. And I would once again ask for your support."

Speaker Hannig: "This is on the Order of Short Debate, but we'll move it to Standard Debate. And on that question, the Gentleman from Crawford, Representative Eddy."

Eddy: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hannig: "Indicates she'll yield."

Eddy: "Representative, just very quickly, our analysis shows that DCEO is an opponent of this legislation. Is that accurate?"

Mendoza: "Yeah, it appears that they continue to be opposed to the legislation."

Eddy: "Have they expressed to you the... the reason for their opposition?"

Mendoza: "Well, they originally had mentioned that they didn't think it was necessary to do this, that they feel that the tourism and the trade programs that are run by the state are run without... well enough to not need this type of commission to be created to oversee them and report back to us. I tend to believe that the more we participate as a Body both in the House and Senate with what these programs are doing, how effective they are, and so forth, the more oversight we can have the better. So, you know, I'm certainly not against transparency, that's what we're asking for with this commission. And they additionally had

mentioned that this could create an additional expense because the commission would have to be staffed by somebody potentially from the state and that that would add an increased cost. We haven't come up with what that would be. I anticipate the cost on this would be nominal if any."

Eddy: "Yeah. According to information we have, the legislation is suppose to increase head count by two (2)?"

Mendoza: "That's their estimation, I don't understand why, frankly."

Eddy: "Okay. You don't see anything in here that would require additional head count there to manage this?"

Mendoza: "No, we're just..."

Eddy: "The commission would work independent of DCEO. They would just simply receive a report."

Mendoza: "Right. And we'd be in... you know, we would want to know and have access to the... you know, the programs that are currently under existence, so maybe they're saying that's why we would require additional work product coming from DCEO. But I definitely do not believe that we need to hire an additional two (2) people..."

Eddy: "So it's not your..."

Mendoza: "...to do this."

Eddy: "...intent that they hire anyone for this?"

Mendoza: "No. The intention is just to create a commission that is very bipartisan and has equal representation from both Leaders in this chamber, both Leaders in the other chamber."

Eddy: "Okay. Thank you."

Stephens: "Thank you, Mr. Speaker. Will the Lady yield?"

Isn't it the director of DCEO that's going to take his mark... their marching orders from the Governor, is that right?"

Stephens: "Well, I just think we need to call it for what it is and the administration's opposed to this, shouldn't surprise anybody, especially downstate where we're struggling to sell our products abroad and bring people into our state to see all the fine tourism sights that we have from all the way from Chicago to Cairo. So, I just want to make sure that the Body understood that it's Governor Blagojevich that's opposed to this. And I stand in strong support of your Bill."

Mendoza: "Thank you, Sir."

Speaker Hannig: "Representative Mendoza to close."

Mendoza: "Just once again, thanks for the questions. Hopefully I cleared up any concerns people might have, but I would simply ask for an 'aye' vote. Thank you."

Speaker Hannig: "The question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed 'nay'. The voting open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Will Davis, do you wish to be recorded? Mr. Clerk, take the record. On this question, there are 104 voting 'yes' and 0 voting 'no'. And this Bill, having received a Constitutional Majority, is hereby declared passed. Representative Wait, for what reason do you rise?"

Wait: Yes, Mr. Speaker. Point of personal privilege."

Speaker Hannig: "State your point."

On April 1, I filed a House Joint Resolution 118 Wait: rejecting the 2008 Compensation Review Board Report in whole. As you know, all... as you know, this report contains recommendation for pay raises for us, the Governor, and constitutional officers. According to the State Law, both chambers of the General Assembly must pass the same Resolution disapproving the report or the raises will take effect. We need to take action within thirty (30) days of the report being filed which means we only have fourteen (14) days left to reject these pay raises. Mr. Speaker, our state finances are in shambles and the families back home are feeling the pinch as well. Now is not the time to give ourselves a pay raise. I make a Motion to Discharge. The language shall be, Mr. Speaker, under House Rule 18(g), I move for discharge of House Joint Resolution 118 from the

House Rules Committee. Under House Rule 54(a)(2), all Motions are assigned Standard Debate status and I wish to debate my Motion. Upon the conclusion of the debate, I ask for a recorded vote on the Motion to Discharge. Under Rule 49, any vote shall be a recorded vote whenever five (5) Representatives shall request. There are at least five (5) Members on my side of the aisle for a recorded vote on the Motion to Discharge the Amendment from the House Rules Committee."

Speaker Hannig: "Representative Lang."

Lang: "Thank you, Mr. Speaker. Under the applicable House Rule, this requires unanimous consent, and I object to the Gentleman's Motion."

Speaker Hannig: "And Representative Wait, it's the ruling of the Chair that there has been objections, and so your Motion fails."

Wait: "Mr. Speaker, under House Rule 57(a), I move to appeal the ruling of the Chair that there be no recorded vote to discharge House Joint Resolution 118 from the House Rules Committee."

Speaker Hannig: "That's certainly a Motion that you can make, Representative. And so the question is, 'Shall the Chair be sustained?' All those in favor vote 'aye'; opposed 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this question, there are 59 voting 'yes' and 45 voting 'no'. And the Chair is sustained. Representative Tryon, for what reason do you rise?"

Speaker Hannig: "Yes, state your point."

"I would like to speak to the Motion that my colleague from Belvidere just made regarding the pay raise, because yesterday when I read the newspaper I was amazed at what I saw. And I saw one of our leading Senate Democrats saying, 'I need a pay raise, I need a pay raise, we need pay raises in the General Assembly'. And when I go home you know what I hear in McHenry County, Illinois, I hear I need a job. I need a job. I hear I need to pay my mortgage. And it's... I believe it's unbelievable for any of us to think that we could go home and justify a pay raise at the General Assembly when people in Illinois are economically bleeding here. It is needs for jobs in Illinois and we should be meeting that need, but we aren't. Just four (4) months ago we came down here to debate the CTA. And we had a healthy debate on that. And many of us said, no capital, no CTA. And it is nearly the anniversary when Representative Molaro said when we asked him when are we going to have a jobs Bill? When are we going to have a capital Bill? answer was, ten (10) days. He was the Representative leading the charge and putting together a funding package for a twenty-five billion dollar (\$25,000,000,000) capital Bill and we were suppose to see it in ten (10) days. didn't see it in ten (10) days. We asked when would we be voting on it? Three (3) months. We haven't voted on it and three (3) months has gone by. That Bill would have generated seven hundred and twenty-five thousand (725,000)

jobs in the State of Illinois and we have failed that. We don't have a surplus to give Legislators pay raises. We are looking at, according to the Governor, in order to balance the seven hundred and fifty million dollar (\$750,000,000) shortfall cutting Medicaid payments. That is wrong. We need a capital Bill. I say we don't take a pay raise 'til we have a capital Bill. We don't take a pay raise 'til we have budget reform. We don't take a pay raise until we look at school funding and do something about it. And we don't take a pay raise until we have transparency on the process that we have here in Springfield, and how do we go home and justify a pay raise when we can't do the jobs that we came here to do. Thank you."

Speaker Hannig: "Representative Lang."

Lang: "Well, thank you, Mr. Speaker. I don't know what that last speech was about. Under the House Rules, any Member can object to discharging the Rules Committee. I did that. I don't know why that leads to a long discussion about all these other issues. HJR118 or some other Resolution like this, I'm sure, will pass the House in due time. In my twenty-one (21) years in the House, this House has never failed to reject the Compensation Review Board Report and I'm certain we will reject it again this year when the time is right. So I think people ought to calm down and not make speeches about pay raises. I think we're all prepared to vote against the pay raise. Thank you, Sir."

Speaker Hannig: "Representative Schmitz."

Schmitz: "Thank you, Speaker. Point of personal privilege."

Schmitz: "As the previous speaker said just a moment ago, that I'm sure in due time or when the time is right, we can deal with the pay raise issue. Mr. Speaker, I'm imploring to the Members of this chamber, the time is now and the time is right. When we adjourned here Thursday, we went back to our districts, we got our local mail that was sent to us snail mail. My office was inundated with letters from constituents that say, how can you consider a pay raise? I'd ask myself, how can we consider a pay raise? We cannot consider this pay raise. I look at this Body as the board of directors. And we sit here and we read the newspapers you got a CEO that makes a billion (\$1,000,000,000) on a company that loses money. The board of directors take pay raises on a company that loses millions and billions of dollars. And here this Body can sit in here and not even figure out how we're going to reject a pay raise for our own checkbooks when we've got families in our district that are paying the same gas prices, paying higher food prices. Rose: "Mr. Speaker, Representative Lang's comments remind me of Kevin Bacon in <u>Animal House</u>. Remain calm, all is well. Well, all is not well, Ladies and Gentlemen. All is not well in the State of Illinois and this is absolutely no time to be taking a pay raise. Thank you, Mr. Speaker."

Speaker Hannig: "Mr. Clerk, do you have some items to read?"

Clerk Mahoney: "Referred to the House Committee on Rules is
House Joint Resolution 132, offered by... Senate Joint
Resolution 90, offered by Representative Smith and House
Joint Resolution 132."

Speaker Hannig: "Representative Holbrook, you have House Bill 5092. Do you wish us to read that Bill? Out of the record. Okay. Representative Soto, you have House Bill 4577. Read the Bill, Mr. Clerk."

Clerk Mahoney: "House Bill 4577, a Bill for an Act concerning civil law. Third Reading of this House Bill."

Speaker Hannig: "Representative Soto."

Soto: "Thank you, Speaker and Members of the House. House Bill 4577 is a Bill that I inherited from Representative Rich Bradley, so I'm carrying this Bill in his behalf. House Bill 4577 amends the Civil Code Procedure. Provides that if there is any surplus after a judicial sale or mortgage foreclosure, the clerk of the Circuit Court shall collect a twenty dollar (\$20) fee for each surplus proceeds deposited. Provides that of each twenty dollar (\$20) fee, fifteen dollars (\$15) should be deposited into the county's general fund and five dollars (\$5) into the Circuit Clerk

- Fund... Operating Fund. And I am open for questions and I urge an 'aye' vote."
- Speaker Hannig: "The Gentleman from Crawford, Representative Eddy is recognized."
- Eddy: "Thank you, Mr. Speaker. Will the Sponsor yield?"
- Speaker Hannig: "She indicates she'll yield."
- Eddy: "Representative, I have some questions just for clarity.

 Does this create a fee?"
- Soto: "It does not create a fee. It's for any surplus that is left over after any sale of a mortgage or foreclosure. Any surplus that is left from that should go into a... shall go into the Clerk of the Circuit Court Operating Fund."
- Eddy: "Well, I just... okay, so there's a... there's a judicial sale or there's a mortgage foreclosure that takes place."
- Soto: "Correct."
- Eddy: "That's step one. Step two then, is that if there are proceeds beyond the obligations of the sale, then there is a fee that would be charged?"
- Soto: "Yes. Provides that of each twenty dollar (\$20) fee, fifteen (15) should be deposited into the county's General Election Fund and five (5) into the Circuit Clerk Operation Fund."
- Eddy: "So is the twenty dollar (\$20) fee a new fee? Is it something new?"
- Soto: "I guess it would... yes, it would be a new fee."
- Eddy: "Okay. So you're creating a twenty dollar (\$20) fee only for those situations where there is a judicial sale or mortgage and a surplus exists? Okay. Then of that twenty dollar (\$20) fee, fifteen dollars (\$15) of that would go

into the county's General Fund and five dollars (\$5) would go into the Circuit Court Clerk's Operation Fund. Is that..."

Soto: "Yes. And that is due for the high foreclosure… due to the added increase of administrative fees due to foreclosures."

Eddy: "How often are there surpluses when there is a judicial sale or mortgage foreclosure? How often does this occur?"

Soto: "We don't have any figures."

Eddy: "Okay. So basically then the Floor Amendment that is part of this, Floor Amendment 1, that's been adopted and is part of the Bill?"

Soto: "Yes. Yes, it has."

Eddy: "And that then adds sheriffs to the legislation in regards to who deposits the surplus funds so the sheriffs get involved. What's their involvement meant to accomplish?"

Soto: "Okay. It goes by notice."

Eddy: "So, their job is just for the filing purposes? Okay. Thank you very much. I just wanted to make sure that folks understood this is... this is a fee that is being created and who then, the payer of the fee would be whomever it is that purchases the mortgage or the property that is being foreclosed upon but only after 100 percent of the... of the person's obligation is met. Only after that is met. This is only if it goes above..."

Soto: "Yes, Sir."

Eddy: "...and beyond? Okay. Thank you."

Speaker Hannig: "Representative Franks."

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Hannig: "Indicates she'll yield."

Franks: "I have a few questions on this. Following up on the prior speaker, you're saying the person or the entity that would pay the fee would be the... would it be the successful bidder or would it be a person or entity that was making an application for the surplus funds?"

Soto: "Okay. It would be... Representative Franks, it would be the previous owner who is now the defendant to the suit."

"I'm not sure that makes sense for this reason. you... right now are you aware of how many fees are attached when one files a foreclosure? First you have to file the filing fees which are typically for a chancery, about three hundred dollars (\$300). Then you have all the service fees which could be hundreds of dollars as well. Then if the property... excuse me... were going to go to sheriff's sale, the sheriff charges six hundred dollars (\$600) for the sheriff's sale. Okay? The clerk has already received approximately five hundred dollars (\$500), the sheriff has received six hundred dollars (\$600) to do the sale. Typically in a foreclosure, that... the entity that forecloses loses about 40 percent of the value. wondering why we would add on another fee to, and I'm not sure who yet would have to pay this fee, because if... here's my question. If you are the mortgagor and you give the mortgage and then you go forward and do the foreclosure, it's very rare that you'd be taken out whole. cases you lose about 40 percent. In this instance, would it be the purchaser who would have to pay that fee or would

it be... 'cause here's... I'm not... let me explain something. I'm not sure you understand how this works. Let's assume there are other defendants, and let's assume they're defendants because they have a judgment against the mortgagee, and they place a lien against the property. And let's assume there's, you know, three (3) entities that have liens, and let's say one of them is the City of Rockford. So the City of Rockford has filed a lien and let's assume there's a surplus and let's just say that the first mortgage holder has a judgment for a hundred thousand dollars (\$100,000), City of Rockford has ten thousand dollars (\$10,000), City of Waukegan has a ten thousand dollar (\$10,000) lien and another city has another ten thousand dollar (\$10,000) lien. A purchaser comes in and buys it for a hundred and thirty-one thousand dollars (\$131,000). So that way the first mortgagor is paid in full, but then there are three (3) entities who could claim for that surplus. Who would pay that fee?"

Soto: "We're checking. I inherited this Bill so we're checking.

Okay. The fee will be taken out of the deposit of surplus,
only if there's a surplus."

Franks: "Okay. But it would come out of the... so it would be taken out of the thirty thousand (30,000) that's left over?"

Soto: "It would come out of the deposit of surplus. So only if there's a surplus and this is..."

Franks: "Okay. Well, let me ask you, a policy..."

Soto: "Can I just... can I just run through this?"

Franks: "Go ahead. Sure."

- Soto: "In this... in this Bill it says, 'the clerk shall charge and collect twenty dollar (\$20) fee for each deposit of surplus proceeds'."
- Franks: "How do you define 'each deposit'... or 'each surplus'?

 Would it be one for each of the three (3) others who might
 be claiming the surplus? Because in this scenario which I
 gave you..."
- Soto: "And I answered it."
- Franks: "...there would be three (3) entities who could claim surplus."
- Soto: "Right. So, any of those three (3)... who is going to voluntarily pay that fee. That's what you're... and maybe no one."
- Franks: "Yeah. And my question is policy wise. Why do we want to do this when the folks who have already been involved have had to pay literally thousands of dollars? And if you're a defendant in a foreclosure suit, and you... and let's say, let's use the city for an example, and they had to file a claim to get their lien, they had to pay hundreds of dollars in their first suit, then in order to protect their interest in the underlying foreclosure suit, they had to file an appearance and another answer for another three hundred bucks (\$300). So let's assume they're already... each of the defendants are already six hundred dollars (\$600) into it. Why do we want to sock them again, especially if they're not going to be made whole."
- Soto: "Can I just mention, Representative, unless otherwise ordered by the clerk... by the court."

Franks: "Right. I just... I just think it's bad public policy because these folks have already been victimized..."

Soto: "Exactly."

Franks: "...they have not been able to collect and then to charge them another fee to get what's already theirs, that they've had to pay hundreds of dollars for."

Soto: "Yes."

Franks: "I think this is a Bill you might want to take out of the record."

Soto: "And I was... I was going to... I mentioned that. I said I think... I inherited this Bill, so I'm going to pull it out of the record and then call the clerk's office and see, you know,..."

Franks: "Thanks, I appreciate it."

Soto: "...if they have any other information."

Speaker Hannig: "Okay. So, out of the record."

Soto: "Thank you. Out of the record."

Speaker Hannig: "Representative Turner has House Bill 2467.

Out of the record. Representative Wyvetter Young, you have House Bill 5205. Mr. Clerk, read the Bill."

Clerk Mahoney: "House Bill 5205, a Bill for an Act concerning transportation. Third Reading of this House Bill."

Hannig: "Representative Younge."

Younge: "Thank you, Mr. Speaker. House Bill 5205 requires the Department of Natural Resources to evaluate the adequacy of the levee systems in the state. If the system is evaluated as being inadequate, then the Bill requires the Department of Natural Resources to come up with a figure that it will tell us how much it will cost to repair the system."

Younge: "It is subject to appropriation which is Amendment #1.

Speaker Hannig: "The Gentleman from Jasper, Representative Reis. Does not wish to speak. Are there any... is there any further discussion? Then the question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Phelps, Krause and Brady, do you wish to be

 Representative Barbara Flynn Currie, Chairperson from the Committee on Rules, to which the following legislative measures and/or Joint Action Motions were referred, action taken on May 6, 2008, reported the same back with the following recommendations: 'approved for floor considerations', referred to the Order of Resolutions, 'recommends be adopted' is House Joint Resolution 132, offered by Representative Crespo, and Senate Joint Resolution 90, offered by Representative Smith."
- Speaker Hannig: "And on Supplemental Calendar #1, under the Order of Resolutions, is Senate Joint Resolution #90.

 Representative Smith."
- Smith: "Thank you, Mr. Speaker, Ladies and Gentlemen. This is our semiannual look at the education mandate waivers that come to us from the State Board of Education. This is the Resolution put together by the Senate Education Committee. Basically takes the following actions and I would remind the Body that the action we take is actually a negative action. So, this Resolution actually disapproves certain waivers and there are two (2) of them in the area of physical education, one by Knoxville School District 202 and one by Zion-Benton East District 126. The majority then are in the area of behind the wheel driver's

There were a number of school districts who instruction. had requested waivers for simulators as a replacement for behind the wheel instruction and this Resolution would approve those for one (1) year only rather than the five (5) years requested. So, it would be a one-year waiver rather than five (5) years. In addition, there's one-waiver for the Rockford School District 205 with regard to general state aid, and that's a one-year waiver rather than the five (5) years requested. There are... there's one (1) waiver for substitute teachers and that was approved... or is recommended for one (1) year rather than five (5). then finally there's a number in the area of driver's education fees. A number of school districts had requested raising those fees and has been the custom in the past, we're recommending that they only be allowed to do that up to the two hundred and fifty dollars (\$250) which has been the precedent of the General Assembly in the past. That basically is what is in this Resolution. The action that we're recommending be taken on the waiver request for this half of 2008. I'd be happy to answer any questions."

Speaker Hannig: "The Gentleman has moved for the adoption of Senate Joint Resolution #90. And on that question, the Gentleman from Crawford, Representative Eddy."

Eddy: "Representative, for purposes of clarifications, once in a while this gets very complicated. You're asking for Members to vote 'yes' on this, is that correct?"

Smith: "That's right. That's right and this..."

Eddy: "And by voting 'yes' they are rejecting certain requests by schools districts for waivers?"

Smith: "That's right. They're rejecting certain requests and they're asking for... or they're accepting modifications of those requests."

Eddy: "Okay. And this is why yes means no in this case."

Smith: "I'm sorr..."

Eddy: "Yes means no because..."

Smith: "Unfortunately yes, the way this process is set up.

There's actually only two (2) waivers that are flat out disapproved and those are the two (2) on physical education by the two (2) districts I mentioned."

Eddy: "Okay. And for clarification purposes, really basically any school district that requested a waiver from the State Board of Education of the driver's education fee rule which the law is fifty dollars (\$50) or more, the state board has kind of made it practice that they approve waivers up to two hundred and fifty dollars (\$250). So the waivers that are being denied are those that requested over two hundred and fifty dollars (\$250)?"

Smith: "That's right, that's right. They're... they're being approved up to two hundred and fifty dollars (\$250)."

Eddy: "So a lot of driver's education fee waivers that were processed have been approved."

Smith: "That's right."

Eddy: "Okay. Just wanted to clarify that. Then on the issue related to simulators for driver's education courses, I think that there was a group of school folks that came up and set a simulator up and did a really good job of demonstrating the value of simulators..."

Smith: "That's right."

Eddy: "...and the fact that, you know, maybe we should take at least a second look at that. So those requests that were for five (5) years, how... how were those addressed in this waiver then?"

Smith: "That's an excellent question, Representative Eddy, and probably the one issue that received the most concern over the waivers during this process. The recommendation is that they be granted a waiver for one (1) year. Not for five (5) years as they had requested, but for one (1) year. So that'll give them a year basically to continue to operate the simulators and to come back next year either requesting I guess an extension of that waiver or hopefully they will have been able to work out some of the differences that they have mainly with the Secretary of State's Office."

Eddy: "So this gives them an opportunity to make their case.

Is that right? It just gives them that year, that opportunity to make their case?"

Smith: "Absolutely. Right."

Eddy: "Now when... when the... we discussed... this could be something that the horse is already well out of the barn down the road on because there is a deadline involved with this that has passed. Is that right?"

Smith: "That's my understanding, yes."

Eddy: "So..."

Smith: "Unfortunately because of this deadline, the Senate took action late on Thursday after we had already adjourned. So this has been the first opportunity that we could take action."

Eddy: "So it's entirely possible that even though we vote 'yes' meaning 'no', that districts who applied for waivers will get them because the deadline passed, and it's not your intention to mess with the deadline, it's your intention to at least have on the record a vote regarding those waivers."

Smith: "That's right."

Eddy: "Okay. So... so basically this is... this is nothing more as it ends up then being a waiver that was sent over late by the Senate, too late for us to act on with the appropriate Amendments... and by the way, is the Senate... I don't even think the Senate's around today to... is that right?"

Smith: "I... I don't believe they're here. No."

Eddy: "Hoosiers. I think. They're in the Hoosier State, a lot of them anyway. Thank you for answering the questions. think it's something that obviously we have responsibility to act on. Although, again, I don't think it's going to make any difference because that... that deadline has passed and when you deal with eight hundred (800) and some school districts across the state and you promise them a deadline, the least thing we can do in the General Assembly is to honor that deadline. But I appreciate the fact that at least this shows that there's some working relationship and agreement albeit it late. Thank you."

Smith: "Thank you, Representative Eddy. This is, as you know, this is a process that doesn't work very well in my opinion and we've... we've tried to fix the process in the past and obviously..."

Representative McCarthy, you're recognized for 5 minutes."

McCarthy: "Thank you, Mr. Speaker. Will the Sponsor yield?"

McCarthy: "Okay. Representative, the... this is just for waivers that were either denied or adjusted, correct?"

Smith: "This... this is for waivers that the state board sent to the General Assembly."

Smith: "No."

McCarthy: "...that..."

McCarthy: "So you know all the school districts that ask for like waiving like Casmir Pulaski day, for example?"

Smith: "Right."

McCarthy: "Have those all been denied this year then or..."

Smith: "No. No."

McCarthy: "They don't need our action. Is that the story?"

Smith: "That's right. That's right. The state board takes on...
most wavier requests, the state board takes action on their
own. What we have to do basically is disapprove ones that
we find unacceptable."

McCarthy: "Okay. In the past, have those holiday waivers been in the report that we had to vote on? Seems like I used to remember them..."

Smith: "I think they may have been in years past, but not recently because I think we've... we've worked out most of those..."

McCarthy: "Okay. This is not in your legislation. Is there any school district in the state that still observes the Casmir Pulaski holiday?"

Mitchell, J.: "Representative Smith, our options are fairly limited since this seems to always start in the Senate. did have an option though of amending this Bill bringing back these, let's say, bringing back simulators to a four- or five-year waiver other than a oneyear waiver or eliminating them altogether. We could have done the same for Rockford on their request on how they count student attendance. However, we chose to not to do that and I think you and I both agree, the reason why we chose not to change what the Senate did, number one, since it's already late that would have made it even later and the Senate would not have acted on that. Basically today's vote is more ceremonial than anything because these waivers by law have already been granted. What... what... every district went before their board and held their hearings requesting a particular waiver, that is exactly the way it's going to be in law. So the simulators, what they requested as a waiver, that's going to stand even though the Senate sent us a Bill they sent it so late there was no opportunity to us to act on it to make sure that the waivers are approved or disapproved. So, any district that required... or requested a waiver this year, they have it. So you can vote however you want, quite frankly, the vote is just simply I quess, do you support the Secretary of State's request or do you not support it. Other than that, this vote means very little if anything. So, Mr. Speaker, I thank you for that clarification. People understand that when you go home to your districts, those from Rockford and that area, those with the simulators, you can tell them

that their request for a waiver is approved in exactly the way that they requested it. So, vote however you wish. Thank you."

And I applaud him for that because I think it's going back to what is was before and they have reduced the deaths of

And when I talk about the change in relationships with modern adoption practices, we want to codify, at a minimum, an opportunity for biological parents to receive a gift from an adoptive family without it being considered criminal. And so what we've done in this legislation is we have set a cap and teased out the language a little more so we know what is legal and what isn't legal."

Eddy: "So this then, for example, one of the... one of the items has to do with something called a 'confidential intermediary' and this... this would allow that person a little greater access to vital records than... than is currently in effect. Is that accurate? And if you could, does confidential intermediary... is this court ordered? Is this person court ordered?"

Feigenholtz: "Yes, this is a... the confidential intermediary program has an advisory council which meets two (2) or three (3) times a year and they end up with certain situations that they need to come back to the General Assembly to tweak the law. If you look at... I don't know what your staff analysis says, but there have been situations where the court and the confidential intermediary are actually trying to get some kind of jurisdiction in other states and have our court orders recognized in other states so that the confidential intermediary can do its job."

Eddy: "One of the other issues related to this that... that our analysis covers has to do with the perspective adoptive parents of a child that those perspective adopted parents, they could give the biological parents gifts or things of value as long as those are under two hundred dollars (\$200)."

Feigenholtz: "Correct."

Eddy: "And that there's other flexibility written in however, if it's not a gift or an item of value but the perspective adoptive parents can advance the birth parents certain living expenses that aren't necessarily gifts but it allows for some of those things. Are those some of the modernizations that you've kind of alluded to?"

Feigenholtz: "Yes."

Eddy: "And so… and again, this is a… this is a… an area that I think a lot of us… a lot of us in the General Assembly are learning about and there is a lot of legislation out there,

this is one that I think we need to make sure folks know is a little different than a different Bill..."
