"Mr. Speaker, Ladies and Gentlemen of this Consul Rouine: distinguished House, I bring you greetings of the Irish government. This is my first trip to Springfield. been posted to Chicago since the first week of December, and it's a privilege and an honor for me to be received by you here in your very, very busy schedule. There is a long tradition of close relations between Ireland and the great United States of America. Generations of close family ties leave me with a very strong sense of being at home here in I... indeed, I've meet some of my fellow Springfield. countrymen this morning. But the names that make up the membership of this association speak volumes for relationship between our countries. Mr. Speaker, these bonds have held true over the generations. And I am proud to be able to inform this great House that Ireland is at peace. We've overcome decades, indeed, centuries conflict. And we now have elected representatives of both communities in Northern Ireland, using Democratic means to resolve the problems of Northern Ireland. Mr. Speaker, our dream and the dream of the friends of Ireland in America and across the world have come true. And we express a sincere word of gratitude to our friends who have helped us in our search for peace over the past two (2) decades. We

can now turn our attention to building an even stronger economy that will benefit the people of all Ireland. Ireland is small and very open economy, we export over 80 percent of what we produce. And as such, we're very, very vulnerable to the shifts in global economy. The current slowdown in the U.S. and global economy has persisted for longer than initially expected. The effects are also spreading to other sectors. The outlook for many of Ireland's kev trading partners has correspondingly weakened, but we are working very hard to ensure that we are well positioned to meet the challenges that lie ahead. Fundamentals of the Irish economy remain healthy. young, well-educated, outward looking dynamic workforce. And we have a lower burden of taxation on both capital and labor. U.S. investment in the Irish economy continues to be very important as we manage the transition into a leading 21st century knowledge-based economy. for many U.S. countries Ireland provides the critical access to markets in Europe and beyond. Ireland is also a location for young, highly educated, English-speaking and adaptable employees and provides а regulatory tax environment that is attuned to the needs of business. Of course, investment and business is a two-way street and many Irish companies are investing in the U.S. start of this year, New York Times ran an article entitled, 'Ireland is alive with enthusiasm and entrepreneurship.' And these entrepreneurs have global ambitions. companies now employ over eighty thousand (80,000) people across the fifty (50) states. This number has increased

ten-fold over the last ten (10) years and last year alone forty seven (47) companies opened offices in the U.S. U.S. market is a key market for the Irish indigenous industry with an estimated growth figure of ... of 2007 being in excess of 16 percent. This is very impressive growth in the light of the current economic conditions and the weak dollar and is testament to the caliber of Irish companies and their ability to compete in the global However, we still have a number of young people in Ireland who wish to follow the footsteps of previous generations to this great country to find employment. We also have a number who have already come here and who now number amongst the undocumented. These are hardworking, welleducated young people who would be an asset to any country... any country's economy. And while we fully appreciate the difficulties involved in framing equitable nondiscriminatory legislation in this field, on behalf of the Irish government I look to you to continue supporting a comprehensive immigration reform that will work to the advantage of the U.S. economy, and present to future generations of aspiring immigrants. Thank you very much, indeed, for your attention."

A very basic human right, I might suggest to you Ladies and Gentlemen. And certainly those who in this unfortunate are circumstance, being detained in our society for a sometimes extended period of time, are, probably those are who are at the lowest point in their life. And I might suggest to you at that point being those who would need a little counsel

For those who have immigrated here to our country, to our State of Illinois, for whatever reason... and certainly, I would suggest to you that the reason is good and solid. They want to make a better life for themselves and their families. But in this instance... in this legislation, for those who have come here illegally, who have been apprehended, who are now detained in our society, who this state is receiving dollars for from the Federal Government, I suggest to you, Ladies and Gentlemen, that these individuals should have the opportunity to visit with religious workers. I'd be happy to answer any questions, Mr. Speaker."

Speaker Lyons: "The Chair recognizes the Gentleman from Kane, Representative Tim Schmitz."

Schmitz: "Thank you, Mr. Speaker. Will the Gentleman yield?" Speaker Lyons: "Gentleman yields."

Schmitz: "Representative Burke, as I was cruising through the computer here, there's numerous Amendments on it and some had the opposition and some didn't. It's my understanding that Floor Amendment 4 basically reinstated what you had on Floor Amendment 3. Has the Sheriffs' Association officially removed their opposition?"

Burke: "Through a process through a series of discussions with the Sheriffs' Association, I would suggest to you and this Body that they are now neutral on the matter. Burke: "I am not familiar with that entity. They have not had discussion with me."

Schmitz: "Okay. Thank you, Speaker."

Sullivan: "Thank... thank you, Mr. Speaker. Ladies and Gentlemen, I rise in support of this Bill for the very fundamental reason that we are here in this country, religious prosecution (sic-persecution), religious freedoms. This Bill is very simple. It says, no matter what you have done in the past, how you have gotten into this country, you are entitled to the right to have a spiritual counselor of your choice come and discuss with you spiritual needs while you're incarcerated. It's that simple. So with that, I would hope that you would all join Representative Burke on a fine piece of legislation and vote in favor. Thank you."

Speaker Lyons: "Representative Dan Burke to close."

Burke: "Thank you, again, Mr. Speaker and Ladies and Gentlemen of the House. I think if we look at this piece of legislation, it is again, simply a human right. One in this society, whether they have papers or they don't, are

still entitled to the basic human right of having the opportunity to be counseled by a religious advisor. We are not asking for amnesty in this Bill, Ladies and Gentlemen. We are not asking for special privilege here. It's a very simple issue, Ladies and Gentlemen. I would certainly encourage your support. If you've got a human heart beating in your chest today, I think you'd have to consider this as a legitimate initiative. Thank you so much, Mr. Speaker and Ladies and Gentlemen."

Mulligan: "Thank you, Mr. Speaker. Will the Sponsor yield? Representative, the problem I see with this is... and I suppose since it's optional that'll clear it up, but some physicians will not provide those services. So, they don't want to be on the list because they either can't in their practice provide anymore or they're not going to or they don't provide the services through the state. So, if they hand the person a brochure that comes to their office and they don't provide the services it causes a little bit of a problem. So, either they have to have a list or someway for the people to find out how to get the services. But I suppose if it's optional, if a pediatrician or a doctor does not want to provide the services, they may or may not hand out the brochure."

Hamos: "I... I think you're... I think you're making a good point, Representative. I know that we've been calling around in my district to see who has available slots for All Kids. And there are some physicians who do. So, I think that if they're interested in more business from the state they would probably do more of this kind of education and making forms available. And if they're not, they're not going to do it."

Mulligan: "So, then how would they go about instituting the law? Would they just have the Department of Human Services or Department of Healthcare and Family Services send out a mailing to all physicians saying, we encourage you to provide this service, we encourage you to hand out the brochure to your people that don't have any kind of health care?"

- Hamos: "You know, I think that what the Bill says... technically what the Bill says is that the department will work with physician groups to try to figure out how to do this. And it has to do with two (2) parts to it. One is, the availability of health care benefits and secondly, how to apply for them. It may be as simple, at the end of the day, as giving and handing out a brochure with a Web site address or an application form. But it is... they will work that out as a part of this Bill."
- Mulligan: "All right. 'Cause I think that would be the better part of the law is to have them be able to actually provide the services or to encourage them, and some will and some won't. So, thank you."

This Department of Juvenile Justice needs to look at how juveniles are treated, not only the minute they arrive in the department once they're already incarcerated, but what happens at the very first time that they're arrested and they're being held in county jail. What happens if they're being held just for misdemeanors? Is there a different kind of approach? What happens if, in fact, they're technical violations? Do they need to return

in every case back to the department? There are a series of policy issues that the department, along with this advisory board, still needs to work on. We have given this a time frame, by December 30, 2010. They will have a chance to look at a bunch of these systemic issues. And that's really what this... the intent of this legislation is. Out of that will come some... probably some policy recommendations. We will have an opportunity at that point to debate the actual policies that flow from it. But at this point in time, that advisory board needs to be working together, needs to be appointed, needs working together and needs to struggle with some of these policy issues."

Speaker Lyons: "Is there anyone seeking recognition? The Chair recognizes the Lady from Kane, Representative Pat Lindner."

And I believe that we should give them so many... like a ninety-day grace period before they know about all of these new regulations. And I think this... I believe that the council in some way is a little harmful to businesses.

- Poe: "Yeah, Mr. Speaker. As many of you know, we lost the 183rd jets from the Capitol Airport. And usually when that happens we have... fire service is provided by the National Guard at the airport. We're hoping for another assignment at the airport and rather than disrupt that, we don't have any service... fire service out there currently for our commercial airlines. And this is something that will provide a lot for the community. And we think it's a plus for the homeland security being located here in Springfield that they're trained in homeland security and they could help out all of central Illinois. Thank you."
- Speaker Lyons: "The Chair recognizes the Gentleman from Knox, Representative Don Moffitt."
- Moffitt: "Thank you, Mr. Speaker. To the Resolution. I'm sure this will probably get all 'yes' votes, as it should. But I mean this is extremely serious. Here we are in the State Capital potentially... probably more subject to some problems and the high-tech firefighting equipment that the National Guard can provide, it would just be a real disservice to this city, to this state if that is moved out of here. We all benefit, our state benefits. But they bring some additional equipment to give... that can give mutual aid if needed. And so, it isn't just the airport. But they're
