Mulligan: "Thank you, Mr. Speaker. I just have a question. Who's extended the invitation to the mansion at 3:30? Is it... is it our Leaders or is it the Governor? And my understanding is that some of these meetings have gotten a little contentious. So, if you wanna keep stalling about not getting the work done and you're the Governor and you want to stall and keep us here forever, then he's just going to invite everybody in. Is there any organization to these meetings? Or... who has invited us all to appear there?"

Speaker Hannig: "I'm advised that the Governor's Office sets the meeting and advised the Leaders and the Members that we're all invited. And I think a number of Members have often indicated that they would like to be part of this budget process. So, it's open to all Members."

Mulligan: "Over this past section, there's any number of people in this Body that have expertise in certain areas. Not that we all have expertise in all areas, I don't think everybody expects us to. But some of us have developed certain expertise in the area that we work in the most. You, on the budget, me, on human service appropriations, different people on... Representative Hamos currently on public transportation. Has the Governor ever sought to have small meetings where he actually tries to learn something as

opposed to preaching something, from those of us that have that expertise and would be more than willing to discuss why or why not we are for a particular issue rather than to have a mob scene where everybody hits each other over the head and continues to hurl insults? My feeling is that at some point after 5 years he should develop an area of expertise. We don't expect him to ... just as we don't expect any lawyer or judge or anyone to know everything, but he has numerous experts at his fingertips where he could hold these meetings and actually educate himself on some of these issues and the propositions on whether they're realistic or not. opposed to have a cattle call, all of us going over there to listen why he insults us whether he insults us by insulting our Leaders who we've duly elected or he insults us by calling them names as opposed to being a Democrat Republican, which I find to be an insult, also. perhaps he ought to get real about actually learning what the real issues are on this budget and start talking to the people that have expertise in them and listening to his own advisors. Because what he's doing is aiding an untenable situation that will never be solved. And it's really unfortunate that his mindset is one of just yanking everybody's chain as opposed to actually learning anything, being here and doing anything."
