Everywhere I go in my district this is a major topic and I'm sure it is in everyone else's districts too about whether we're going to have a Special Election for the United States Senate seat. That's why I'm taking this effort. When I go home this weekend, I want to be able to tell my constituents and let my children know that I've taken every step possible to restore our democracy. The citizens of the State of Illinois have been abused by their public officials. There is a crisis of

The citizens have lost faith in their government and deservedly so. The last few months have been a sort of political hell for our citizens. We have become a national disgrace. We have become a punch line. There are more federal agents in Illinois investigating corruption by public officials than in any other state. None of us want the citizens of Illinois to have to go through this again. We, the Legislature, we created the problem by not stripping the former Governor of his power to appoint when we had the chance. It's now incumbent upon us to clean up our own mess. It is clear that when Mr. Burris came to our committee he misled the Legislature and he misled the public. Every week it seems that more and more information trickles out. I sat on that special investigative committee and I heard the questions and I heard Mr. Burris's response. It is clear that he was not forthcoming and he was seated in the United States Senate under false pretenses. Now, I harbor no illusions that the United States Senate will discipline one of their own. last time a Member was expelled was in 1862. Speaker Madigan: "Mr. Franks."

"Mr. Speaker, in all due respect, I understand your position, but I respectfully would ask that the Chair be This is a difficult position to put my overridden. colleagues in, especially those Members of my own Party, but I think it's an easy Motion to make because it's the right one. We were elected to do a job and to stand up for what's right. We're supposed to be independent voices for our constituents. This Motion, Ladies and Gentlemen, that I've asked that you override the Speaker, requires not loyalty to a Party but rather a loyalty to our state as a whole. The only way to get past the problems of the past is to rise above partisan politics. If that means that we risk our positions, sobeit. It is better to risk our seats than to lose the confidence of the people of the State of Illinois. This extraordinary circumstance requires all of to rise up and to do what's right, not what's politically expedient. I ask my colleagues, respectfully, to vote to override the Chair and allow this Body to vote on this Special Election Bill. Let's take our government

Speaker Madigan: "The Gentleman's Motion is to overrule the ruling of the Chair. And on this question, the question for the Members shall be 'Shall the Chair be sustained?'

The Chair recognizes Mr. Durkin."

Durkin: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Madigan: "Sponsor yields."

Durkin: "What exactly kind of stunt are you pulling right now, Mr. Franks? I was in this committee yesterday. You, well, had this orchestrated vote set up to make sure it failed not only our Bill but also yours. What exactly are you trying to get done today? This is absolutely hysterical."

Franks: "It's not funny..."

Durkin: "No, it is funny. You are..."

Franks: "...and I really resent the implication."

Durkin: "Actually, this is the phoniest exhibition I've witnessed in my lifetime, though."

Franks: "You know, Durkin, I filed a Bill in December to strip the Governor from making that appointment and you didn't get on the Bill. I tried to get the Bill passed. You had no… you had no reason to help, because you guys wanted a political chit. That's all it was about. Now, I've been consistent from the very beginning to have a vote and to have a Special Election. There's no game playing here. I'm doing everything I need to, to get this vote. I wish

Durkin: "The political games which I... And I recall January 8 was probably the first time you were silent in your career with Mr. Burris."

Franks: "You want to know why I was silent, because I believed his answers and I was listening to your questions and I listened to Jil Tracy's questions. And when he told me that the only person that he spoke with was Lon Monk in July, I figured there was no follow-up necessary. Now, if he would have said I spoke with John Wyma, the person who set the listening devices in the former Governor's office, I guarantee you I would have asked questions. But when he told me he talked to somebody in June or July, there was no reason to follow up. And as you know, I was one of the most vocal Members, but when he answered those questions, I think we were all duped. And I told... as soon as I found out I felt betrayed and I went after him. So, don't say I'm playing games. I've been straight from the beginning. I don't know what your angle is, though."

Durkin: "Mr. Franks, we've had enough of your charade, as have I."

Speaker Madigan: "Mr. Reboletti."

Reboletti: "Thank you, Speaker. Will the Sponsor yield?"

Speaker Madigan: "Sponsor yields."

Reboletti: "Representative, numerous times the House Republicans have tried to get election Bills out and not

Reboletti: "If this is a nonpartisan issue and we're trying to get good government, it shouldn't matter, Representative. You should have joined us to get a Bill out so the people of Illinois could have good, clean elections but let the best person win."

Franks: "Here's your opportunity now."

Speaker Madigan: "The question is, 'Shall the Chair be sustained?' Those supporting the Chair shall vote 'yes'...

Mr. Black. The question is, 'Shall the Chair be sustained?' Those supporting the Chair will be vote 'yes'; those voting against the Chair will vote 'no'. The Clerk shall take the record. The Clerk shall take the record. On this question, there are 54 people voting 'yes', 62 people voting 'no'. The Motion fails. Black... Mr. Black."

Black: "Thank you very much, Mr. Speaker, point of order. Pursuant to Rule 58 there is a suspension clause that that rule could be suspended and we could revisit this issue if we need to. And I would ask the parliamentarian to look at the suspension article in Rule 48 (sic-58), to suspend that entire rule which if necessary would let Mr. Franks make a Motion to again release that Bill, and would not be then held accountable under the failure to have a positive Motion in the committee. I make my Motion in good faith.

Stephens: "Thank you, Mr. Speaker. How did you vote?"

Speaker Madigan: "Yeah, you should stop right there."

Stephens: "I'll stop right here."

"Thank you, Mr. Speaker. I have a point of order pending. We would like a response to that prior to the resumption of normal business. I have moved under Rule 58. It has a suspension clause under the applicable rule, that that rule being used to deny Mr. Franks' Motion to Discharge was denied based on the fact that the Bill in question did not get an affirmative vote in committee. All I'm asking in my point of order, under Rule 58 you can suspend that rule which would then let Mr. Franks have another attempt, in my opinion, to discharge the committee because the rule then would not stand in his way for a Motion to Discharge since the rule saying he didn't get a ... an affirmative vote would be suspended by a vote of 71 Members of the House. And I would ask the Chair to so rule before we move on to the resumption of normal business. And I... Mr. Speaker, it's not... this is getaway day. enjoy doing this. I'd like to get home as all of us would as well, but I really do think that this is a very important issue. Sixty-two people voted to have some vote

- or hearing or debate on a Special Election. Sixty-two people, that's more than a majority. So I, again, I would make my point of order about the suspension of the rule."
- Speaker Turner: "Representative Black, the parliamentarian will give you his ruling."
- Parliamentarian Ellis: "Representative Black, on behalf of the Speaker, in response to your inquiry. Sir, Rule 58 is the mechanism by which you can move to discharge. If you suspend the rule you don't have a mechanism for discharge in the first instance."
- Black: "You are telling me that the suspension, that entire rule cannot be... I would assume that it would be divisible. The only thing I'm asking that we suspend, under the suspension reference, would be the applicable rule under Rule 58 that he has to have an affirmative vote to discharge. I would think, under a suspension point of order, that that applicable rule could be suspended and that Mr. Franks, in fact, then could move to discharge that Bill from committee. I will defer to your expertise. I've seen these things happen before and all I can say, Mr. Speaker, is 62 people voted to overrule the Chair. That is more than a majority. I don't know why we can't move to the order of the election, and I think the rule could be suspended in a divisible fashion and let Mr. Franks renew his Motion."

Speaker Turner: "Representative, a ruling has been made."

Black: "Can I... can I disagree with the Motion? Let the record reflect I disagree with the... with the response. I understand that the hour grows late and people have a long

way to drive. I will not pursue an over... try to overrule the Chair, but I think the message is clear, Mr. Speaker, more than a majority voted to overrule the Chair. I know it takes 71 votes to overrule the Chair, but a clear majority voted with the Representative to have a vote or a debate on an election Bill. I... I always stand in confusion when the majority, a majority of the Members of this House, will find their wishes ignored. Yes, you all have a Roll Call and some of you can hide behind that, but I think people are much more sophisticated today; they ask us what were the results, not how we voted. And I think the result clearly shows of the 62 voting in the affirmative, that we should debate a Special Election Bill. I will accept the ruling of the parliamentarian. I want the record to reflect I certainly don't agree with it and disappointed that we cannot, in an open and fair fashion, debate a Special Election Bill."

Speaker Turner: "The Gentleman from Kendall, Representative Cross, for what reason do you rise?"

Cross: "I think we're through, for all practical purposes, with the previous speaker, but I have filed now, Mr. Speaker, under... House Rule 61, a Motion to ask that my Bill, House Bill 2503, be taken off the table... be taken off the table where it is, brought back here and immediately sent to the floor for a vote. Obviously, as Representative Black said, 62 people at least on paper are going to try to allege that they are for a Special Election. That's what we... let's not kid ourselves, that's what the vote was all about, to give people some cover so they can say, I voted for a Special

Election, look at the Roll Call. Let's get the real Bill, our Bill, 2503, and quite frankly, I don't care if it's my Bill or Representative Franks', if he really is sincere about this, out here. Take it off the table, have it discharged immediately to the floor. We all know what the issue is, it's whether or not we ought to set an election and have a Special Election. So, I would move, as I said, repeat my Motion to take 2503 from the table and have it immediately discharged to the floor for a vote on whether or not we should have a Special Election in the State of Illinois."

Speaker Turner: "The parliamentarian will give an answer to your request."

Parliamentarian Ellis: "Leader Cross, on behalf of the Speaker, in response to your inquiry a... the result of a Motion to take from the table, if one carried, would be not to return it to the floor, but to where it originally came from, which is the Executive Committee where it has been unfavorably reported, Sir. So, there is no mechanism to move to discharge as we previously ruled, because it's been reported unfavorably.

Cross: "Well..."

Parliamentarian Ellis: "There's no mechanism to use a Motion to Table to deliver that Bill directly to the floor. It would go back to the Executive Committee, Sir."

Cross: "Well, I know as Representative Black said, it's late, it's Thursday afternoon, but if this is the last week to get Bills out of committee, 62 of us say we support Special Election. I would ask the Chair to convene… waive the

posting, convene the Executive Committee. Let's go back down there, have a vote, get it back on the floor, have a vote today on whether or not there really are 62 of us that support House Bill 2503 or the alternative, Representative Franks's Bill and vote on it this afternoon. We are either for Special Election, 62 of us, or we're not. So, I would ask that you suspend the posting and convene the Executive Committee this afternoon. I would hope that Representative Franks... Representative Franks, I know you... I assume you're supporting us on this. You are very anxious to get your Bill called. It doesn't have to be me; it can be your Bill, Jack. We'll take you at your word that you're for this. You've got a number of colleagues over there that have said they were... moved to override the Chair. I hope you can get them to support us on the waiving of the posting and let's go back down to Executive, get it out of Exec, come back up here and vote on it this afternoon. I hope you can rally your Members and let's see if... how sincere people really are. We're ready to go. Maybe you can get substituted in. Are you going... I assume you're going to sit here and support me on this before the Body and with the Chair."

Speaker Turner: "Representative... Representative, before he supports you, let me tell you the..."

Cross: "Well, let's see if he's going to."

Speaker Turner: "Well, it doesn't make any difference. The Executive Committee has met for this week. It's not scheduled to meet again until Wednesday at the hour of 8:30. So, that would be the earliest that we could even consider this issue, but it will not meet again today."

- Cross: "All right. Well, let's back up. You denied my Motion under House Rule 61 to take it off the table. I move to override the Chair on that Motion. And, apparently, this would be a... in my opinion, you are with us if you are for Special Elections, you're not with us if you're not, and I move to override the Chair."
- Speaker Turner: "So, the question is... the Gentleman has made a Motion to override the Chair. The question is, 'Shall the Chair be sustained?' Speaker Turner: "State your point."

- Sacia: "Ladies and Gentlemen in the Body, we have with us, in the gallery today, two distinguished folks from Galena, Illinois, Gary and Gale Appel. They are some tremendous supporters and observers of the constitutional process. Would you make them feel welcome."
- Speaker Turner: "Welcome to Springfield. Representative McCaskey. McAsey, I'm sorry, the Lady from Will."
- McAsey: "Thank you. I also rise for a point of personal privilege, if I may. I would hope that the House will join me in welcoming members from all of our districts who are down here for Lupus Advocacy Day. They are in the gallery and if you would help me welcoming them this afternoon. Thank you."

- Speaker Turner: "The Lady from Cook, Representative Yarbrough."
- Yarbrough: "Thank you, Mr. Speaker. I have for your consideration House Bill 606 which amends the Addison Creek Restoration Commission Act. It extends the repeal date from January 1, 2010 to January 1, 2015. The extension of this Act is to allow more time and proper funding to finish this ongoing project. The Addison Creek project is aimed at implementing flood control solutions to seven communities in western Cook County. I'd be happy to answer any questions."

Franks: "How is this funded?"

Yarbrough: "This was funded through an appropriation, a \$400 thousand appropriation a few years ago."

Franks: "So, this is just a... they haven't probably spent all the money and you just want some more time to spend all the money?"

Yarbrough: "Yes, that's correct."

Franks: "And was the appropriation from the General Assembly?"

Yarbrough: "Yes."

Franks: "Thank you very much."

Speaker Turner: "The Gentleman from Crawford, Representative Eddy, for what reason do you rise?"

Eddy: "Mr. Speaker, I'm sitting here a little confused 'cause I've had two different answers to relatively the same question regarding whether or not there's taxing authority. It appears as if the extension of this would continue a levy authority for this taxing body. And if there was an appropriation at the beginning of this, there might have been, but I think when you just answered Representative Franks's question, there might have been some confusion as to whether or not there is taxing authority. Clerk Mahoney: "House Bill 607, a Bill for An Act concerning State Government. Third Reading of this House Bill."

Yarbrough: "Okay. So, House Bill 607 amends the Department of Commerce and Economic Opportunity Law of the Civil Administration (sic-Administrative) Code. It requires the department, subject to appropriation, to develop and administer three pilot programs that use work therapy to assist homeless adults transitioning into employment. The whole idea of work therapy as a up and coming way of helping people who have kind of got... been down on their luck, people who are homeless and especially, veterans who

Speaker Turner: "She indicates she will."

Stephens: "Why do you say especially veterans?"

Yarbrough: "I said that this program has been very successful with veterans."

Stephens: "I'm sorry. I thought you pointed out especially veterans and I just didn't..."

Yarbrough: "No, no, no, no."

Stephens: "I didn't know if there was a..."

Yarbrough: "No. No."

Stephens: "...what the derivation of that was. Thank you."

Speaker Turner: "The Gentleman from Vermilion, Representative Black, for what reason do you rise?"

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield?"

Speaker Turner: "Indicates she will."

Black: "Representative, when you say it's been successful, has there been an audited evaluation of the program?"

Yarbrough: "Yes, there has. If you go on the Web site and you look up work therapy programs you'll see that it has been especially helpful and especially with veterans who have had substance abuse problems. And when they come back from the war they are able to help them with some of their

psychological problems and needs and also to focus their attention on soft skills to help them to transition back to the community."

Black: "Now, I'm confused. Conceptual plan, are you talking about the plan that you want to develop in Chicago or are you talking about a plan that has been utilized in other areas? Because I..."

Yarbrough: "This is a plan that's been used across the country."

Black: "Okay."

Yarbrough: "Work therapy is a plan that's been used across the country."

Black: "All right, but..."

Yarbrough: "It..."

Black: "...as far as Illinois, there's never been an appropriation, so we're not sure whether this has worked well in Illinois or not."

Yarbrough: "Well, we're hoping... we're looking at the evidence that we've seen already and how it's been successful already. And we want to bring this to Illinois to implement it in Illinois."

Black: "You have filed then, I assume, a separate appropriation Bill?"

Yarbrough: "Yes."

Black: "Okay. And what are you asking for, a little less than a million?"

Yarbrough: "Yes."

Black: "Okay. I assume that you've seen this career advancement net work?"

Yarbrough: "Yes, I have."

Black: "Okay. I'm a little concerned that the cost per participant was \$6,400, and yet it doesn't give me any audi... audited evidence of what happened to these participants. For \$6,400, how many were moved from the ranks of homeless into some kind of shelter and how many were, in fact, we're able to transition into a work... a work setting?"

Yarbrough: "What we're asking for today, is to implement the program. The numbers that you have, we'll be looking at a separate Bill, appropriation Bill, for 950 thousand to administer the work. The pilot program for homeless adults, this is about 150 people at about 6400 per person. We have not done this program in this state yet. The program..."

Black: "Right. That..."

Yarbrough: "...the program curriculum though has the model; stabilizes people in supportive housing. It gives them intensified job readiness training, it places them, you know, finally in unsubsidized job and job retention counseling. We think it's a good model and we'd like to try it in Illinois with the homeless population."

Black: "And I think the key, what I was after, we've not done this in Illinois. So it's your... it's your plan to replicate this plan that has been used in other states, but we haven't done it in Illinois as of this time. Correct?"

Yarbrough: "They have... they do have a program in Chicago that...

I visited the group there, and so they've implemented a
type of this program. We want to implement this program,

especially with... working with the west suburban PADS, south suburban PADS and possibly another group. We're looking to pilot three different programs."

Black: "How would those groups be selected? Will that be up to the Department of Commerce and Economic..."

Yarbrough: "Yes. Yes, it will."

Black: "Okay. The last question. It's for anyone who is homeless. It is not necessarily aimed at veterans, young adults."

Yarbrough: "No."

Black: "There's no age group. It's just aimed at..."

Yarbrough: "Not at all."

Black: "...homeless."

Yarbrough: "Yes."

Black: "Okay, fine. Thank you very much."

Speaker Turner: "Seeing no further questions, the question is, 'Shall the House... pass House Bill 607?' All those in favor should vote 'aye'; all those opposed vote 'no'. The voting is now open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Brady? Winters? The Clerk shall take the record. On this question, there are 103 voting 'aye', 12 voting 'no', 0 'presents'. McAsey: "Thank you. I rise to exercise a point of personal privilege. I hope that Members of the House will join me in welcoming from Lockport, from my district, teacher Jason Ozbolt and five students: Dan Howard, Margaret Knowles,

- Speaker Turner: "Welcome to Springfield. Under the order of Representative Yarbrough, we have House Bill 608. Read the Bill, Mr. Clerk."
- Clerk Mahoney: "House Bill 608, a Bill for an Act concerning appropriations. Third Reading of this House Bill."
- Speaker Turner: "Take it out of the record. Under the order of Yarbrough, we have House Bill 610. Read the Bill, Mr. Clerk."
- Clerk Mahoney: "House Bill 610, a Bill for an Act concerning criminal law. Third Reading of this House Bill."
- Yarbrough: "Thank you, Mr. Speaker. House Bill 610 has been around for the last few years and finally we've pared it back and gotten it exactly the way we want it. What it does is it amends the Code of Corrections by requiring any county sheriff to forward to the Department of Corrections any governmental issue, identification documents of a person who was committed to the department. It requires the department to retain these documents and then forward them to any institution in which the person is transferred and then make them available to the offender upon release. The purpose of this Bill is to ensure that an incarcerated individual's personal belongings are kept in the place the person is held. Upon the release, the individual would be able to immediately collect their belongings instead of

waiting for them to be forwarded. The whole idea behind this Bill is to help people to transition back into society by providing their identification at the time that they're released. I'd be happy to answer any questions."

- Speaker Turner: "The Gentleman from DuPage, Representative Reboletti, for what reason do you rise?"
- Reboletti: "Thank you, Speaker. Will the Sponsor yield?

  Representative Yarbrough, I have a question for you. I know we talked about this Bill last year. What happened to this Bill? I know we passed it out of here, what happened?"
- Yarbrough: "Well... well, let me tell you. Last year, Cook County wanted me to add keys of prescription drugs. I didn't quite think that was a good idea, but they thought it would be helpful. That didn't work out, so we stripped it back. We're dealing with strictly with identification, like Social Security cards, driver's license and identification, cause that's what I'm trying to get at."
- Reboletti: "So... I've had this concern. Some other Member's on this side of the aisle have raised the concern about an expired license. It would only be used then to make sure that they could get a new license if they we're..."

Yarbrough: "Yes."

- Reboletti: "...eligible to get one, but if it was expired they would have to turn that back in because were concerned about..."
- Yarbrough: "But if it had expired, they could take it to the Secretary of State's Office and have it renewed with the proper fee."

- Reboletti: "The only other question I have is that if it becomes revoked for whatever reason, that's where I have some concern about them possessing a revoked driver's license. But I'm sure you could work that out maybe over in the Senate."
- Yarbrough: "Well, for the most… for the most part the… well, the largest, you know, sheriff's office, of course, is Cook County and he's supportive of this Bill. They don't see… they don't see it being a problem."
- Reboletti: "All right. Thank you, Representative."
- Speaker Turner: "Seeing no further questions, the question is, 'Shall the House pass House Bill 610?' All those in favor should vote 'aye'; all those opposed vote 'no'. The voting is now open. Have all voted who wish? The Clerk shall take the record. On this question, there are 115 voting 'aye', 0 'noes', 0 'presents'. And this Bill, having received the Constitutional Majority, is hereby declared passed. Representative Mautino in the Chair."
- Speaker Mautino: "The Chair recognizes Representative Harold Murphy. On House Bill 612, Representative Chapa LaVia. Read the Bill, Mr. Clerk."
- Clerk Mahoney: "House Bill 612, a Bill for an Act concerning appropriations. Third Reading of this House Bill."
- Speaker Mautino: "The Chair recognizes Representative Chapa LaVia."
- Chapa LaVia: "Thank you, Speaker and Members of the House.

  This would appropriate for FY10 budget 2.6 million from GRF to the Department of Public Health for the Illinois Poison Center. I'll take any questions."

Speaker Mautino: "And on that question, Representative Roger Eddy."

Eddy: "Mr. Speaker, is this your first Bill?"

Speaker Mautino: "Yes, it is."

Eddy: "Would the Sponsor yield?"

Speaker Mautino: "Indicates she will."

Eddy: "Representative, the first question I have is where...
where's the poison center located?"

Chapa LaVia: "The actual entity of the headquarters is in Chicago, but it helps out in everybody's district throughout the state. In fact, it was in education committee, Elementary & Secondary Ed when Scott Ziomek came in and explained all the saves they've done, especially with three to five, as far as children throughout the state. So they serve the entire state."

Eddy: "Okay. Have you had a chance... You know, next week we're supposed to be hearing from the Governor regarding the budget and there's a lot concern. Have you heard yet from the Governor as to what the appropriation line item for this poison center is being recommended by... by his budget?"

Chapa LaVia: "No, I don't. This is a small increase in what they asked for in the last budget; however, I'm willing to cooperate with whatever number they come through on this, Representative."

Eddy: "So, you don't know... you don't know what the Governor is going to recommend in the budget for this line item, but you're willing..."

Chapa LaVia: "No. No."

Eddy: "...you're willing to cooperate with the Governor. By the way, that's very nice of you."

Chapa LaVia: "Yeah."

Eddy: "That's very nice of you to do that. Don't you think this would be more timely as an appropriation Bill, if we waited until we heard what the Governor had in mind for this appropriation?"

Chapa LaVia: "Well, I would, but I was requested to go ahead and push it forward. So, if there was any dissent from the Governor's staff they would have let me know."

Eddy: "You're confident that they..."

Chapa LaVia: "Yeah, I'm pretty confident, Representative."

Eddy: "So you expect things to be much different with the notification regarding issues related to the budget from now on?"

Chapa LaVia: "I'm sorry, clarify?"

Eddy: "What gives you that great confidence?"

Chapa LaVia: "Well, I would... I would have heard from them."

Eddy: "Okay. This is general revenue?"

Chapa LaVia: "This is general revenue."

Eddy: "Representative, in all seriousness, I think we're getting ahead of ourselves a little bit with an appropriation when the Governor's going to be addressing us next week. We have serious fiscal issues facing the state and to begin to pass appropriations Bill at this time seems just a little bit premature. I think we'd be much better off."

Chapa LaVia: "Right and I also felt that way also, but I had...

had put requests in and I didn't get any response back not
to hold this so..."

Eddy: "Are you trying to jump ahead because next week we have priority lists?"

Chapa LaVia: "No, I'm not."

Eddy: "All right. Representative, thanks for the answers."

Chapa LaVia: "Thanks."

Eddy: "I caution the Body to be careful with this kind of procedure, e though, until we know what the Governor says about this line item. We really don't know what his office wants. I do think maybe they would have contacted the Representative, but we really need to be careful with these appropriations."

Speaker Mautino: "The Chair recognizes the Gentleman from Morgan, Representative Watson."

Watson: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Mautino: "Indicates she will."

Watson: "Representative, in committee this morning you made a pretty strong point about wanting to know where the funds for a small program came from regarding veterans' affairs, and my question to you is, where you getting this money?"

Chapa LaVia: "Well, this has always been appropriated, Representative Watson, in the past and the amount of money that the state actually saves from individuals in the state being able to call the poison center is we save the state alone \$28 million from this program, otherwise it would have been affected where the child would have gone to the hospital and things like that. So, there's diagnosis by

physicians that help out parents when they don't... don't know what to do with the child, so they call the poison center first. So, it's something that is a cost savings. Now, you're..."

Watson: "Well, I understand, but where is the 2.6 million not going to go?"

Chapa LaVia: "I'm sorry?"

Watson: "Where is the 2.6 million coming from?"

Chapa LaVia: "From the general state fund."

Watson: "And what was the appropriation last year?"

Chapa LaVia: "The appropriation last year, they went from... they went from 14.8 cents capita level to 20 cents per capita level. So, I think it increased... I don't have the proper documentation to tell you 100 percent how much it was increased from last year. Hold on one second. We're checking, Representative Watson."

Watson: "Thank you."

Chapa LaVia: "While we're looking for that, I just want to clarify some stuff. The IPC Center served over a hundred thousand poison-related cases throughout the state last... last year and last budget, fiscal budget we appropriated \$1.8 million for them. And another 500 thousand was appropriated to them on top of that, but our last Governor vetoed it."

Watson: "Okay. Representative, I think... I think this... I think you know where I'm coming from. The struggle is, let's be consistent on both sides of the aisle, but also I think Representative Eddy did have a good point, how do we know where this fits into the entire scheme... to the entire mix

if somebody from the second floor didn't come and talk to you. Maybe that's their fault. I'm not saying so, but how do we know..."

Chapa LaVia: "And I explained..."

Watson: "...this isn't going to be an \$800 thousand increase that will not be available for a veterans program."

Chapa LaVia: "And I had said to you, if we need to change the appropriation based on what the Governor's staff wants to do, I have no problem with amending this. I'm more than happy to. We've let an appropriation, a couple of appropriation Bills out of here from... in the beginning. But I understand your issue, this is not a... it's not a new program, it's been in existence for quite a bit of time, so... Yeah, and it still has to go through the Senate for verification, too."

Watson: "Sure."

Chapa LaVia: "So there is... there's a couple more checks and balances before it actually gets to the Governor's desk, but I appreciate your questioning."

Watson: "I would just... again, as Representative Eddy said, I would just caution us to trickle these out before we see the whole picture. I think we may end up in a situation where we do have to come back and why... why cover the same ground twice if we could do it... you know..."

Chapa LaVia: "Well, it's a Bill that needs to be amended.

That's fine. It'll come back to us."

Speaker Mautino: "Further questions? The Gentleman from Bond, Representative Stephens."

Stephens: "Well, Mr. Speaker, to the Bill. The... as I understand it, this is about a 25 percent increase then, in what was appropriated and spent last year or in the current fiscal year. At that rate, I think what you're... we're talking about is about a \$7 billion increase expenditures for our budget in a state that's already nine or ten or eleven or some hundred billion, I don't know. The numbers are getting so big we can't get... I can't get my small mind around them. The... Why are we doing this? Speaker, this is your first time in the Chair and you're trying to spin this into doomsday. I don't get it. don't we go to a different order? There's no deadline on this Bill. Why don't we wait and see what the Governor has to say. Maybe he's got one of those quick fixes from the Never can tell. last six years that worked so well. There's no deadline here. There's no reason to be doing appropriations, not a new program. But it does infer at least that people on your side of the aisle and maybe even a few others are in favor of a 25 percent increase in spending that we can't... already can't afford."

Speaker Mautino: "Thank you. Thank you, Representative. And the Chair is attempting to run all the Bills as the Members wish and we look forward to the response from the Governor when he makes his address next Wednesday. Representative Stephens."

Stephens: "Well, I appreciate that spirit of cooperation. With that in mind, we would like to discharge from the Rules Committee that Bill about special elections."

Speaker Mautino: "The Chair will take that under advisement as we seek some discussion with Representative Black."

Stephens: "You're a gentleman and a scholar."

Speaker Mautino: "Thank you, Sir. The Gentleman from Vermilion is seeking recognition."

Black: "Thank you very much, Mr. Speaker. Will the Sponsor yield? Representative, I'm just a little bit confused. The... we used to have a regional poison control center in my area of the state but I believe it closed, I'm going to say three or four years ago, I could be wrong, because there was not funding. Where is this poison control center that you're seeking an appropriation for?"

Chapa LaVia: "Well, the poison control center, the headquarters is actually in Chicago."

Black: "Noooo."

Chapa LaVia: "And I want to go back... this is a hotline..."

Black: "Chicago."

Chapa LaVia: "...so it's throughout the whole entire state. It's an 800 hotline."

Black: "Ah, yes."

Chapa LaVia: "And it's 1-800-222-1222, in fact. But I want to correct a Representative earlier. I said earlier we had appropriated 2.4 million in last budget for the poison control center. This... the Governor vetoed 500 thousand of it. So, it's not a 25 percent increase from last year."

Black: "No."

Chapa LaVia: "I want to be clear on that. How..."

Black: "It's closer to 30."

Chapa LaVia: "No, it was 200 thousand that was..."

Black: "Oh."

Chapa LaVia: "...200... 200 thousand difference from this year."

Black: "Let's not quibble over a half a million or whatever."

Chapa LaVia: "But the poison control center is manned by nurses and physicians and anybody in the state can call in and ask, and ask, and ask, and ask for help. Seriously, with children..."

Black: "Well, if you have to ask three times I think you're in trouble."

Chapa LaVia: "...you know, swallowing poisons, older gentlemen that are married to wonderful people, swallowing something, maybe needing help. You know, things happen. But in all ser... all seriousness, I mean, lives... people that die and they have the ability to get an answer quickly from a physician or a nurse."

Black: "Yeah. No, and I... it... forgive me, I don't mean to make light of this. It is a serious topic, no question about that. I had a son... when my son was very, very young, he swallowed several aspirin. So we did use the poison control center. But I'm just... because of the closure in my immediate area I'm not familiar. Do they advertise what the number is..."

Chapa LaVia: "Yes."

Black: "...publicly or do medical professionals have the number?"

Chapa LaVia: "No, they do it publicly. And most of the offices, the representative Scott Ziomek has tried to visit and give the magnets and pamphlets on how to get a hold of them and what have you and you know, the... the IPC operation is a toll-free hotline, 24 hours, 7 days a week. So, what

it's done is taken it out of a base where someone goes to a place as opposed to just a call center to help them with immediate questions about poison."

Black: "Is this a stand-alone center or is it domiciled in a hospital or some other facility? What I'm trying to get at, Representative, the cost factor. I'm trying to figure out why they need the money."

Chapa LaVia: "Right."

Black: "I mean, that's a dumb question, I know why they need the money. But I'm trying to get at what is the expense.

Are they domiciled at a hospital?"

Chapa LaVia: "Well, it's the... those physicians and nurses aren't... aren't volunteer, they're paid."

Black: "Okay. So, they're paid."

Chapa LaVia: "They're paid. So, 24 hours, 7 days a week and it's a call center that... that is operational where if you called 9-1-1 or 4-1-1 you'd get answered by somebody immediately. You wouldn't get put on hold or a voicemail or things like that."

Black: "So are they... are they located in a stand-alone facility?"

Chapa LaVia: "They're located in the Metropolitan Chicago Healthcare Council building at 20... 222 South River (sic-Riverside) Plaza Street, 19th floor."

Black: "Is that the high rent district? I'm not familiar with River Plaza."

Chapa LaVia: "Yeah, I want to say it's by the train station downtown."

Black: "Okay."

Chapa LaVia: "By the Aetna Health Building, the tall building.

It's down there by them."

Black: "I was familiar with the river precincts many years ago.

But that's a whole other story. That goes back to the '62 election. So, it operates 24/7, 365 days a year?"

Chapa LaVia: "Yes."

Black: "Are they in imminent danger of closure or cutbacks without this appropriation?"

Chapa LaVia: "I'm not thinking; however, you know, just putting them against other national averages, which is about 22 percent per capita, like New York, Florida, Texas, California. Their poison centers receive 40... 24 cents per capita and they haven't asked for an increase for a while. But they do a really good job. Can we micromanage it a little bit more? I'm sure we could. But speaking to the individual that goes around the state and tries to give as much literature to many people in their districts, he doesn't sit there and not do work. I've seen him throughout the communities."

Black: "All right. All right, thank you very much,

Representative."

Chapa LaVia: "Thank you."

Speaker Mautino: "Thank you. This Bill is on Short Debate. We have had two Members speak in response. Representative Tracy, the Lady from Brown, why are you seeking recognition?"

Tracy: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Mautino: "The Sponsor indicates she will."

- Tracy: "Is this affiliated with the national poison center? I thought the national poison center was actually in Atlanta, Georgia."
- Chapa LaVia: "No. Well, what they do is if Illinois, if it los, this center would lose its national accreditation poison center."
- Tracy: "Okay. So, it's not the, the national?"
- Chapa LaVia: "So, no. So, without the appropriated funds IPC would not be able to meet the American Association of Poison Control Center's criteria for certification and as a result, not meet Illinois codes."
- Tracy: "Does every state have one?"
- Chapa LaVia: "I can't... I can't speak to that 100 percent. I know the states I listed earlier do. But I would assume, but I can't be 100 percent sure on that question."
- Tracy: "Do you know how it makes the public aware that this center exists, because this is the first time, I guess, I realized we had one other than the national, which this isn't the actual national poison center."
- Chapa LaVia: "Right. The toll-free number is in all phonebooks throughout the state. However..."
- Tracy: "But is that... is that for the state one or the national one?"
- Chapa LaVia: "The state one. The poison help... it has a little pill with a little x of the skeleton on it."
- Tracy: "Well, I've called that one and they say they're in Atlanta, Georgia."
- Chapa LaVia: "The 1-800 number?"
- Tracy: "Well, the one that's in my phonebook."

Chapa LaVia: "Okay. Well, I have no problem with getting it coordinated and make sure that... to make sure how many people he has visited with boxes. But he... when he goes around, when Scott Ziomek goes around to everybody's individual districts he wants to talk to the Representative or the Senator. So if they're not there he doesn't leave the stuff, 'cause he takes upon himself serious to get it to you and let you know all about the center. So, I have no problem with contacting him after this debate and making sure that that's done."

Tracy: "Well, to the Bill. I was not aware the state had a poison control center. I know we have a national control center and it seems to me that we might be duplicating what can be accomplished already through the national center. I've called the national center, having raised four children and dogs that eat crazy things all the time, more than one occasion and never had any trouble getting to... get a qualified person. I just think in these tight financial times we have to analyze and look at everything and so, I don't know why, I mean, I just can't support this Bill at this point in time, not knowing if it's duplicative and if we could save the entire expense."

Speaker Mautino: "Representative Chapa LaVia."

Chapa LaVia: "Part of it also, Representative Tracy, is the IPC is a key component within Illinois disaster and emergency response infrastructure. So, it's part of the department's response... first responders, if you will. It's integrated with the public health and the first responder agencies to provide surge capacity. So, if there's something that

fails in there they have overflow of the other agencies as well as far as disaster. So, they just don't cover poison, they cover a couple of other elements. But it's actually within their infrastructure of the Illinois disaster and emergency response, also. So, I understand your issue. But I don't know why you didn't hear about it and you've been using services... I will talk to the gentleman and see what's going on in the area down where you live."

Tracy: "Well... oh, thank you. And I... from my analysis I didn't see anything about the emergency disaster and I don't know what the breakdown is. So, there again, I just can't support this Bill at this time."

Chapa LaVia: "That's fine."

Tracy: "I think the theory is great."

Chapa LaVia: "After this I'll go over there and I'll give you the paperwork so you can contact them if you want to, so you can hear from the center and have them come and give you a briefing."

Tracy: "Okay. I would just prefer to wait to vote on this, as has been previously mentioned, until we get a better handle on the whole budget."

Chapa LaVia: "Thank you."

Tracy: "Thank you."

Speaker Mautino: "No other Members seeking recognition on House Bill 612, the question is, 'Shall this Bill pass?' All in favor vote 'aye'; opposed vote 'no'. And the voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative Hamos, Tryon. Mr. Clerk, take the record. On this question there, are 75
