Speaker Madigan: "Roll Call for Attendance. Representative Currie."

Currie: "Thank you, Speaker. Please let the record reflect the excused absence of Representative Golar."

Speaker Madigan: "Mr. Bost."

Bost: "Thank you, Mr. Speaker. Let the record reflect that Representative Jerry Mitchell is excused on the Republican side of the aisle and we're looking forward to an awesome day."

Speaker Madigan: "Mr. Clerk, take the record. There being 115 Members responding to the Attendance Roll Call, there is a quorum present. Ladies and Gentlemen, if everyone could take their seats, we have a very, very significant ceremony today. As you know, we're going to unveil the portrait of former Speaker, Lee Daniels, who is right next to me on the podium. Let me just say that Lee and I worked together, sometimes against each other, for many, many years. And Lee, I did the math here and I think you became the Minority Leader in '83 and you served all... as Minority Leader until '02 and then in '95 and '96 Lee served as the Speaker of the House. And I would say that he was a very, very competent, effective Leader, both as a Minority Leader and as a Speaker. I know; I was there. We had our differences, but there's one thing that people like me and President Cullerton and former Governors would say that, yes, there were a lot of differences, but when we would sit down and negotiate a settlement and it was time for people to go to work and get votes for the settlement, Lee Daniels went right out, did his job, got his votes. And for that,

Clerk Bolin: "House Resolution 132.

- WHEREAS, The Honorable Lee A. Daniels was elected to serve sixteen terms, from January 1975 until January 2007, in the Illinois General Assembly as the State Representative of DuPage County; and
- WHEREAS, The Honorable Lee A. Daniels was elected by his peers and colleagues in January 1983, to lead the House Republican caucus in the Illinois House of Representatives, thus making him the House Republican Leader; and
- WHEREAS, Lee A. Daniels led his fellow Republicans for 20 years, from 1983 until 2003, which was a period in which both DuPage County and the entire State of Illinois experienced tremendous challenges but also great prosperity; and
- WHEREAS, As the leader of the Republicans in the Illinois House of Representatives, Lee A. Daniels was a part of a long line of Illinois political leaders dating back to Abraham Lincoln, who occupied the same position on behalf of the Whig Party in 1838 and 1839; and
- WHEREAS, Lee A. Daniels was honored in January 1995 when his colleagues elected him to the position of Speaker of the Illinois House of Representatives for the 89th General Assembly; and
- WHEREAS, The 89th General Assembly leadership of Lee A.

  Daniels as Speaker of the House was marked with

  path-breaking achievements in Illinois history, including

the reorganization of the Chicago Public Schools, passage of a charter school law, the reorganization of the systems of Illinois higher education, the extension of property tax cap opportunities to cover all 102 Illinois counties, expansion of the system of registration for sex offenders, public assistance reform, and a statewide program of help for persons with developmental disabilities that has received nationwide honor and recognition; and

- WHEREAS, In recognition of his leadership as Speaker of the House, the Illinois State Capitol will from now on contain a permanent portrait memorial of the Honorable Lee A. Daniels, so that the people of Illinois can recognize and remember his life and public service; therefore, be it
- RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we congratulate the Honorable Lee A. Daniels upon the occasion of the unveiling of his official portrait; and be it further
- RESOLVED, That a suitable copy of this resolution be presented to the Honorable Lee A. Daniels as a permanent reminder of this ceremony."

Reboletti: "Thank you, Speaker Madigan and to Speaker Daniels.

Ladies and Gentlemen of the Body, I have the pleasure of serving as a successor to Speaker Daniels. Little did I know, that when I was six years old, that Speaker Daniels began his career in the General Assembly, but little did I know later on, as I wanted to follow a career in public service, that he would become a mentor and a friend. And then we look at all the growth in the businesses throughout the area and to the leadership that he brought to the state. And today truly is an awesome day that we recognize one of the icons of State Government, referred to as one of the four tops for many saw negotiations happen down here vears, as we Springfield, and I was just a student at Eastern Illinois fascinated by the process. But I never thought I would be in the position here to be able to address both of you to all the work that you have done for the state. I know Lee's passion for his family. Speaker Madigan: "You've all heard the Gentleman's request. Is there leave? Leave is granted. All Members will be added as cosponsors to the Resolution. Mr. Reboletti moves for the adoption of the Resolution. Those in favor say 'aye'; those opposed say 'no'. The 'ayes' have it. The Resolution is adopted. It's now my great pleasure and honor to give you Speaker Lee Daniels, who will proceed to help us with the unveiling of the portrait."

Speaker Daniels: "Thank you. The Speaker just said, feels good, and I said, yeah, I really liked the two years I was Speaker. The trouble is he dethroned me after that short time. Well, thank you all. You honor me, but you honor yourself, because this august Body is one that is the greatest in the world, a great, deliberative Body, one that has awesome responsibility for what you do and for all of that I thank you for all your hard work that you are going to go in today, tomorrow, and in the future. Speaker Madigan and Leader Cross and Members of the Illinois House, I thank you for this honor, and this chance to once again remind myself what a privilege it was to not only serve as a Representative from the 46th Legislative District, but also to serve as a Leader on the Republican side and the Speaker of the House for two years. But I do want to pay a special remark to my friend, Speaker Madigan, and how nice it is to call him my friend, Speaker Madigan, because Mike many times, although we were adversaries, we always knew that we had to get our job done. We always knew that at the end of the day we had to come together for the benefit of the people of Illinois and to deal with the issues of state. I can think of no time that we've had a harder job than we do today: the budget, the debt, challenges that we have. And of course, serving the great people of the State of Illinois, they expect it, they deserve it, and they need to have your constant vigilance and your attention. Where these are challenging times that each of us has to deliver our own priorities in life, I implore you and ask you to not forget the community as Abraham Lincoln observed of people that cannot do for themselves but depend upon your help. I have found my years here that there's not a single Legislator from the northern, western, eastern, or southern part of Illinois that doesn't truly care about people that need our help and have great compassion for people that have suffered as no fault of their own. Now is the time that we are calling for leaders to step forward, to demand that government continues its help to them, and expand that help all categories whether it's in help... of health, education, or welfare, we need to be there for them. I ask you to remember that and I thank you as you meet Illinois' challenges which are so profound today that you may think at times that we're faced... what we are facing are nearly insurmountable. I've been there. I know the problems, but I will tell you they are not insurmountable. Each one of you is a leader in your own right - that's why you are there... that's why you are here. Those of us as citizens of this state need your assistance now more than ever. So, let me

McAsey: "Thank you, Mr. Speaker, Members of the House. House Bill 1466 is a Bill to address Internet safety education in our schools. What it's doing is bringing the curriculum where... rather the... the safety education curriculum up-to-date with today's technology by simply making sure that instruction includes safe and responsible use of the Internet. It brings it in line with texting, different technologies that we have today. This is not a new mandate on schools. It's bringing current practice in line with current technology. And I would ask for the support of the Members of the chamber."

Speaker Mautino: "The Lady moves passage of House Bill 1466.

And on that question, the Gentleman from Knox,

Representative Moffitt."

Moffitt: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Mautino: "She indicates she will."

Moffitt: "Just a... at one point there were, I think, at least one opponent. Have they removed their opposition? And I ask again if maybe you could say why. I... probably they viewed it as a... maybe a mandate. But would... could you address it? Are there any opponents?"

McAsey: "I'm unaware of whether individuals who had filed in opposition in committee have removed their opposition.

There was not any oral testimony from opponents in the

committee. This did pass committee unanimously. What I would suspect is that individuals would possibly think that this is a mandate on schools, but I would reiterate that this is not a new mandate on schools, that this is an insertion within the existing Internet safety curriculum to make sure that it's inline with our current technology that we're protecting our kids."

Moffitt: "Okay. I appreciate your response. Obviously, we all have that same objective of protecting kids. I just was... wasn't sure why there had been at least one organization that listed as an opponent, but again, I'm... probably assume it was that potential that it was an unfunded mandate. Thank you for your response and I agree with what you're trying to do."

McAsey: "Thank you."

Mautino: "Further discussion? The Gentleman from Crawford,
Representative Eddy."

Eddy: "Thank you. Would the Sponsor yield?"

Mautino: "She indicates she will."

Eddy: "Representative McAsey, I think you nailed this, but I want to make sure for the record. The... the understanding is that this is not an additional mandate, but a clarification and actually adds some specificity to the mandate that exists already for age appropriate curriculum for Internet safety instruction."

McAsey: "That is absolutely correct."

Eddy: "Okay."

McAsey: "This is not a new mandate on schools. This is specificity with regard to making sure that our students

are being instructed with regard to risk and consequences in dissemination and transmission of sexually explicit images and videos within that existing curriculum."

Eddy: "Okay. Thank you. Ladies and Gentlemen of the House, I think that from time to time it doesn't hurt us to revisit some of the public policies that we've established regarding requirements in curriculum and make sure that those requirements are up-to-date. All this does is include new types of video and other types of devices to the existing curricular mandate that's been around a while for students to get some instruction on the danger of Internets and what Internet safety is like. So, I would urge people to support this. It's reasonable and she's worked very hard to make sure it's not an additional cost or mandate for schools."

Speaker Mautino: "No one seeking further recognition? The Lady moves that House Bill 1466 pass. All in favor vote 'yes'; opposed vote 'no'. Voting is open. Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. 115 voting 'yes', 0 voting 'no', 0 voting 'present'. House Bill 1466, having received the Constitutional Majority, is declared passed. House Bill 1485, Representative Rose. Mr. Clerk, read the Bill."

Clerk Bolin: "House Bill 1485, a Bill for an Act concerning State Government. Third Reading of this House Bill."

Speaker Mautino: "Representative Rose."

Rose: "Mr. Speaker, if we could move that to Second, for purposes of an Amendment, please."

"Thank you, Mr. Speaker. Last year this Body, pursuant to House Bill 5124, which took effect as probably like 96-1141, created a commission and a task force to look at how we deliver services to the disabled, mentally ill. It was a bipartisan issue. I was the House Sponsor here and Senator Bond was the Senate Sponsor. This is one of several Bills came out of that summer/fall task force essentially would recreate it moving forward. There were a number of recommendations that were made, legislative, some are rulemaking, some they didn't need either. The departments could just go ahead and do them anyway. The departments are moving forward on that. This would sort of reconstitute the task force to keep this process moving forward. I believe it's agreed to by everyone at this point and we expect Senator Crotty in the Senate will be carrying it again in a bipartisan fashion. So, would ask for favorable passage as we did the original Bill last year."

Speaker Mautino: "The Gentleman moves passage of House Bill 1488. All in favor will vote 'yes'; opposed will vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish?
