Speaker Mautino: "The hour of 10:00 having arrived, the House will be in order. Members and guests are asked to refrain from starting their laptops, turn off all cell phones and rise for the invocation and Pledge of Allegiance. We shall be led in prayer today by Pastor Shaun Lewis who is the Illinois State Director of Capitol Commission, serving the political leaders of Illinois. He is the guest of Representative Brauer. Pastor Lewis."

Pastor Lewis: "You'd bow with me in prayer. Father, it's good to pause and in the silence of this brief moment look to You before Session begins today. It's Friday and I know many here are eager to rest and enjoy time with their families. Help them to focus this morning on the tasks at hand and give them the time away from Springfield that they Thank You for the service of our lawmakers. I know many of them personally on both sides of the aisle who want to serve well. Their disagreements at times are great, the debates can be heated but give each one here humility to be corrected, courage to stand on conviction even when it's not popular. Above all, bless the Members of this House to the... to the degree that they uphold what is found in Your word, the Bible. May they become well acquainted with this book, meditating upon it day and night, being careful to do what is written in it. Pray that in the name of Jesus, Amen."

Speaker Mautino: "We'll be led in the Pledge today by Representative Lisa Dugan."

Dugan - et al: "I pledge allegiance to the flag of the United States of America and to the republic for which it stands,

- one nation under God, indivisible, with liberty and justice for all."
- Speaker Mautino: "Roll Call for Attendance. Majority Leader Currie."
- Currie: "Thank you, Speaker. Please let the record show that Representatives Hernandez and Soto are excused today."
- Speaker Mautino: "The Gentleman from Jackson, Representative Bost."
- Bost: "Thank you, Mr. Speaker. Let the record reflect that Representative Beau... Representatives Beaubien, Mulligan and Sosnowski are excused on the Republican side of the aisle today."
- Speaker Mautino: "Mr. Clerk, take the record. 111 voting 'present', a quorum is present and the House is prepared to do its work. Mr. Clerk. On page 22 of the Calendar appears House Bill 1857, Representative Lang. Mr. Clerk, read the Bill."
- Clerk Bolin: "House Bill 1857, a Bill for an Act concerning local government. Third Reading of this House Bill."
- Speaker Mautino: "The Gentleman from Cook."
- Lang: "Thank you, Mr. Speaker, Ladies and Gentlemen. There's an antiquated law that only applies to the Cook County Water Reclamation District which prohibits the members of that board from being involved in any political activity whatsoever on their free time. The first Amendment would require that we change this law which was written way back in the '30s. I ask your support."
- Speaker Mautino: "The Gentleman moves passage of House Bill 1857. No one seeking recognition, all in favor will vote

'yes'; opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Representative May, Sommers, Stephens, Acevedo, do you wish to be recorded? Mr. Clerk, take the record. 86 voting 'yes', 25 voting 'no', 0 voting 'present', House Bill 1857 is declared passed. Page 19 of the Calendar appears House Bill 171, Representative Thapedi. Representative Thapedi. Mr. Clerk, read the Bill."

Clerk Bolin: "House Bill 171, a Bill for an Act concerning public health. Third Reading of this House Bill."

Speaker Mautino: "Proceed."

Thapedi: "Thank you, Mr. Speaker, and Members of the House. This is House Bill 171. We've talked about this quite a bit. This deals with smoking in casinos. I think it's very important to note that the difference here with this particular Bill is we're creating smoking optional rooms. Smoking optional rooms, state-of-the-art rooms, ventilation systems, this is ready to go. We heard from Mr. Burke earlier on his Bill. This is far more narrowly crafted. And I ask for your support on this particular provision."

Speaker Mautino: "The Gentleman has moved passage of House Bill 171. On that question, Representative Eddy."

Eddy: "Thank you. Will the Sponsor yield?"

Speaker Mautino: "Indicates that he will."

Eddy: "Representative, you mentioned in your opening remarks that there would be created... you referred to them as smoking optional rooms."

Thapedi: "Yes."

Eddy: "Can you... can you expand and give us the practical application as to how that would... would work?"

Thapedi: "Certainly. I can use the House Floor as an example.

Let's assume that our desks are all gaming positions in a casino and then we have the two anterooms on each side of the chamber. Imagine the anterooms being segregated separated rooms as they are, separate ventilation systems and gaming is going on inside of those rooms. That's the best explanation that I can use or at least explain to you by using a demonstrative exhibit of the House Floor as an example."

Eddy: "Okay. So, what about the basic argument that everyone is affected and... and employees of... of the casino is obviously, I mean... I mean I get your description...

Thapedi: "Sure."

Eddy: "...but what about employees?"

Thapedi: "And I think that if you look at the actual language in the Bill, employees are protected as well and in fact, that was of paramount importance to me that before an employee would be permitted to work in a smoking optional room they would have to apply separately to work in the smoking optional room and in addition, they must also sign an acknowledgment acknowledging the danger and the harmful effects of secondhand smoke which is uncontroverted."

Eddy: "So, the mechanism... the text of the Bill contains a mechanism that an employee would opt in?"

Thapedi: "If you look at the statute... Can you look at it?"

Eddy: "Yes."

Thapedi: "And I think that it speaks for itself."

- Eddy: "Well... well, how is an employee protected, for example, that... I mean, whenever you staff any organization you're going to have a certain number of people that... what if nobody opts in? What if everyone in that organization says we don't want to work in that environment?"
- Thapedi: "I guess it would be the same as an asbestos removal company or coal miners. If coal miners chose not to work in the coal mines or if asbestos removers decided not to remove asbestos, it would be the same scenario. I don't know if these are real questions or we're just kind of extending it out for a little bit more time."
- Eddy: "What part of this has to do with the economic impact that the loss of these... this option has had on the industry?"
- Thapedi: "And... and again, I think that if you look at the notes, and you'll see that there are several notes on this particular Bill, and those notes were requested by me personally to make sure that I had a full financial picture of what we're faced with. And I think that you'll recall when Representative Burke ran his Bill I think that he quoted numbers in the hundreds of millions of dollars and there's no question that the State of Illinois has lost hundreds of millions of dollars. COGFA has come up with opinions after the amounts of money that we've lost. In fact, the Federal Reserve Bank in St. Louis earlier this year did their own independent study and opine that Illinois is losing roughly about \$200 million per year."
- Eddy: "Representative, I know this isn't your issue but there are those of us that feel like that same problem has

occurred for clubs, organizations, American Legions, some AMVET facilities. And I represent a border area and I have business folks that... that talk to me all the time. Is there any reason you didn't take into consideration those additional entities that claim the same loss?"

Thapedi: "I... I take a little dispute with... with your statement I did in fact take because those entities consideration; however, all I could rely upon is the empirical data. I don't have any empirical data that shows the amount of losses that those particular entities are losing as a result of the Smoke Free Illinois Act. And I should add, if you actually look at the language of the statute as it exists today there are several enumerated exceptions there. I think that you'll also notice, if you'll take the opportunity to look at the statute that you're questioning me about, that there is one particular provision there and I believe it's a subsection 3 that's listed as a blank which would lead us to believe that another exception was anticipated or over the course of the years, there's been movement in those exemptions. This is very straightforward, Representative."

Eddy: "Well, I... I'm not sure what I want to do, but I'd feel a lot better if we were carving out exceptions for other types of groups as well."

Thapedi: "Sure."

Eddy: "I know why you're doing this..."

Thapedi: "Sure."

Eddy: "I get that. I think it's important to that industry..."

Thapedi: "Sure."

Eddy: "...but it's just as important to those other indus...
industries."

Thapedi: "Well... well and I agree with you. It is important to this industry, but I think the question is, here in Illinois we're \$15 billion in debt. We have to come up with innovative ways to raise money. This is something that we're not raising money on the backs of poor people and in fact, you may recall, Representative, that yesterday the gallery was filled with African American seniors that came down here from the south side of Chicago and they were here because they are fighting to keep vital programs like Circuit Breaker, Illinois Cares Rx those types of programs intact and we're telling them that we don't have adequate money in order to fund those particular programs. Here's one solution. It's not perfect, but it is a solution."

Eddy: "Representative, I appreciate what you're doing. I understand the purpose and I actually support the concept. I want to wait and see what happens with the rest of the debate, but again, I would feel more comfortable if we took a broader approach. But I appreciate where you're coming from. Thank you."

Thapedi: "Thank you, Representative."

Speaker Lang: "Representative Lang in the Chair. The Chair recognizes Representative May."

May: "Thank you. Will the Sponsor yield?"

Speaker Lang: "The Gentleman yields."

May: "Yes. Thank you. Just of... I have the utmost respect for you. I know you're a very healthy person; you've got good lung capacity. I've found that as I've met you on the

tennis court and so $I\dots$ I know that you are healthy and fit. I'm very concerned. Were you here when we passed Smoke Free Illinois?"

Thapedi: "I was not."

May: "Okay. Well... I... I was. I'm one of those old-timers and was instrumental in fighting for it. My question to you is, you're going to have separate rooms. Are there completely separate ventilation systems for these rooms bringing in fresh air from the outside not just recirculating from the smoke rooms?"

Thapedi: "Absolutely. The objective here is to have state-of-the-art ventilation systems and a state-of-the-art room and please keep in mind that it's important for me to make this very clear to you, Representative, that the casinos have indicated to me that they're willing to make the investment to create this state-of-the-art facility. Under no circumstances and if you'll look at the language in the Bill, under no circumstances can secondhand smoke come out of those rooms. So, I used the anterooms as an example. Smoke would not be permitted to come out of those anterooms. That would be completely contrary to the law."

May: "How do you seal the doorways?"

Thapedi: "Well, there's several different ways to do it. Think about from a construction standpoint. If you have the anteroom there as we see and if you have yet another interior room there to block it off, it can be done. I mean, I have a lot of confidence in our architects and our construction people to make sure that it can be done and they'll comply with the law."

May: "Has the casino industry shared with you how much this will cost per facility?"

Thapedi: "They have not shared with me the cost, but they tell me that the cost that they are losing as a result of the smoking ban here in Illinois is not even close."

"Okay. Thank you, Representative. I'd like to move on to May: Because some of our good health the health care costs. care groups the Lung Association, the Respiratory Health Association have shared with me that the state has saved money. The state has saved money on health care costs since we've passed Smoke Free Illinois. So, I really question, although I... I know you're a very smart and savvy Legislator so you got these notes, but I don't know how the Department of Public Health can say that there is no impact on the health when we have seen health care costs go down. guess I don't also understand the fiscal notes so while you were very wise to request these notes I am sorry I don't have at my desk at this moment what has been shared with me by the Department of Public Health and our good health care advocates who oppose this why it will cost us more in health care costs in the long run. So I... I have those ... those deep concerns about this. I think that you have worked hard and you have crafted something that perhaps is the least offensive of any Bills to give exceptions to Smoke Free Illinois and I expect that of someone as bright as dedicated as you are. But I do think that it is going to increase health care costs. I do also believe that while employees have a choice if they may feel the pressure that if they say they don't want to work there and there is a

staffing problem, there may be pressure to say that they want to work there. So while it is not you, it is the Bill you are carrying reluctantly, I have to stand against this Bill and vote against it for health care reasons and the concerns of pressure on employees. Thank you."

Speaker Lang: "Representative Harris. Sorry, Representative, was there a response for Mr. Thapedi?"

"I wanted to respond to the last statement and I'll be Thapedi: very brief. And I do empathize with Representative May, who I have quite a bit of respect for, that we've worked together on other issues and in fact, we have played tennis together. But I think you should note here that the Department of Public Health did render an opinion with respect to cost that would be impacted by the State of Illinois and they say and I'll quote them, 'House Bill 171 would not have a financial impact on the Department of Public Health.' I think that's because this particular Bill does not encourage or promote smoking. Those who choose to smoke are going to smoke. There's nothing that we can do about that, but if we do have documentary evidence that we're losing hundreds of million dollars as a result of people making that choice, I don't see why this proposition is problematic."

Speaker Lang: "Members, this Bill is on Short Debate and since we didn't start with the timer, we won't use it on this Bill, but since we already debated smoking in casinos perhaps the Members could show some restraint on this Bill. Representative David Harris."

Harris, D.: "Thank you, Mr. Speaker. And I will certainly show restraint as directed by the Chair. I have a question of the Sponsor?"

Speaker Lang: "The Gentleman yields."

Harris, D.: "Representative, it seems to make sense that since we passed Representative Burke's Bill that we would pass this Bill. Let me just make sure I understand. Representative Burke's Bill had no pro... no provisions whatsoever for smoke free areas within the casinos, correct?"

Thapedi: "None. None."

Harris, D.: "So, what you're doing is you are mandating that there be smoke free areas within the casinos?"

Thapedi: "Absolutely."

Harris, D.: "Okay."

Thapedi: "I... I'm carving out sections of the casino, segregated ventilated smoking optional rooms, unlike Representative Burke that was an outright lift of the ban in casinos."

Harris, D.: "Right. And it's my understanding that given the impact, the financial impact that casinos feel they've had from the no smoking..."

Thapedi: "Yes."

Harris, D.: "...prohibition that I think the casinos are probably willing to invest in needed... needed funds to make these... these modifications."

Thapedi: "Yes. And they have made that clear to me that in light of the losses that they're sustaining that they would be willing to make the business decision that this would be something they would look into."

Harris, D.: "Right."

Thapedi: "Of course, from a financial perspective I believe that the casinos would tell you that their preference is obviously, Representative Burke's Bill because that wouldn't require them to make any capital investments in their structures but this Bill obviously does."

Harris, D.: "Right. Now, so, this might be better than Representative Burke's Bill in that respect; however, you do make a big change from Representative Burke's Bill. As I understand, Representative Burke's Bill only deals with the Riverboat Gaming Act. Your Bill deals with both the Riverboat Gaming Act as well as the Illinois Horse Racing Act..."

Thapedi: "That's correct."

Harris, D.: "...which means you anticipate if slots should go in at the racetracks, then the racetracks have the ability also to have these... these facilities."

Thapedi: "You're absolutely correct."

Harris, D.: "Okay. Do you have any sense that these racetracks, which in my estimation are not in as good a financial condition as the casinos, that they are willing to make that same substantial investment of dollars to get these sorts of facilities in place."

Thapedi: "And I must tell you, Representative, that I don't know the answer to that question and you would probably know the answer better than I 'cause I believe that you're from the Arlington Heights area that has a racetrack, so perhaps maybe you can give me some insight on that issue. I have invited the racetracks to discuss this matter with

me. They have shown great interest. However, as far as making an investment in a state-of-the-art facility, as we both know, the racetracks are... are clearly, clearly strapped for dollars and I don't think that they're in a position now to make the commitment to build these smoking optional rooms, but again, the law as proposed would give them that option."

Harris, D.: "Yeah. Thank you for your direct answers and just very briefly to the Bill. The Gentleman's approach I think is a good one based on what we've done with Representative Burke's Bill, but there is a significant change because we no… we now are indeed widdling away at the no smoking ban because now we're expanding it to… to racetracks. Presumably it could… could come to other facilities as well with future Bills. So, the Members need to be aware that this does not just impact casinos but also the possibility of racetracks, if we… if we put the slots at the racetracks. Thank you, Mr. Speaker."

Speaker Lang: "Representative Yarbrough."

Yarbrough: "Thank you, Mr. Speaker. Will the Gentleman yield?" Speaker Lang: "Gentleman will yield."

Yarbrough: "So, Representative, could you tell me what your Bill does?"

Thapedi: "I believe that we've talked about this at length, Madam Leader. This this particular Bill allows casinos and racetracks, if they choose, to build smoking optional rooms in the casinos or in the racetracks. And I should point out that these must be enclosed smoking optional rooms and please don't confuse what I am proposing today with what we

see in airports. The smoking rooms in airports, they don't work. That's clear. The scientists have done detailed studies on these smoking rooms in airports, they do not work. I'm talking about something that is state-of-the-art that the casinos have indicated to me that they are willing to make the capital investment to make this a reality and save hundreds of millions of dollars for the state."

- Yarbrough: "So, these are going to be enclosed... enclosed areas you're saying and it's going have some kind of ventilation system?"
- Thapedi: "It will have state-of-the-art ventilation system, yes."
- Yarbrough: "And so, have you talked to anybody about... from anywhere about how that would work and if it actually removes all the carcinogens that would be in the air in that room?"
- Thapedi: "Yes. Actually we... we discussed this matter and we vetted it out very thoroughly in... in committee. And I provided each of the Members on the Executive Committee with information from a company and I don't want to give them a free plug, but a company that indicates that they do have the ability to remove all of the harmful affects of secondhand smoke. Now keep in mind, it's not going to get rid of every single micro particle; it's not going to do that and I would defer to some of the professors that are here on the floor to give me some assistance on that but I don't think that in any event that you can actually do that."

- Yarbrough: "So, then, Representative, by your own admission these rooms still would not be... free of cancer causing carcinogens that would affect someone's health?"
- Thapedi: "I don't think that the House Floor is 100 precent free of carcinogens that would protect people's health, but I think that what we're proposing here and what the scientists tell me and what these construction people tell me is that they do have the ability to construct such rooms."
- Yarbrough: "Well, it's my understanding there's no technology or any kind of apparatus that would do that. Now the second thing I want to ask you about, I want to talk about these waivers. So, you... you say that people who work in casinos will have to sign a waiver that they understand that they're in a room that could cause them to have cancer or... tell me how that works."
- Thapedi: "Well, what's contemplated here is something similar to what, and I've used this example before, coal miners. Coal miners that are working in the coal mines. Asbestos removers that are removing asbestos. Those are dramatic examples but what we're contemplating here with this particular piece of legislation is that employees that want to work in the smoking optional room, because health care is obviously a major consideration, we want to make sure that they know and that they recognize the harmful effects of secondhand smoke, and in fact, I even made this invitation during the committee that if the Smoke Free Illinois folks that I think that you're probably reading a script from them, if they have something that they would

like to include in the acknowledgment I'm more then happy to include that in there 'cause I think that is something that's important."

Yarbrough: "So, Representative, in this economy when jobs are at a premium people are going to have to make a determination on whether they can feed their families or their health could be at risk on... in their workplace. Is that what you're suggesting here?"

Thapedi: "Would you repeat your question again? It's a little loud on the floor."

Yarbrough: "People who will sign these waivers will have to make a decision on whether they want to feed their families and keep their jobs and... opposed to their health. They're going have to make that kind of decision?"

Thapedi: "That is certainly not the legislative intent here.

Certainly not that..."

Yarbrough: "Okay. To the Bill, Mr. Speaker.

Thapedi: "...and in fact... and in fact, if I may."

Yarbrough: "To the Bill, Mr. Speaker."

Thapedi: "I would assume that there would be some croupiers and some people that work in the casinos that actually smoke and they would not have a problem working in the smoking optional room."

Yarbrough: "To the Bill Mr. Speaker. Mr. Speaker, to the Bill."

Speaker Lang: "Representative, to the Bill."

Yarbrough: "As you know, another Bill left out of here and went over to the Senate; I'm not sure what's going to happen to that Bill. We passed a comprehensive Bill in this... in this

chamber in this state; it was a good Bill. It addressed the health concerns and that's where we've been. We're concerned about people's health. I understand there's only about 20 percent of people in the State of Illinois that even smoke. This is not about smoker's rights; this is about workplace safety. I urge a 'no' vote. And Mr. Speaker... Mr. Speaker, if this gets the requisite number of votes, I'd like a verification."

Speaker Lang: "That will be acknowledged. Representative Williams."

Williams: "Will the Sponsor yield?"

Speaker Lang: "The Gentleman yields."

Williams: "I want to go back to the issue of the casino workers and taking a look at this from the workers' perspective."

Thapedi: "Sure."

Williams: "The language in the Bill discusses... I think I'll read from the Bill. 'The room is only accessible to persons who have requested in writing to have access to the smoking room.' How do you contemplate this working?"

Thapedi: "That would be something that I would leave to the casinos and also to the racing board and the gaming board to work on that to ensure that... that can become reality. Please understand the legislative intent, very, very carefully crafted, very specifically crafted. We definitely would anticipate that the gaming board and the racing board would be involved in addressing the issues that I'm sure that you're going to present to me now, Representative and that Leader Yarbrough just mentioned earlier."

Williams: "Well, it's my understanding that many people that work at casinos in Illinois have already signed a waiver when they first were employed and hired and that waiver said something to the effect that I will not hold the casino workplace liable for working in a smoking environment because many of these people started working at the casino when, in fact, you could smoke in the casino. So, I'm wondering if this Bill contemplates or if we should contemplate, maybe by rule, requiring a new affirmative request to work in these smoke filled rooms. Because otherwise I think there's a big issue with employees being retaliated against."

Thapedi: "Absolutely, Representative, and I appreciate what you recommended. I think that that's something that we definitely would want to incorporate either by rulemaking authority or in fact, if we want to make that change over in the Senate I'm happy to do that because, please understand, that my motivation here is recouping hundreds of million dollars that we've lost here in Illinois at the same time balancing the health care consideration of employees. That's an excellent recommendation that you've made and I'll definitely incorporate that as the process moves along."

Williams: "Okay. So, to reiterate, we're contemplating a new affirmative request to work in the rooms and the waiver that's already been signed. Is this outside of the scope of the waiver that's already been signed?"

Thapedi: "Absolutely. In fact, I specifically asked members in the casino industry whether or not that was the practice in

the casino industry to have employees sign waivers. They tell me that they do not do that. So, again, the thought process was, was that I was going above and beyond the call of duty, but now that you've brought up something that I heard as well, I think a second affirmative act is definitely in place and would definitely be consistent with the legislative intent."

- Williams: "And along those lines, would you consider or contemplate the idea or have you contemplated the idea of a provision either in the law or in the rulemaking process that would provide that employees cannot be retaliated against for opting not to... to work in the smoke filled rooms? I mean, it may be hard to fill those rooms with dealers and other workers."
- Thapedi: "I... I'm happy to do that as well. Whatever will take into consideration the health and the safety of workers clearly that's something that I would want to do. I would anticipate that OSHA and some other regulations would cover that issue, but again, I'm perfectly happy to put in additional safeguards."
- Williams: "Okay. To the Bill. To the Bill. I... I think that the reason this issue is so troubling is that we have gone out of our way to recognize the terrible impact that secondhand smoke has on our workers and patrons of businesses throughout the state enough that we've passed a smoking ban and I... celebrated along with many people in Illinois when the smoking ban passed. I never contemplated that I would be back here voting on this exact same issue. I'm also going to challenge the idea that if you are a

casino worker or worked in a casino you ever contemplated that the job you'd be doing was akin in any way to the type of job in a coal mine or dealing with asbestos. It... it just shouldn't be that way and I don't think the workers anticipated they would be dealing with that sort of health hazard especially when they did celebrate along with many of us when the ban was enacted. I appreciate your consideration of my questions. And I would urge an 'aye...' a 'no' vote on this Bill."

Speaker Lang: "Representative Reis."

Reis: "Inquiry to the Chair."

Speaker Lang: "State your inquiry, Sir."

Reis: "We've started a process this week where appropriations is downstairs meeting with their important decisions and I don't want to make light of that not happening, but there are probably 20 Members that are not on the floor. And how we going to do verifications and Roll Calls for next week..."

Speaker Lang: "My understanding, Sir, is that that group has suspended and they're on their way up here but your point is well-taken, but on the other hand, people have a right under the rules to request a verification."

Reis: "Absolutely, but I mean, I didn't know if we were going to do this for next week as well. Maybe we can do these appropriation meetings early in the morning or late in the evening just..."

Speaker Lang: "I'll pass your... question along, Sir. The Chair recognizes Representative Watson."

Watson: "Thank you, Mr. Speaker. I move the previous question."

- Speaker Lang: "Gentleman moves the previous question. Those in favor say 'yes'; opposed 'no'. In the opinion of the Chair, the 'ayes' have it. And the previous question is put. Representative Thapedi to close."

This is a piece of legislation that passed out of the Human Services Committee unanimously yesterday that attempts to tighten the controls on group homes, CILAS, in the State of Illinois in response to some total... truly, truly horrendous abuses that occurred in the homes run by the Graywood Foundation here in Central Illinois where two children were murdered and there were 11 other cases of abuse and neglect that were substantiated and the department did not respond because they did not believe they had the adequate authority. We're trying to close these loopholes, prevent this kind of tragedy from ever happening again. I would be happy to take any questions."

These four tasks could be important for a number of schools who have under 20 students that would be in the transitional programs. We have some successful schools in Lake County doing that and we'd like the ability to be able to study whether the alternate schools would be allowed in the State of Illinois."

Speaker Lang: "The Lady's moved for the passage of her Bill.
