My... my goal is to continue to be an elected official that I can be proud of myself, but also most importantly that other people can look to and feel proud that this individual is trying to do the best job they can to represent them. And so, I want to thank you all for your friendship over the years. Thank you, especially of course today, to those of you who got up and spoke. To Dan Burke who has been my greatest mentor in this Chamber since the day I walked in. Obviously to Linda who I know tried embarrassing me by saying that we sleep together, but yes it is in separate beds, of course. She's my roommate and I adore her. She's my sister, frankly. To Jack, who is more than a colleague here. He's a member of my family. And while he never votes with the Dems, you know, I'm hoping maybe one of these days he will. And to, you know, Sara... there's just so many, I... I can't continue with all the name... name dropping here. But, what I will say is that I have friends on both sides of this aisle. And
