So, this Bill simply clarifies that the Illinois Anti-piracy Act applies to only those recordings recorded prior to February 15, 1972. There's no opposition. I'd be glad to take any questions."

Brady: "So, they would be designated as an emergency vehicle and they're not now?"

Acevedo: "They're not now, no."

Brady: "Okay. Thank you very much."

If you do that three times, that is the crime of gunrunning."

Eddy: "Okay. So, three separate occasions someone violates a law related to the sale of a firearm..."

Biss: "I'm sorry, three firearms. It can be one, two or three occasions."

Eddy: "Okay. And the current penalty for gunrunning is what?"

Biss: "I'd have to check on that, Representative."

Biss: "Correct. The Secretary of State is authorized to revoke the license for 90 days."

Eddy: "Okay, Representative, I... I'm kind... kind of interested in what the... what the penalty is and why it's being enhanced here. I noticed that... Is there any opposition? Is..."

Biss: "No, there's no opposition. I'm certainly happy to take the Bill out of the record and get back to you on the penalty if you're so inclined, but there isn't any opposition. The Bill was an initiative of the City of Chicago and the Chicago Police Department and it wasn't about enhancing the penalty in a punitive or even a deterrent level. It was simply giving law enforcement an

Eddy: "Okay."

Biss: "They felt that if you had a collection of people working together, then one person might be caught, convicted, but if the vehicle that's being used is still at large, so to speak, then that was problematic. And so they wanted this additional tool in fighting rings of crime."

Eddy: "Okay, Representative, thank you for your answers. I'll listen to the rest of the debate."

Biss: "Thanks."

Speaker Lyons: "The Chair recognizes the Gentleman from Cook, Representative Jim Durkin."

Durkin: "Will the Sponsor yield?"

Durkin: "Well, if we're basing it based on gunrunning more than three... three guns, I sense a lack of uniformity with the application and the penalty which you are prescribing in this... in this Bill."

Biss: "That's absolutely right. The penalty is at the discretion of the Secretary of State and that's definitionally not uniform. It's... it's a..."

Durkin: "That it is not uniform, but also we're saying that the same penalties we're giving optional penalties, there's really no clear distinction between the two... what would qualify for the suspension versus the revocation. The revocation is the more serious of the two, but we would be penalizing them, one for perhaps maybe a... we're seeking a suspension for one where the facts and circumstances may be more egregious. I think that, as well-intentioned as it is, I think that there is still a drafting error. And I think when you don't at least give guidance on what... which circumstance would qualify for a suspension versus a revocation, whether that situation is ever going to arise, but I think it's our responsibility to bring more clarity to the individual or the party that's going to have to

enforce this, the Secretary of State. So, I'll... you know, it's clearly up to you, but I think that this Bill needs a little more work and perhaps just some more clarity."

Biss: "Well, my feeling would be that only to the optional nature of the penalty it's acceptable to provide one tool or the other to the relevant law enforcement entities. And so I intend to continue to bring the Bill... to bring the Bill to a vote as it is, but I do appreciate the points."

Durkin: "I know that you're a... you know, you're a mathematician, you come from a higher... teach at higher levels than I can ever achieve, but I do believe that there is a fundamental flaw with the way this is drafted and that enforcement of this is going to be very difficult. I'll wait to see if anybody else has anything to say on this. But I... you know, generally we mean we should try to fix the problems before we pass these things. And I know you've got a very wise attorney over to your right and I think she's advised you to move, probably to move forward with the vote. But I think that just as long as you know that this is a... there is a problem with the way this is drafted and that the Secretary of State is not given any type of guidance or clarity on how to enforce this law. And I see
