Osmond: "Thank you, Mr. Speaker. Senate Bill 3170 amends the Illinois Power Agency Act and provides that township boards may adopt ordinances under which they may aggregate residential and small commercial retail electric boards low... loads. This is the exact same legislation that we gave villages and counties; we're just extending it to townships."

Speaker Lyons: "You've heard the Lady's explanation on Senate Bill 3170. Is there any discussion? Representative Mike Fortner on the… on the Bill, on Senate Bill 3170."

Fortner: "Thank you, Speaker. Will the Sponsor yield?"

Speaker Lyons: "Sponsor yields."

Fortner: "So, all the language is identical then to the municipal language, so it has the same referendum provisions with opt out if people want to opt out afterwards."

Osmond: "Exactly. It just adds the word township."

Fortner: "So, it's in the same part of the Code."

Osmond: "Yes, it is. Uh huh."

Fortner: "Okay."

Osmond: "And it's all agreed. Ameren and ComEd all came forth and agreed to help with account numbers and everything like that. So, it's all agreed upon."

Fortner: "Thank you."

Speaker Lyons: "No one seeking further discussion the question is, 'Should Senate Bill 3170 pass?' All those in favor signify by voting 'yes'; those opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this Bill, there's 111 Members voting 'yes', 0 voting 'no'. This Bill, having received the Constitutional Majority, is hereby declared passed. Leader Lang, on page 4 of the Calendar, you have Senate Bill 758. Read the Bill, Mr. Clerk."

Clerk Hollman: "Senate Bill 758, a Bill for an Act concerning liquor. Third Reading of this Senate Bill."

Speaker Lyons: "Leader Lou Lang."

Lang: "Thank you, Mr. Speaker, Ladies and Gentlemen. This Bill's an initiative of Kendall College in Chicago. Kendall College, among others, have culinary art schools where they

teach chefs how to do their trade. As you know, in the process of making a fine cuisine there is... there are sometimes liquor involved, wine in sauces, et cetera. This Bill would allow those students who are at those schools who are over 18, but under 21 to taste but not swallow the sauces made from the wine. It does sound like a funny Bill, but it's a serious Bill for those who are in these classes. And I would recommend your 'aye' votes."

Speaker Lyons: "Leader Mike Bost."

Bost: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lyons: "Sponsor yields."

Bost: "We've... we've come to know this as the sip and spit Bill."

Lang: "Yeah. I didn't want to say it, so I'm glad you did, Sir."

Bost: "I... Well, you know, I say a lot of things that probably other people don't want to say on the floor."

Lang: "By the way, this is not my first Bill."

Bost: "I was just going to ask, but nice tie."

Lang: "Thank you very much."

Bost: "Representative, I do have, you know, a couple questions. With... with this right now, are there students that have already been in the culinary arts and we've just kind of been ignoring that or how has that been working over the years?"

Lang: "Actually, my understanding is that the schools that do this have been adhering to the law and they have not been letting their students break the current law. But if we want our schools here to compete with other schools around

the country and around the world, then I think it's appropriate that we pass this Bill. There... this is not a way to get young people to drink; it's a way to let them learn their craft."

Bost: "Thank you."

Speaker Lyons: "Representative Lang to close."

Lang: "Please vote 'aye'."

Speaker Lyons: "The question is, 'Should Senate Bill 758 pass?'
All those in favor signify by voting 'yes'; those opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this Bill, there's 93 Members voting 'yes', 14 voting 'no', 1 Member voting 'present'. This Bill, having received the Constitutional Majority, is hereby declared passed. Mr. Clerk, on page 9 of the Calendar, we have Senate Bill 770. What's the status on that Bill, Mr. Clerk?"

Clerk Hollman: "Senate Bill 770, a Bill for an Act concerning public aid. This Bill was read a second time on a previous day. No Committee Amendments. Floor Amendment #4, offered by Representative Currie, has been approved for consideration."

Speaker Lyons: "Leader Currie on Floor Amendment #4."

Currie: "Thank you, Speaker. This is actually part of the agreement that resulted in our supplemental appropriation yesterday. Several years ago when we had federal stimulus money, we were able to speed up the time during which the people who applied for our Temporary Assistance to Needy Families, our TANF Program, in which they could start

receiving checks. That federal stimulus money has gone away and so we are reverting, with this Amendment, to the old law which says that there are 45 days that the department has to determine eligibility and the point at which the department determines eligibility is the point at which the checks start coming. I would appreciate your support for this Amendment."

Speaker Lyons: "You've heard the Lady's Motion to adopt Amendment #4. All those in favor signify by saying 'yes'; those opposed say 'no'. In the opinion of the Chair, the 'ayes' have it. And Amendment #4 is adopted. Anything further, Mr. Clerk?"

Clerk Hollman: "No further Amendments. No Motions are filed."

Speaker Lyons: "Third Reading and read the Bill, Mr. Clerk."

Clerk Hollman: "Senate Bill 770, a Bill for an Act concerning public aid. Third Reading of this Senate Bill."

Speaker Lyons: "Majority Leader Barbara Flynn Currie."

Currie: "Thank you, Speaker. The Bill is identical to the Amendment. I would appreciate your 'aye' vote."

Speaker Lyons: "Seeing no one... there's no discussion, the question is, 'Should Senate Bill 770 pass?' All those in favor signify by voting 'yes'; those opposed vote 'no'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, take the record. On this Bill, there are 97 Members voting 'yes', 12 voting 'no', 1 Member voting 'present'. Clerk Hollman: "Senate Bill 180, a Bill for an Act concerning government. Third Reading of this Senate Bill."

Speaker Lyons: "Representative Reboletti."

Reboletti: "Thank you, Mr. Speaker and Members of the Body. Senate Bill 180 is a Comptroller initiative which deals with reciprocal offsets that we allow other municipalities and other governmental groups to recuperate some of the money that's owed to them. We passed a Bill like this last year. This would allow the Circuit Clerks to do the same thing. I would ask for your favorable support."

Speaker Lyons: "Representative Jack Franks."

Franks: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Lyons: "Sponsor yields."

Franks: "Representative, this had a pretty active debate in committee and received 6 'no' votes. I did meet with the representative of the Comptroller's Office subsequent to this... to the Bill and I was told there was an Amendment that would take out the new fee. Has that Amendment been added to this Bill?"

Reboletti: "The... the... there is not a new Amendment. What happened was some of the other parties did not want that portion to come out. So, there... the metro counties and others did not want that portion removed from the legislation."

Franks: "Mr. Speaker, I'm not sure people can hear this debate at this point."

Speaker Lyons: "Ladies and Gentlemen, we're having a discussion on a Senate Bill-Third Reading. The respondent is

- requesting us to bring the noise level down. Shhh. Thank you very much."
- Franks: "Representative, when we were in committee, there was indication that there may be an Amendment that would take out the additional fee increase and I was under the impression that was going to happen. When I met with members of the Comptroller's Office, they thought it would happen as well. And now, this comes to the floor and frankly, I'm surprised because I was assured that was going to happen. And now I'm told that metro counties wants an additional fee and for some reason, we're keeping it in. I don't think it's a strong enough reason to keep in a fee that we don't agree with."
- Reboletti: "Mr. Speaker, can I take the Bill out of the record for one minute, please, to talk to Mr. Franks?"
- Speaker Lyons: "Mr. Clerk, on request of the Sponsor take that Bill out of the record. Representative Sosnowski."
